Dear Governor Dunleavy,

I am writing this to plead for help and relief from the unconstitutional covid vaccine mandates being forced on members of my family working for the Ketchikan Indian Community clinic in Ketchikan. They are now being coerced or forced into getting the still experimental covid 19 vaccine, if they want to keep their jobs or seats on boards related to the KIC Health Clinic, by the CMS mandate issued by the Biden administration.

My family members have applied for religious and medical exemptions, but word is being spread now that the tribal "council" is not going to allow ANY exemptions of any kind, just issue a get vaxxed or lose your job ruling. I find this highly problematic that the "council" of a sovereign nation is forcing members of this sovereign nation to submit their sovereignty to the CMS service, a branch of a foreign nation to the tribes of Alaska, because the CMS has threatened the funding of the health clinic in Ketchikan if KIC does not comply with the unconstitutional mandate.

At this point may I remind you that MANDATES are not LAWS, have not been legislated by congress, and that this vaccine is EXPERIMENTAL with no long term effects, and the government as well as the vaccine manufacturers, have been caught hiding pertinent information on the adverse effects of these vaccines, as well as not giving information on what is in these "vaccines" as well as updated and full information on the adverse effects that are needed for full informed consent!

The video above is 9 minutes long, you should watch it as the attorney exposes that the Dept. of Defense has been "doctoring" and hiding data on the adverse effects of the vaccine, and that these effects are so significant many of the doctors on this panel thought this experiment should be stopped because of the HARM they are causing!

Every day there is more and more information on this experimental injection, which was called a vaccine. We were told it would give immunity, stop the spread, and keep those receiving it from getting hospitalized or lessen the effects, AND IT HAS BEEN SHOWN TO ACHIEVE NONE OF THESE! I have been

told the covid infection rate at KIC is 81% vaxxed! This vaccine is an abject FAILURE as a vaccine and is causing irreparable harm, young people in the prime of life now dropping dead from heart problems, young athletes dropping dead on the playing field, so many people with devastating neurological problems so bad they need assisted care to live, cannot work, and have had their lives DESTROYED by this injection! This injection is being shown to destroy the immune systems of many with these adverse effects, and it is not a vaccine, it is GENE THERAPY, and is permanently altering the DNA of those getting this injection, it is a total experiment and continuing to FORCE it on others is INSANE and a violation of our human rights!

NOBODY should be fired from their jobs or prevented from participating in our society and commerce for declining to accept ANY vaccine or medical procedure, not to mention one so ineffective that now 80% of the covid cases are fully or partially vaxxed!

ALL REQUEST FOR EXEMPTIONS SHOULD BE ALLOWED....AND ACCOMADATED!

Alaskans, and all HUMAN BEINGS have the RIGHT to evaluate the benefits versus the RISKS of all medical procedures, and make INFORMED decisions, based on facts and the evidence (that is presently being withheld from us) and FREELY consent or decline without being illegally coerced, intimidated, or bullied. Threats of losing your job and income, healthcare, and the ability to financially take care of your family IS NOT INFORMED AND FREE CONSENT! NO one should be prevented from going to school or college because they declined this experimental medical procedure!

THOSE WHO DECLINE THIS INJECTION HAVE VALID CONCERNS!

Many who are religious have conscientious objections to the unethical methods used to develop these injections! Many have LEGITIMATE concerns that these vaccines will harm their health, as is being shown in the highest amount of adverse effects reported, more than all other vaccines in history COMBINED! Many have already had this disease and HAVE NATURAL IMMUNITY, which HAS BEEN SHOWN IN STUDIES TO BE SUPERIOR to the short lived positive results of this injection. AND MANY MORE DON'T WANT TO PARTICPATE IN AND EXPERIMENTAL INJECTION THAT ALTERS THEIR DNA GENOME, AND WHICH NO ANIMAL STUDIES OR LONG TERM STUDIES HAVE BEEN DONE!

THESE ARE ALL LEGITIMATE REASON FOR DECLINING THIS INJECTION!

I am now asking you to do all in your power to stop these illegal and unconstitutional mandates, they are a violation of the Nuremburg code, our laws on INFORMED CONSENT, and OUR HUMAN RIGHTS!

PLEASE USE YOUR EXECUTIVE AUTHORITY TO INTERCEED AND STOP THIS ... NOW!

And PLEASE fully support and push SENATE BILL 156, which would make vaccine mandates and passports ILLEGAL in Alaska, as it should be! I urge you to try to get this legislation passed and signed as fast as possible and to use your executive action to temporary halt these mandates , while this legislation is pending!

I am also sending this letter CC'd to the Senate State Affairs Committee and it's members and urging them to please share this letter with the entire legislature.

Now about myself. I am a 73 year resident of Alaska, born and raised, of mixed heritage of European and Native American. I have a large family of mixed heritage of European/Native American/ Alaska Native/Hispanic/black, and my children, and many cousins here, are members of the Ketchikan Indian Community and Alaska native, so I do have a dog in this fight and many concerns about my fellow Americans of not only the adverse PHYSICAL effects of this injection, but also EXTREME CONCERNS on allowing our federal government to FORCE medical procedures on the SOVEREIGN citizens of Alaska and the other states and territories! Are we citizens who "own the government" which requires CONSENT OF THE GOVERNED, or are we a FEDERAL GOVERNMENT WHO OWNS "IT'S SUBJECTS" AND CAN IMPOSE MEDICAL PROCEDURES ON THEM? AND WHERE DOES THIS STOP? IF THEY CAN IMPOSE THIS, CAN THEY THEN IMPOSE OTHER PROCEDURES, UP TO AND INCLUDING THE ORGANS OF IT'S SUBJECTS AS CHINA DOES NOW?

Please stop this insanity of mandates NOW, FREEDOM IS THE...RIGHT....TO CHOICE.
