HB 273 Increasing the Base Student Allocation According to Inflation

- Years of flat funding have led to a financial loss for Alaska's Students.
- We have a Constitutional obligation to Alaska's families and economy to ensure strong schools.
- This bill creates steady and reliable funding for children's education and services.
- School communities will better be able to deliver on student needs, knowing that education allocations will be tied to real costs.
- Efficiencies in school staff time leads to more time focused on school students.

HB 273 Increasing the Base Student Allocation According to Inflation

- HB 273 introduces inflation proofing to the Base Student Allocation (BSA) in the foundation formula.
- This ties the growth of education funding to the Consumer Price Index (CPI) for Urban Alaska from the United States Borough of Labor Statistics.
- This helps families and communities, by offering steady and reliable funding to children's services.

Inflation Proofing Formula

- For example: FY23 BSA increase = (CY20 inflation + CY219 inflation + CY18 inflation)/3 x FY22 BSA amount
- 5930 x 1.0111 = 5996
- The BSA would increase by \$66 per student, an increase of 1.11%
- By averaging three years, the formula smooths out big swings in inflation.
- And by adding a lag year, school communities will know their allocation ahead of time, which helps them to craft their budgets and meet student needs.

HB 273 Increasing the Base Student Allocation According to Inflation

- This is a fundamental statewide economic issue.
- The best way to attract new residents, build a skilled workforce, and maintain a strong economy is to assure good schools, pre-school through college. An investment in our children now, pays back down the road.
- By ensuring a fair base to our schools' funding, we are investing in Alaska's future.
