You requested an amendment that returned the legal age for the purchase and possession in HB 110 back to 19 years.¹

On December 20, 2019, Public Law 116-94 raised the federal minimum age for tobacco purchase from 18 to 21. Under 21 U.S.C. 387f(d)(5), it is "unlawful for any retailer to sell a tobacco product to any person younger than 21 years of age." Federal law preempts conflicting state law. Therefore, retailers in the state are currently only legally permitted to sell tobacco products to a person 21 or older, regardless of the contradictory state law.

Although federal law sets the minimum age for retail sales, it is my understanding that enforcement of tobacco laws is largely left to states. Under 42 U.S.C. 300x-26, a state may be denied certain federal grant funding² for failure to enforce the 21 year minimum age for tobacco purchases against retailers. There is a three year transition period for loss of federal funding; the three year period began December 20, 2019. Therefore, the state is not at risk of losing federal funding for failure to enforce the state law until December 20, 2022.³

In sum, if your amendment is adopted, or if the state law remains unchanged, the state law will conflict with federal law. The federal law, related to the minimum age for a retailer to sell tobacco products, will control.
