The Alaska State Medical Association (ASMA) represents physicians statewide and is primarily concerned with the health of all Alaskans.

ASMA would like to express its support for Senate Bill 56 and the extension of the COVID-19 Disaster Declaration until September 2021. While Alaska and the nation have made great progress in dealing with the COVID-19 pandemic, there remain significant concerns over its continued impacts to our state's overall health, as well as significant concerns over virus mutations and how those mutations will react to current treatments and vaccines. The extension of the Disaster Declaration will provide necessary tools for the state to continue managing the impacts of COVID-19.



#### To all HHS committee members

My name is Mike Coons. I am the President of the Matsu Chapter of the Association of Mature American/Alaskan Citizens (AMAC) Action. I will be speaking for the vast majority of my members. In addition to speaking for AMAC Action, I am a commissioner on the Alaska Commission on Aging, I know that the commission is in support for of all senior citizens of the State of Alaska by supporting this existing SB 56. We also have two other Chapters, the Greater Anchorage and the Fairbanks Chapters. I got approval by Cheryl LaFollette, Fairbanks and Robert Coulter, Greater

Anchorage to state here that both chapters are in full support of SB 56.

That is the majority of over 500 chapter members. Also, State-wide, AMAC is over 7,800 concerned and strong mature citizens of this State, not to mention 2.3 million strong nation-wide.

The extension of the emergency powers that is requested by Governor Dunleavy in SB 56 will have a huge impact on the lives of all 142,000 plus seniors in the State of Alaska. This gives the Governor and his administration the ability to not only get the vaccines, be they Pfizer, Moderna, the up and coming Johnson and Johnson, Astra Zenaca, or others in the pipeline, but the means to get those vaccines to the citizens of Alaska and in my opinion the most important of all Alaskans, those mature Alaskans that want to regain our freedoms by having the choice to get our choice of vaccines and then be able to be out in the community and society. We have been told from the President of the United States on down, that this virus was the most deadly to seniors and to those with other medical issues that weaken the immunity of the person. RE: ASHNHA Strongly Supports SB 56

Dear Senator Wilson,

The Alaska State Hospital & Nursing Home Association strongly supports SB 56, which extends the existing public health disaster emergency declaration issued by the Governor on January 15, 2021 to September 30, 2021.

SB 56 is vital to Alaska's health care system. In recognition of the present outbreak of COVID-19, and the credible threat of a greater, imminent outbreak from variant strains, the public health disaster emergency declaration in SB 56 allows Alaska's health care system to access (1) critical operational flexibilities at the federal level, and (2) key licensing and telehealth flexibilities at the state level.

If SB 56 is not passed, hospitals and nursing homes' compliance with federal requirements will be in question. This will place hospitals, nursing homes, and other health care providers into a position of great uncertainty, and potentially force a drastic curtailment of COVID operations.

#### Federal Flexibilities

Early in the pandemic, the Centers for Medicare & Medicaid Services (CMS) issued approximately 125 "blanket waivers" for 32 categories of health care services and provider types. Pursuant to section 1135 of the Social Security Act, the federal blanket waivers are automatically in effect for all states, and modify or set aside a variety of federal requirements that "pose issues or challenges for the health care delivery system." See <u>CMS Letter to Commissioner Crum. April 2, 2020</u>. These primarily affect requirements for individual facilities, such as hospitals, long term care facilities, and home health agencies. *Id*.

CMS' blanket waivers include the following language in 20 specific waiver flexibilities: "This waiver [or these flexibilities] may be implemented so long as it is not inconsistent with a state's emergency preparedness or pandemic plan." <u>CMS Fact Sheet</u>.

If the State no longer formally recognizes the existence of a public health disaster emergency in Alaska, then it is reasonable to believe that the CMS blanket waivers are "inconsistent with" the state's emergency preparedness or pandemic plan because, again, there is no longer an active "emergency" for which a plan is required.



If the blanket waivers are no longer available to Alaska health care facilities and providers, effects could include:

- Closure of alternate care sites for screening and testing because there would be no waiver of
  provisions of the federal Emergency Medical Treatment & Labor Act (EMTALA) that allows
  screening of patients at locations offsite from a hospital campus.
- Severe reduction in surge capacity and quarantine units because there would be no waiver
  of certain physical environment requirements under Medicare conditions of participation to
  allow for surge capacity and patient quarantine in facility and non-facility space.
- 3. <u>Limitations on practitioners and health care workforce</u> because there would be no waiver of requirements under 24 CFR §482 to allow use of practitioners to the fullest extent possible.

Not extending the emergency declaration also sends inconsistent signals to the public that an otherwise active pandemic is over and could compromise future funding opportunities from the federal government.

Finally, it should be noted that having an emergency declaration in place is customary with other states. As of last week, the National Governors Association reports that every state in the union has an active emergency declaration in place.

#### State Flexibilities

SB 56 also contains key provisions that provide flexibilities for professional and occupational licensing (Section 5), telemedicine and telehealth (Section 6), and fingerprinting (Section 7). If these state flexibilities are no longer available, the ability to increase staff quickly for a surge will be diminished. Additionally, the ability to deliver expanded services in rural Alaska through telehealth, especially for behavioral health, will be reduced with restrictive provider types and services.

#### Conclusion

SB 56 is critical for Alaska's health care system. ASHNHA strongly supports SB 56 and urges lawmakers to move with haste to pass the bill. After being on the frontlines of the pandemic for a year, the last thing hospitals and nursing homes need is more uncertainty on the ability to deliver health care. Thank you for your attention on this matter, and your partnership in solving this and the many other health care challenges facing Alaskans.

Senator Wilson,

We are writing today regarding SB 56 "An Act extending the January 15, 2021 governor's declaration of a public health disaster emergency in response to the novel coronavirus disease (COVID-19) pandemic;".

The Alaska Advanced Practice Registered Nurse Alliance supports SB 56. As front-line health care providers caring for Alaskans of all ages in hospitals, birthing centers, primary care clinics and surgical centers, we believe the bill includes two provisions that are necessary to effectively respond to the COVID-19 pandemic. The first is Section 2 of the bill, which extends the emergency declaration. The declaration is necessary to convey to the governor the powers granted in AS 26.23.020.

Specifically, the emergency declaration allows the governor to exercise the powers found in AS 26.23.020 subsection (g)(10), which is to "allocate or redistribute food, water, fuel, clothing, medicine or supplies;". It is the last two items, "medicine or supplies", that most directly affects us as frontline health care providers. This provision allows personal protective equipment and vaccine to be allocated and distributed to health care providers.

We believe it is also important to extend the powers granted in Section 5 of the bill, which deals with occupational licensing. Responding to the pandemic has stressed our health care system in ways we have not previously seen. In Alaska, the need for more providers is acute. Regulators must have the power to license new providers on an expedited basis.

We appreciate the opportunity to submit written testimony on SB 56. Please feel free to contact us any time if you have questions about our position on the bill, or other health care issues.
