- (d) A person entitled to register under AS 15.07.030 [QUALIFIED VOTERS] may register in person before a registration official or through a voter registration agency at any time throughout the year, except that a person registering within 30 days preceding an election is not eligible to vote at that election. Upon receipt and approval of the registration forms, the director or the election supervisor shall forward to a [THE] voter who is at least 18 years of age an acknowledgment in the form of a registration card, and the voter's name shall immediately be placed on the master register. Upon receipt and approval of the registration forms of a person who is at least 16 years of age and not yet 18 years of age, the director or election supervisor shall immediately place the person's name on the master register and shall, within 90 days before the person's 18th birthday, forward the person a registration card. Names of persons on the master register who will be at least 18 years of age on the date of an election and who are registered [REGISTERING] 30 or more days before the [AN] election shall be placed on the official registration list for that election.
