14 nominating petition, declaration of candidacy, or other required filing for the [ELECTIVE  
15 MUNICIPAL] office."

18 Delete all material and insert:

19 "(b) A public official or former public official other than **a** [AN ELECTED  
20 OR APPOINTED] municipal officer shall file the statement with the Alaska Public  
21 Offices Commission. Candidates for the office of governor and lieutenant governor  
22 and, if the candidate is not subject to AS 24.60, the legislature shall file the statement  
23 under AS 15.25.030. **A current or former borough or city mayor, borough**

1 **assemblyman, or city councilman, or a candidate for the office of borough or city**  
 2 **mayor, borough assemblyman, or city councilman in a municipality with a**  
 3 **population of more than 15,000,** [MUNICIPAL OFFICERS, FORMER  
 4 MUNICIPAL OFFICERS, AND CANDIDATES FOR ELECTIVE MUNICIPAL  
 5 OFFICE] shall file with the municipal clerk or other municipal official designated to  
 6 receive their filing for office. All statements required to be filed under this chapter are  
 7 public records."

11 **"(2) elected and appointed municipal officers, including school**  
 12 **board members, elected utility board members, city or borough managers, and**  
 13 **members of a city or borough planning or zoning commission within a home rule**
