My name is Ely Cyrus, I am writing a letter to express my interest in regards to the vacancy on the Marijuana Control Board, specifically the open Rural Public seat. I live and work in Kiana, a community within the Northwest Arctic Borough.

I am interested in serving on this board because of the parallels it has in relation to current and past alcohol regulation in our state. Growing up in a rural community, which until very recently was subject to a local option ban on Alcohol, helps me to understand the importance of regulating a controlled substance and ensuring there is proper oversight in its use.
