
Dear Senators,

My husband almost lost his job for not getting the vaccine due to having **Left ventricular hypertrophy** that appeared suddenly a couple months after he had Covid. He was not given a medical or religious exemption from his employer and would have been fired had the Supreme Court upheld vaccine mandates for employers. I would rather have my husband here with me and be broke, than lose him to an experimental vaccine that does not have open records and/or decades of studies behind it. Nobody should be fired from their job, kicked out of school, or denied access to public places for simply declining to accept a medical intervention.

Alaskans have the right to weigh the benefits and risks of COVID-19 vaccination, just like other medical interventions, and make a free and informed choice, without coercion or other threats and intimidation tactics.

Many people, such as my husband, have valid reasons for declining vaccination, including personal health conditions

Please join other states that have vaccination requirements and passports banned by legislation (not just the governor).
