A BILL

FOR AN ACT ENTITLED

1 **"An Act relating to pollutants; relating to perfluoroalkyl and polyfluoroalkyl**
2 **substances; relating to the duties of the Department of Environmental Conservation;**
3 **relating to firefighting substances; relating to thermal remediation of perfluoroalkyl and**
4 **polyfluoroalkyl substance contamination; and providing for an effective date."**

5 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

6 * **Section 1.** AS 46.03 is amended by adding new sections to read:

7 **Article 5A. Perfluoroalkyl and Polyfluoroalkyl Substances.**

8 **Sec. 46.03.340. Testing; drinking water.** (a) The department shall ensure the
9 responsible party tests for perfluoroalkyl substances and polyfluoroalkyl substances in
10 all drinking water used in the state that is in a water supply located in the state when a
11 perfluoroalkyl substance or polyfluoroalkyl substance is released in the area of the
12 water supply. If a test conducted under this subsection detects a perfluoroalkyl
13 substance or polyfluoroalkyl substance at a level equal to or greater than the limit
14 described in (b) of this section, the department shall ensure the responsible party

provides a person who routinely uses the tested drinking water, at no cost to the person, a source of drinking water containing levels of perfluoroalkyl substances and polyfluoroalkyl substances lower than the limits described in (b) of this section.

(b) For purposes of (a) of this section, the limit of perfluoroalkyl substance or polyfluoroalkyl substance contamination in water is the lesser of

- (1) the limit established by the department in regulation; or
- (2) the following limits:

Sec. 46.03.345. Liability for drinking water and drinking water testing. (a)

A person who causes a fire that results in a release of a firefighting substance containing a perfluoroalkyl substance or polyfluoroalkyl substance is liable for the costs of providing drinking water and drinking water testing under AS 46.03.340. This subsection does not apply to a release of a firefighting substance to extinguish a fire in a residential building or motor vehicle.

(b) A person who extinguishes a fire by releasing a firefighting substance that contains a perfluoroalkyl substance or polyfluoroalkyl substance is not liable for the costs of providing drinking water and drinking water testing under AS 46.03.340 or site cleanup under this chapter, AS 46.08, AS 46.09, or another state law unless the firefighting substance was released for training or testing purposes.

(c) The liability of a person for costs under this section is in addition to other liability under this chapter, AS 46.08, AS 46.09, or other state law for a release of a perfluoroalkyl substance or polyfluoroalkyl substance.

(d) In this section,

1 (1) "motor vehicle" has the meaning given in AS 28.90.990, but does
2 not include a commercial motor vehicle, as defined in AS 28.90.990;

3 (2) "residential building" has the meaning given in AS 18.60.780.

4 **Sec. 46.03.350. Use of firefighting substances.** (a) A person engaged in the
5 business of oil or gas production, transmission, transportation, or refining may use a
6 firefighting substance that contains a perfluoroalkyl substance or polyfluoroalkyl
7 substance in the state unless the state fire marshal adopts regulations under (b) of this
8 section requiring use of an alternative firefighting substance.

9 (b) If the state fire marshal determines an alternative firefighting substance
10 listed by an organization recognized by the federal Occupational Safety and Health
11 Administration's Nationally Recognized Testing Laboratory Program is safe and
12 effective, the state fire marshal shall adopt regulations requiring use of the alternative
13 firefighting substance. The regulations must state the proposed effective date of the
14 regulations.

15 (c) The department shall accept for disposal from a person domiciled in the
16 state a firefighting substance that contains a perfluoroalkyl substance or
17 polyfluoroalkyl substance in a quantity not to exceed 25 gallons each year.

18 (d) Notwithstanding AS 46.03.320 and except as provided in (a) of this
19 section, a person may not use a firefighting substance that contains a perfluoroalkyl
20 substance or polyfluoroalkyl substance in the state unless the use is required by federal
21 law.

22 **Sec. 46.03.355. Thermal remediation permit.** A facility that thermally
23 remediates a perfluoroalkyl or polyfluoroalkyl substance contamination must have a
24 permit from the department under 42 U.S.C. 7661 - 7661f (Clean Air Act, secs. 501 -
25 507) authorizing the remediation. The department may not issue a permit or allow a
26 facility to retain a permit issued under this section if the department determines that
27 the remediation will result in the release of more than a minimal amount of an airborne
28 compound with a carbon-fluorine bond detectable through source testing. Source
29 testing under this section must include testing of all compounds with a carbon-fluorine
30 bond for which the United States Environmental Protection Agency has approved a
31 testing methodology.

1 **Sec. 46.03.359. Definitions.** In AS 46.03.340 - 46.03.359, "perfluoroalkyl
2 substance" and "polyfluoroalkyl substance" include

3 (1) perfluorooctanoic acid;

4 (2) perfluorooctanesulfonic acid;

5 (3) perfluorononanoic acid;

6 (4) perfluorohexanesulfonic acid;

7 (5) perfluoroheptanoic acid;

8 (6) perfluorobutanesulfonic acid;

9 (7) hexafluoropropylene oxide dimer acid;

10 (8) other perfluoroalkyl substances or polyfluoroalkyl substances
11 specified by the department in regulation.

12 * **Sec. 2.** The uncodified law of the State of Alaska is amended by adding a new section to
13 read:

14 APPLICABILITY; RETROACTIVITY. AS 46.03.345, added by sec. 1 of this Act,
15 applies retroactively to a release of a perfluoroalkyl substance or polyfluoroalkyl substance
16 occurring before, on, or after the effective date of sec. 1 of this Act.

17 * **Sec. 3.** The uncodified law of the State of Alaska is amended by adding a new section to
18 read:

19 TRANSITION: REGULATIONS. The Department of Environmental Conservation
20 shall adopt regulations necessary to implement this Act. The regulations take effect under
21 AS 44.62 (Administrative Procedure Act), but not before the effective date of the law
22 implemented by the regulation.

23 * **Sec. 4.** Sections 2 and 3 of this Act take effect immediately under AS 01.10.070(c).

24 * **Sec. 5.** Except as provided in sec. 4 of this Act, this Act takes effect January 1, 2023.
