A BILL

FOR AN ACT ENTITLED

"An Act relating to broadband; establishing the office of broadband; providing for a broadband grant and loan program; establishing the Statewide Broadband Advisory Board; establishing community engagement task forces; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* Section 1. The uncodified law of the State of Alaska is amended by adding a new section to read:

LEGISLATIVE FINDINGS, PURPOSE, AND INTENT. (a) The legislature finds that

- (1) access to broadband is critical for a person to fully participate in modern society and the economy;
- (2) increasing broadband access to unserved and underserved areas of the state serves a fundamental governmental purpose and function and benefits citizens of the state by enabling access to health care, education, and essential services, providing economic opportunities, and enhancing public health and safety;

(3) achieving affordable and quality broadband access for all citizens of the state requires sustained investment, research, local and community participation, and partnerships between private, public, and nonprofit entities;

- (4) the Federal Communications Commission has adopted a national broadband plan that includes recommendations directed to federal, state, and local governments, including recommendations to
 - (A) design policies that ensure robust competition and maximize consumer welfare, innovation, and investment;
 - (B) ensure efficient allocation and management of assets that the government controls or influences to encourage network upgrades and competitive entry;
 - (C) reform current universal service mechanisms to support deployment of broadband in high-cost areas, ensuring that low-income individuals can afford broadband and supporting efforts to boost adoption and use of broadband; and
 - (D) reform laws, policies, standards, and incentives to maximize the benefits of broadband in sectors significantly influenced by the government, including public education, health care, and government operations;
- (5) extensive investments have been made by the telecommunications industry and the public sector, and policies and programs have been adopted to provide affordable broadband throughout the state, that will provide a foundation to build a comprehensive statewide framework for additional actions necessary for advancing the broadband goals of the state; and
- (6) providing additional funding mechanisms to increase broadband access in unserved and underserved areas is in the best interest of the state.
- (b) The purpose of this Act is to establish a grant and loan program that will support the extension of broadband infrastructure to unserved and underserved areas.
- (c) To ensure the grant and loan program established by sec. 2 of this Act primarily serves the public interest, it is the intent of the legislature that a grant or loan provided to a private entity under the program be conditioned on a guarantee that an asset or infrastructure funded by the grant or loan program will be developed and maintained for public use for at least 30 years.

Article 16A. Broadband.

Sec. 44.33.910. Office of broadband; powers and duties. (a) The office of broadband is established in the Department of Commerce, Community, and Economic Development.

- (b) The office serves as the central planning body for broadband in the state and has the power and duty to
- (1) coordinate with local governments, tribes, public and private entities, nonprofit organizations, and consumer-owned and investor-owned utilities to develop strategies and plans promoting deployment of broadband infrastructure and greater broadband access, while protecting proprietary information;
- (2) review existing broadband initiatives, policies, and public and private investments;
- (3) develop, recommend, and implement a statewide plan to encourage cost-effective broadband access and to make recommendations for increased usage, particularly in rural and other unserved and underserved areas;
- (4) update broadband goals and definitions for broadband service in unserved and underserved areas as technology advances, except that the definition for broadband service may not be actual speeds of less than 25 Megabits per second download and three Megabits per second upload;
- (5) encourage public-private partnerships to increase deployment and adoption of broadband services and applications; and
- (6) review and consider the recommendations of the Statewide Broadband Advisory Board established under AS 44.33.920.
- (c) When developing plans or strategies for broadband deployment, the office must consider
- (1) partnerships between communities, tribes, nonprofit organizations, local governments, consumer-owned and investor-owned utilities, and public and private entities;
- (2) funding opportunities that provide for the coordination of public, private, state, and federal funds for the purposes of making broadband infrastructure or

broadband services available to rural and unserved and underserved areas;

- (3) barriers to the deployment, adoption, and use of broadband service, including affordability of service and project coordination logistics; and
- (4) requiring a minimum broadband service of 25 Megabits per second download and three Megabits per second upload speed, that is scalable to faster service.
- (d) The office may assist applicants for the grant and loan program established under AS 44.33.915 in seeking federal funding or matching grants and other grant opportunities for deploying broadband services.
- (e) The office may take all appropriate steps to seek and apply for federal funds or grants for which the office is eligible and may accept donations.
- (f) The office shall adopt regulations under AS 44.62 (Administrative Procedure Act) to carry out its duties.
- **Sec. 44.33.915. Broadband grant and loan program.** (a) The office of broadband shall establish a competitive grant and loan program to award funding to eligible applicants to promote the expansion of access to broadband service in unserved and underserved areas. The office shall work in collaboration with the Statewide Broadband Advisory Board established under AS 44.33.920 to review applications and award grants.
- (b) Grants and loans may be awarded under this section to assist in funding acquisition, installation, and construction of middle mile and last mile infrastructure that supports broadband services and to assist in funding strategic planning for deploying broadband service in unserved and underserved areas.
 - (c) The office may fund all or part of an application for funding.
- (d) The office shall award funds under this section to qualified applicants in all regions of the state.
- (e) The office shall consider affordability and quality of service to end users in making a determination on an application.
- **Sec. 44.33.920. Statewide Broadband Advisory Board.** (a) The Statewide Broadband Advisory Board is established.
 - (b) The advisory board shall work with the community engagement task

forces established under AS 44.33.930 to look at and consider, from a community perspective, the challenges and opportunities related to regional connectivity.

- (c) The advisory board is composed of eight members appointed by the governor to three-year terms as follows:
 - (1) one member who is a mechanical engineer;
 - (2) one member who is a civil engineer;
 - (3) one member who is an aerospace engineer;
 - (4) one member who has expertise in telecommunications;
 - (5) one member who has expertise in fiber optics;
 - (6) one member who has expertise in satellite technology;
 - (7) one member who has expertise in microwave technology; and
 - (8) one member who serves as a technology neutral consultant.
- (d) Members of the advisory board, other than the technology neutral consultant, shall receive compensation of \$307 a day while attending advisory board meetings and shall be entitled to travel expenses and per diem authorized by law for members of other boards and commissions. The technology neutral consultant is in the exempt service and is entitled to a monthly salary equal to a step in Range 27 of the salary schedule in AS 39.27.011(a).
- (e) In this section, "advisory board" means the Statewide Broadband Advisory Board.
- **Sec. 44.33.930. Community engagement task forces.** (a) Community engagement task forces shall be established by the director of the office of broadband who shall appoint state residents to serve as needed and for the duration requested by the office.
- (b) The community engagement task forces shall include members representing
 - (1) a tribe;
 - (2) a broadband user;
 - (3) a health care provider;
- (4) a member of the Alaska Search and Rescue Association or an operational member organization;

(5) the social services sector;

(6) a tribal or state governmental employee with access to judicial

- (7) the transportation industry;
- (8) a member of a regional development organization;
- (9) a local government public servant; and
- (10) a state government public servant.
- (c) Members of a community engagement task force shall receive compensation of \$307 a day while attending task force meetings and shall be entitled to travel expenses and per diem authorized by law for members of boards and commissions.
- (d) In this section, "regional development organization" means a nonprofit organization or nonprofit corporation formed to encourage economic development within a particular region of the state that includes the entire area of each municipality within that region and that has a board of directors that represents the region's economic, political, and social interests.

Sec. 44.33.940. Definitions. In AS 44.33.910 - 44.33.940,

- (1) "office" means the office of broadband established under AS 44.33.910;
- (2) "underserved area" means an area that does not have broadband speeds of at least 100 Megabits per second downstream and at least 20 Megabits per second upstream with a latency sufficient to support real-time interactive applications;
- (3) "unserved area" means an area that does not have broadband speeds of at least 25 Megabits per second downstream and at least 3 Megabits per second upstream with a latency sufficient to support real-time interactive applications.
- * **Sec. 3.** AS 44.33.910, 44.33.915, 44.33.920, 44.33.930, and 44.33.940 are repealed June 30, 2030.
 - * Sec. 4. This Act takes effect immediately under AS 01.10.070(c).
