When unfunded liability is paid off, this bill costs 10% less than current cost of Tier IV (12% vs. 22%).

My name is Steven Butts and I am an Anchorage Firefighter. I am writing you in support or HB 55. We are losing good and experienced people to out of state agencies due to the lack of certainty in retirement for Alaskan first responders. We are unable to compete with what other states are offering and until that is addressed, we will continue to bleed highly trained personnel to the lower 48. This costs us in the loss of experienced personnel and in the financial costs of replacing them.

HB 55 is a solution to that problem. It is more in line with what the privates sector and lower 48 offer their employees. It is cheaper than the previous defined benefits program the state has used ( tiers 1-3).

The current system used for tier 4 has employees putting in 8 percent and getting matched 5 percent. This is less than a social security contribution in most private sector settings. Pair that with the fact that our tier 4 employees are not considered eligible for social security even though they do not receive a pension and you can see why we are losing people left and right.

It is obvious that tier 4 is a bare bones plan. It was created to pay off the unfunded liability from previous tiers. Once the liability is paid off, the cost of HB 55 is 10% less than the current tier 4 (22% vs 12%).

HB 55 is also safe. The states actuary and an independent actuary both show that it is safe. It would take a draconian situation for the plan to drop below 90% funding and trigger it's safeguards.

It is for these reasons that I am writing you in support of HB 55.

I am writing today in support of HB 55, Peace Officer/Firefighter Retire Benefits and am urging you to pass this out of Senate Finance and to the Senate floor for a vote.

I am a 9-year Firefighter/Paramedic with the City of Fairbanks Fire Department. I have now wrote a letter(s) for each year of my service in Alaska requesting we move forward with a new system. I have seen first hand the struggles that tier 4 has caused to public servants. FFD has turned into a short-term training department for good people to work their resumes and move on. We hire some amazing people that would spend their career at FFD if we had a retirement system that provided some dignity when it came time to retire. The DC Tier 4 system is not going to meet the satisfactory mark for our members.

FFD is currently short 8 employees and we can't find or hire anyone willing to come here. I have been forced at work and away from my family for 96 hours in the last week alone. I had a stretch of 6 -24 hour days where I could not leave work. In the first quarter of this year, I have had to work an extra 363 hours. This is 45 normal working days for most people. I can't be away from home and my family this much anymore.

Last I checked, on average, our members have a 27% chance of meeting the bar for income in retirement with DC system. I am afraid the FFD members are going to be well below this mark. There is not a better time to act than now as we come out of some of the hardest times our members have seen.

HB 55 is a proven plan that will get us closer to the dignity deserved in retirement. Though I am not pleased it leaves out important aspects such as healthcare, I understand this is the sacrifice we must make so this plan will survive generations to come. I support HB 55 and I urge the legislature to move this bill out of Senate Finance and to the floor for passage by the end of this session.

My name is Russ Dennis, Alaskan Firefighter/Paramedic. I am writing to you and the Finance Committee to urge your support for HB55. Alaska's Fire and Police Departments are struggling to attract recruits and retain employees. Tier 4 retirement does not compete with the lower 48, so we bleed experience and work overtime to fill the gaps. After building experience in the state, young firefighters and police are upgrading their resume and moving to greener pastures south at an unsustainable rate. Those left are faced with a slim chance of having enough money to retire. With this bill we are willing to sacrifice benefits, share risk, and compromise on cost to gain staying-power for future first responders.

I clocked out at 8:00am this morning, 312 hours after I clocked in. The City paid me for 13 days solid because there are not enough firefighters going on shift for me (and sometimes up to 5 other firefighters) to go home. Our ambulances are empirically overutilized, our department perpetually understaffed, and our run numbers steadily increasing. Simultaneously, our responders are getting tired and sloppy from overwork. Training is reduced, sleep is rarer, and the quality of the critical services we provide is foundering. The effects on our spouses, our children, and our lives outside of work are becoming increasingly obvious.

Please pass HB55 out of the Senate Finance Committee and on to the Senate Floor to rebuild public safety for Alaskans.

My name is Angela Johnstone, and I am the spouse of an Anchorage Firefighter. I am writing in support of HB55 because of the huge impact it would have for my family, and my community.

My husband and I are both born and raised in Anchorage, and despite leaving for college came back to work, live, and grow our family here. The current retirement system for Alaska Public Safety Employees is making that dream less and less sustainable. The Anchorage Fire Department is getting younger because they cannot retain employees as soon as the reality of planning for retirement becomes apparent.

This leaves AFD with the expensive task of hiring young, green firefighters and pouring resources into making them assets for their department and their community - just to watch them leave for departments in the lower 48 with decent retirement plans. This revolving door is estimated to cost us between \$8-12 million dollars, aside from the dollar amount, I worry what that inexperience might one day cost my family.

Our public safety employees are asked to put so much on the line everyday, most of these jobs are hard on their bodies, and harder on their minds. The current retirement system creates hardship while they're on the job, and can't provide a dignified life when we've tossed them aside. While discussing this bill at family dinner we learned that my sister in law has a better retirement through the brewery she serves at then my husband does at Anchorage Fire Department, it was only funny for a second.

The Tier 4 program was set up to pay the unfunded liability of earlier tiers and treated employees as an afterthought. I do not expect it will be easy to keep a fully staffed, skilled workforce of afterthoughts. Every time this bill has been delayed AFD employees have chosen to test for other departments, if its delayed further we will lose more valuable knowledge, experience, and lifelong Alaskans who would have chosen to stay.

Please cast your support for HB55, for families like mine, and for communities that deserve a dedicated public safety workforce.

Public safety officers (and all state employees, really) should have a true pension plan. This would encourage employees to remain in the state for their entire careers, rather than receiving very costly training at Alaska's expense and then taking their expertise to other states. The current Tier 4 system is a double whammy, as employees don't receive a pension, but also don't participate in Social Security. Once the employee is vested in tier 4 after five years, they would be short-sighted to continue to work under the Tier 4 retirement system.

The plan proposed in HB55 would be in line with what the private sector and other states offer, and would be at a reasonable cost to the state. Employees, the state, and retirees all share in the risk so that no one group is left holding the liability. In fact, once the, this bill costs less than current cost of Tier IV (12% of payroll vs. 22%.)

Honorable members of the Senate Finance Committee

My name is Eric Tuott and I am a 20 year member of the Anchorage Fire Department. I am writing to you to urge you to pass House Bill 55 as it appears before you today.

With 20 years on the job, I feel fortunate and grateful that I am a member of PERS Tier 3. At 46 years old, my body is feeling the effects of responding to nearly 15,000 incidents to help Anchorage residents. I am hoping to work for another 5-8 years before my body cannot handle the rigors of the job and I walk away from the career that I love.

Every day when I come to work I see the firefighters under my supervision staff Anchorage's busiest fire engines and ambulances. 75% of them are Tier IV members, and do not have a Defined Benefit pension like I do. This affects them in two ways: first, they are not tied to Anchorage or Alaska like I am. If they find another job somewhere else (and they are actively looking) there is nothing financially holding them back. All of the investments in training, culture, and experience we have given them they will take to another Department outside Alaska, or maybe even use the lessons they have learned on the Fire Department in another profession. Second, because their post-employment plans are tied directly to the performance of the financial markets, they may have to work much longer in their lifetimes to earn enough to keep them financially secure. Because their financial security is at the whim of the market, they may find themselves working a highly physically demanding job well into their late 50's, which isn't ideal for anyone.

In his state of the State speech, Governor Dunleavy stated that the funding gap in the Alaska PERS system is virtually closed. This is the perfect time to move Alaska's first responders back into a Defined Benefit system and take a good first step in retaining our current workers and providing an incentive for more applicants to come to Alaska to serve, as opposed to going to the Lower 48 after Alaskans have invested in their

initial training.

Please pass HB 55.
