\$68.4 million for Tustumena replacement – is being matched with an existing FY2018 appropriation of vessel replacement funds

\$8.6 million design for another replacement vessel

Capital amendment for \$2.1 million in match from the vessel replacement fund

\$163.7 million remaining is for electric ferry, dock infrastructure upgrades and existing vessel modernization

Capital amendment for \$40.9 million in match from Federal Highway Administration (FHWA) Ferry Boat Funding using Toll match credits
