**Analysis**

HB 65 will increase the base student allocation (BSA), under AS 14.17.470, by \$1,250 in the public school funding formula. The BSA will change from \$5,960 to \$7,210 in FY2024 resulting in a \$321 million increase in funding to school districts.

This bill takes effect July 1, 2023 (FY2024).
