R p fi	his bill transfers the duties of administering the Permanent Fund Dividend (PFD) program from the Department of levenue to the Alaska Permanent Fund Corporation (APFC). This includes determining the value of each dividend and the layment of each dividend. The bill also moves the Dividend Fund to APFC as a separate fund within the Corporation. This is scal note assumes the Permanent Fund Dividend Division moves from the Taxation and Treasury appropriation to the claska Permanent Fund Corporation appropriation.
