Dear House Education Committee Members,

One late summer day, in my mid-20's, I was sitting in a class called, "Parent-Child-Teacher Interactions" - a required course for a master's in elementary education. The professor was lecturing about how teachers are mandated reporters of child abuse and how we all - no matter our background, education, family income or status - know someone who was sexually abused as a child. Not me, I thought; I don't know anyone. Riding down in the elevator after class, it hit me. I was the person I knew who'd been sexually abused as a child.

Sexual abuse. Child abuse. Those were the words - and the concepts that they described - that finally, finally gave me the language to be able to recognize and talk about what had been done to me as a 12 year old by my mother's boyfriend (who later became her husband). For the past 15 years, I had tried - unsuccessfully - not to think about it. I had felt confused, guilty, ashamed, bad, mean, and alone, very alone. I had talked to no one. Those words, though, gave me and my family a way forward and through. Those words were and are my superpower; my torch to shine light into dark corners.

Please, please, please. Do not keep children in the dark. Sex education is absolutely essential information for all children; do not make it an opt-in part of curriculum as outlined in HB105. Do not take away the power of knowledge and language from children and the adults they will become.

I have thought a lot about my own two children. My parents loved me and hadn't been able to protect me. What could my husband and I do differently? We didn't belabor it, but we did make absolutely sure that they had age-appropriate language and exposure to the ideas. We appreciated knowing when the "good touch/bad touch" presentations happened in school so that we could echo those ideas. We told them what happened to me - again, in age-appropriate ways; each year, we gave a little more information about when and who.

Please consider how revelatory and sense-making language can be - and how the lack of it can be harmful and debilitating. There is a lot of horrible and wrong stuff in this world. Not talking about it doesn't make it go away; it makes it worse.

I understand that parents want to protect their own children; you all, though, as legislators, have the weighty responsibility to protect and nurture all school children. Please use your superpower.

Thank you for continuing to think deeply about this subject.

First, thank you for your service. I know that serving the public is often a thankless job and I appreciate the effort and attention you bring to your responsibilities.

I am writing today to express my strong opposition to the proposed parental rights bill that is currently under consideration. As someone who values the well-being and safety of all children, I am deeply concerned about the potential negative impacts this bill could have on the education and protection of Alaska's youth.

Equity exists when "every student has access to the educational resources and rigor they need at the right moment in their education across gender, ethnicity, language, disability, sexual orientation, family background, and/or family income" (Council of Chief State School Officers). In order to enact equity, we must value the contributions and experiences of our students. We must not impose an identity on them, but allow them to fully be themselves. Any action that limits their rights to learn, or engage in their constitutional first amendment rights of expression, limits their fundamental access to equity and will impede their growth.

Decades of research tell us that learners who do not feel supported in the classroom will not fully engage with the curricula (Hammond, 2015). School is, for many learners, the only place they can experience any amount of freedom to decide who they want to be and to share their personal stories. Denying learners that opportunity will seriously impact their ability to learn.

If our job as educators is to make sure that we prepare our learners for college, career, and community, we must be able to share with them the diversity of the human experience. As adults, they will interact with all sorts of people in their daily lives; they must learn tolerance to be a successful and contributing member of society.

This bill would ban gender nonconforming students from using bathrooms according to their preferred gender. How safe do you think it is for a trans girl to use the boys' bathroom? I can assure you, it's not. Kids have "gaydar" and many trans kids get bullied severely when they try to use the bathrooms at school. Trans kids get absolutely no help from the governor or people like you. They just go to school and try to survive.

I've watched this happen. When I grew up in the 80's, I had a trans friend, "Kellie". Every day, five idiots would trail Kellie from class to class yelling out "faggot" in the halls for everyone to see. Looking back, I can hardly believe this type of assault was allowed to continue in my public school without a lawsuit. If this happened today, I would definitely sue. And, guess what?!?! Do the smart thing and vote against HB 105. And . . . leave the LGBTQ+ community alone!
