### COMMUNICATION

1. Engage in effective communication and promote transparency of public information.

- 1.1 Improve customer service by providing timely and informative updates to applicants and licensees.
- 1.2 Maximize communication channels through the Board of Pharmacy website and List Service.
- 1.3 Maintain accuracy of website content and ensure accessibility of up-to-date resources



### ADMINISTRATION

2. Adhere to and strive for improved organizational efficiencies without compromising quality of record keeping.

- 2.1 Avoid delays in application processing by maintaining adequate staffing and exploring flexible retention strategies.
- 2.2 Maintain a proactive approach to licensing by consulting historical knowledge, researching national trends, and encouraging innovation in the planning process.
- 2.3 Automate licensure through online applications.
- 2.4 Exercise fiscal discipline through effective budget management.
- 2.5 Embrace innovation by exploring integration and/or delegation opportunities to support core administration functions.



### LICENSURE

3. Ensure competency and qualifications prior to licensure and renewal.

- 3.1 Adhere to established licensing standards by reviewing education, experience, and examination requirements.
- 3.2 Take a proactive approach to application and form revision subsequent to regulation changes.
- 3.3 Review professional fitness questions for applicability and update applications accordingly
- 3.4 Develop a license application for manufacturers.



### REGULATION & ENFORCEMENT

4. Grow the economy while promoting community health and safety.

- 4.1 Routinely review effectiveness of regulations that reduce barriers to licensure without compromising patient health and safety.
- 4.2 Combat the opioid crisis by effective administration of the state's Prescription Drug Monitoring Program (PDMP), including collaboration with providers and key stakeholders.
- 4.3 Establish disciplinary guidelines to ensure established safety protocols and competencies are met.
- 4.4 Advocate for legislation as the pharmacy profession evolves and new opportunities for improved patient safety arise.
- 4.5 Anticipate changes to the Drug Supply Chain Security Act and respond proactively.

# Background of SB 94

- Result of multi-year, multi-chair review of statutes and regulations to ensure the Alaska Board of Pharmacy can continue to meet its mission
- SB 94 addresses changes by:
  - Streamlining licensure process while improving public safety
  - Compliance with the Drug Supply Chain and Security Act
  - Alignment with other professional boards in Alaska and pharmacy boards in other states
  - Clarification of pharmacists' roles in epinephrine access
- Collaborative effort between the Alaska Board of Pharmacy and the Alaska Pharmacists Association

# Goal: Streamline licensure process while improving public safety

- Eliminates unnecessary forms currently required in statute
- Clarifies that only pharmacists who dispense controlled substances are required to register with the Prescription Drug Monitoring Program (PDMP)
- Adds national criminal background check

# Goal: Compliance with Drug Supply Chain and Security Act

- The federal Drug Supply Chain and Security Act (DSCSA) further secures the U.S. drug supply through a system to prevent harmful drugs from entering the supply chain, detect harmful drugs if they do enter, and enable rapid response when such drugs are found
  - Boards of Pharmacy play a key role in this process through appropriate licensing of drug distributors and pharmacies
- SB 94 ensures the AK Board of Pharmacy powers and duties support the DSCSA related to manufacturers, out-of-state pharmacies, and internet pharmacies to ensure Alaskans receive safe medications

# Goal: Alignment

- Replaces one of the two public member seats with a pharmacy technician seat
- Allows the board to adopt language for retired pharmacist status
- Clarifies the board executive administrator's salary, allowing flexibility for a pharmacist to serve in this role in the future

# Goal: Epinephrine Access

- Moves epinephrine training program under Board of Pharmacy oversight
- Clarifies that a pharmacist can administer epinephrine to a person or prescribe epinephrine auto-injectors to someone who has completed the training program
- Increases epinephrine access for Alaskans with anaphylactic emergencies
