Dear Senator Giessel:

Thank you for sponsoring SB 94 which relates to the practice of pharmacy and updates our pharmacy practice statutes, increases access to epinephrine auto-injectors, clarifies the board executive administrator's salary, and ensures that the Board has the power to support the Drug Supply Chain and Security Act (DSCSA) which relates to manufacturers, out-of-state pharmacies and internet pharmacies and their delivery of safe medications to Alaskans.

In my over 50-year career as a licensed Alaska pharmacist, I have seen our Statutes and Regulations evolve as my profession has grown. I served on the Alaska Board of Pharmacy twice in my career for a total of 16 years. We were always looking for ways to streamline and improve our Statutes to bring them into alignment with modern practice and with the statutes of other states for continuity. Doing so ensures that the Board continues its mandate to protect Alaskan's health, safety and welfare.

There are two pieces of this Statute update that I am especially interested in:

- **Replacing one of the two public member seats with a Pharmacy Technician seat.** Over the years, the public member seats have been hard to fill and often sit vacant. Pharmacy Technicians have become an integral part of our profession and their input is vital. We started talking about doing this when I was Board President from 2000-2004!
- The adoption of regulations for a "retired" pharmacist status. This would bring us into alignment with other states and with other professional licenses in Alaska. I was able to "retire" my licenses in Oregon and California and have wonderful certificates to display that fact. I got my Alaska license in 1970 and would like to "retire" that license as well. Even though I remain an active member my professional organization, I am no longer actively employed. Letting my license "lapse" feels like I am giving up on being a pharmacist. If I were able to "retire" my Alaska license, it would mean that I am still a pharmacist and care about my profession but just not actively employed.
