Dear House Education Committee Members, Senator & Representatives:

An earlier version of this letter was originally written in support of last week's HB 99 bill, and in opposition to HB 105 and SB 96, but the arguments presented therein are timeless.

Let's look to Elizabeth Peratrovich as our example, not just to applaud her past courage, but continue to realize her vision of speaking up for a just present and future for all Alaskans.

Unfortunately, I cannot attend tonight's hearing as I have to work, but I would be remiss if I did not speak up against HB 105 on the record.

Thank you to Senator Kiehl, and Representatives Armstrong, Hannan, Carrick, and Story for reaching back out to me with your encouraging words. It is good to know that I, and other trans and gender-variant folks in all kinds of communities all over Alaska, have neighbors on my side.

Please stand against HB 105/SB 96, and vote in support of HB 99.

The attitude represented in the HB 99 opposition letter filed by Mike Coons of "Concerned Conservatives of Alaska" is exactly why we need to pass HB 99, and stand against HB 105/SB 96 and similar bills.

Opposition leaders may say, "the science has always said," but their intent, in the end, is clear, as Mr. Coons expresses in his letter: to put me, my wife, friends, and people like the doctors and therapists helping us--and helping us all, as a society, to understand new scientific theories and use them to move toward best-practice medical treatments--in jail, or worse, for the 'crime' of asking to be treated with respect, being able to use restrooms in public, or have fair access to housing and employment.

Opposition leaders may say, "we've had such-and-such an understanding of gender for thousands of years," but as Alaskans, please ask yourself, "who is the 'we' in this sentence?"

As the HB 99 supporting document from Dr. Charlene Apok of Native Movement points out, the brunt of the impact of discrimination from this law--and similar laws and practices--has fallen on not just the LGBTQ+ citizens of Alaska, but specifically the "LGBTQ2 youth, adults, and elders within the state of Alaska." Two-Spirit Native people, who Dr. Apok specifically references in her acronym, have already always been here, living in their own lands, expressing their own Indigenous understandings of gender and sexuality, for many thousands of years more than the 'we' in Mr. Coons' letter have been here, bringing with us settler ideas of the sex and gender binary, and a colonial science that forced the imposition of Western scientific ideas on both ourselves, and other peoples, through violence and silence.

Whether you look to the past or the future to answer the question, "should we treat people fairly, give them fair access to the necessities of life like housing, employment, and the major life activities of public and private life, even if their

gender identity and/or sexuality does not match my own understanding?" the answer comes across clearly. Why should the present be any different?

Those who stand in support of HB 99, and against policies like HB 105/SB 96, want to treat all Alaskan people fairly. We supporters have an opportunity to reject a violently imposed, outdated, inaccurate, colonialist mindset about gender and sexuality, medicine, history, and social structure, and help our own Alaskan communities here, whether we ourselves are Native or non-Native, to heal from that violence.

Those who oppose HB 99, and support bills such as HB 105/SB 96, do not want to treat all Alaskan people fairly. Like Mike Coons, they have said themselves, in their own words in opposition to HB 99, that they want to limit those with a gender identity or sexuality they do not themselves understand, and also imprison doctors and other practitioners who are following best-practice medicine. Can criminal penalties and prison for existing as LGTBQ2 people be far behind? Governor Dunleavy, and others, your colleagues, have already shown their willingness to implement and support proposals that perpetuate Mr Coon's vision of silence now. Those who oppose HB 99 and bills like it may want silence now, but envision violence later. Already, Mr Coons openly supports imprisonment of LGTBQ2 people's defenders.

Those who oppose HB 99 and support HB 105/SB 96 are exercising their understanding of power to ensure that the vilification and diminishment of your Alaskan neighbors, friends, and loved ones not only continues, but will be deliberately increased, with the end goal of silence and violence continuing to rule this land, and continuing the historic wrongs done to Native people--especially Two-Spirit people--on their own lands, all in the name of retaining the past colonizer understanding of gender, sexuality, medicine, science, history, and social structure.

This understanding was wrong.

It is wrong historically, it is currently wrong, and it will be wrong in the future.

People whose understandings of gender and sexuality vary have always been here, they are here now, and they will always be here. Do we want to acknowledge that, and move toward healing and reconciliation and fairness?

Or, like those opposing HB 99, will we remain silent--complicit--in the deliberate crafting of new policy and law that continues to hurt not only others, but also ourselves--all in the name of holding on to our own incorrect, violent, colonial understanding that exercising power through silencing the voices of those who don't think 'like us'--like colonists--is the only way to power?

As a 50-year-Fairbanks resident and grandparent to three public school students I stand in strong opposition to HB 105. This bill is seeking to create problems where none exist. Parental rights are already strong in our schools. This bill is a distraction from the real work of this committee.

Parents already have the right to participate in curricular decisions, through participation in school-district curriculum committees, regular open review of curricular materials, and through regular communication with their schools administration and classroom teachers. Teachers are already required to offer alternative instructional materials when requested.

Parents already have the opportunity to opt their children out of sex education classes. Parents already receive written notice of lessons involving human sexuality and reproduction.

Parents already have easy in-person and online access to library materials at their children's schools AND the opportunity to question a book through existing library policy. Any parent may also communicate directly with their school librarian about their child's book selections.

Individual parental rights are already protected.

However a parent's rights over their individual child must not supersede what education professionals have already deemed appropriate. What this bill seeks to do is give undue power to a single parent at the expense of all students. As a Health teacher in Fairbanks, I am concerned about forcing parents to opt their child into sexual education. We have a VERY difficult time getting a certain number of parents to respond to email or etc. I cannot call ALL parents to get them to respond; I do not have the time. There are just too many students who do not, for whatever reason, have parents who respond to letters, emails or notes sent home. This will result in students not being fully educated in sexual health. You would not believe the questions I've had from students who do not understand anything about sex or even how their own bodies function; there are many parents who clearly do NOT educate their kids in this way. Kids NEED this education, and we cannot allow it to be neglected. In a state with really high, and growing, numbers of STDs, this education is especially important. It is also unclear how I could teach about recognizing abuse-- including sexual abuse-- when I can't educate kids about sex. Will some parents consider that sex education? Do I have to worry-- when I'm trying to teach kids something important-- that I'm going to end up in trouble for talking about sex?

I sincerely hope you have listened with open ears to all the testimony here tonight.

You've heard from teachers, parents, students, <u>LAWYERS</u>, that HB-105 is short-sighted, dangerous, and expensive for the state of Alaska.

I'm genuinely sorry if a certain book upset someone or that a parent was upset at the consequences of their child bullying another because of their identity, or if there is some have vague, hazy fears about teaching kids that diversity exists - but how does this bill actually address parental rights that don't already exist, and in fact, are referred to HEAVILY throughout HB-105?

On the topic of objectionable books, English teachers don't just "spring" book reports on kids - from my experience as a student assistant, they plan out curriculums way ahead of time, and send parents home with a syllabus at the beginning of the semester outlining what books will be reported on, that *_parents had to sign off on as having received it_*, so what I heard in prior testimony is that this parent didn't use the rights they *already* had, ignored a permission slip, and instead reacted so objectionably to the material and it's subject that they made their own child uncomfortable talking about it to their parents or teachers, and now this parent wants to make it _every_ Alaskan parents' problem.

To whom it may concern,

I am writing to you today as a constituent residing in Anchorage Alaska to voice my opposition to HB 105.

In regard to the matter of requiring parents to opt-in to their students between taught material related to sexual education, this bill feels redundant and unnecessary as parents already have the option to opt-out. As a child my mother opted-out for most sexual education classes and because of this I thought I was dying when I had my first menstrual cycle. It wasn't until several years later when my mother decided not to bother with opting out that I learned about subjects like consent, which helped me realize my best friend was being sexually abused. It was in that class that I learned how to report that abuse. The only thing this bill would accomplish would be reducing the amount of students that have access to vital lessons like the ones I received due to errors like the child forgetting to bring the form home, a parent missing an email or returning the form too late. Errors which are easily avoided by continuing with the already effective opt-out already available.

Regarding the matter of school's being required to inform parents when a student would like to go by a new name/pronouns, or discloses to a staff member that they are transgender, I find this bill dangerously reckless. Outing students puts these youth at risk of abuse, homelessness, conversion therapies (which have been scientifically proven to be ineffective and harmful), among other unnecessary harm. It undermines the trust that already vulnerable students put in their teachers, which are often the only adults they feel safe with. We all want to believe that parents have their child's health and wellbeing as their top priority, but gambling the child's trust and safety is not an effective means of establishing whether or not that holds true with that child's parents.

Regarding requiring that students use the locker room and restrooms that correlate with their assigned sex. My first concern is how a child's biological sex is going to be determined by schools. Will this be established by a physical exam from the school nurse? A doctor's note? Would students who do not wish to have an exam or whose parents cannot afford an extra doctor's visit be required to use the restroom in the nurse's office? Would they be barred from physical education and sports? If a child is intersex, what then? Transgender youth do not pose a risk to their peers on the basis of those youth being transgender. However, policies requiring transgender youth to use restrooms and locker rooms that correlate with their assigned sex do pose a risk. It requires school administration to undermine a student's identity and reinforce harmful and hateful rhetoric, creating an environment in which that student's peers are being led by example to discriminate against that student. Transgender humans have always existed, will always exist, and the continuation of denial of that reality has no place in legislation on any level.

In closing, HB 105 is unnecessary, it is government overreach, a breach of students' trust, a violation of students' autonomy, and creates more problems than it seeks to solve.

I am writing to express my strong opposition of HB 105. I urge you and the entire House Education Committee to vote against a bill that would put Alaskan students, our youth, at risk.

This bill threatens to do many things to harm Alaskan youth. First, this bill will limit rights and protections of LGBTQ+ students, our students. Forcibly outing students, by requiring written permission before school staff can use a student's preferred name or pronoun will put them at risk for harm. Educators will forced to get parental permission regardless of the student's wishes or appropriateness. The reality is that not all students come from safe and stable homes. By forcibly outing students, you risk exposing them to mental trauma and potential physical harm in those situations where families are not supportive of their child's identity. My name is Rebecca Bernard, I live in Anchorage, and I oppose HB 105.

I am the proud mother of two beautiful children, one of whom is transgender. My daughter has her family's support, because we see how much happier she is now that she's free to live as herself. And we've done our homework, so we know that being trans is a real thing, not a delusion or a disorder; trans people have always existed and they always will. As parents, we want more than anything that our children be safe and happy. I'm sure that's what you want for your children too. My gentle trans daughter poses zero threat to any other child's happiness and well-being.

HB 105 is a harmful bill that has no place in freedom-loving Alaska. I'll focus on just one part of this bill: the requirement that schools get written permission from parents before using a child's chosen name and pronouns at school. The 2018 Human Rights Campaign LGBTQ Youth Survey revealed that only about a quarter of trans youth can count on their family's support. That means that broadly speaking, about 75% of kids would not be able to get this written permission and would have to spend their school days living an identity that no longer fits them. This will make it much more difficult for these kids to thrive at school, academically and socially. Worse, this survey and other studies show that due to social stigma, trans youth have much higher levels of stress, anxiety, depression, and suicidality than youth in general – and that what protects kids from these dangers are family support, school belonging, and peer support. So this provision would target kids who already lack the protection of their family's support and would take away from them the safe space and sense of belonging they now have at school. That would leave these youth with only peer support to lean on – and that's simply not enough.

Our trans youth deserve better: they deserve the same level of support and protection at school that all youth do. They are not a threat to anyone. Instead of this firehose of fear and hostility directed at them, trans youth need their community's love and acceptance, like all youth do. Please reject this harmful bill.

Thank you for the time to testify in opposition to HB 105. I am speaking for myself.

I agree parents have rights to engage about their child's education. As a public school teacher in Alaska for 22 years there were many times I wished for that opportunity, that all parents came to conferences or reached out in some way. But I admit to being baffled by an outcry against and new pressures on public schools and teachers, often by people who have spent very little time in a school. I have hope for positive collaboration. I have hope for positive collaboration.

HB 105 is of particular interest to me. I was a middle school science teacher most of my career. I believe it is of utmost importance that the science of the human body systems begin to be taught before early adolescence. Separating the reproductive system from all the rest and requiring written permission is unnecessarily burdensome, and disregards full understanding of human mental and physical health. There is an associated social context, a need to include what consent means and strategies for communicating boundaries. Sexual assault is far too prevalent in our state and in the nation. Notifying parents about the topic is a good thing and is already done in most schools. Follow-up questions at home are likely. Opting out could happen and in my experience rarely did. As a classroom activity with peers sharing giggles, practice in maintaining a respectful climate, with a teacher presenting facts with grace, sensitivity, and humor creates a bond and a point of trust. I have been told the experience even made the family conversations easier.

The issue of use of gender pronouns perhaps is more delicate. I believe that a conversation between family and any staff person the child trusts and the children themselves <u>could</u> be helpful in some cases. I don't, however, think it is ever respectful to children to override their wishes in this regard. Identity, particularly in early adolescence, is a big deal. I have seen that bullying in elementary school often centers around damaging nicknames. Being called a non-preferred pronoun hurts just as much.

A state law requiring a certain penalty to punish teachers and schools who honor a child's request against the will of a parent is far too heavy-handed. This is a community issue, including recognition that the school <u>itself</u> is a community for children. Maybe middle and high schools student councils should write the policy.

Notification in advance of planned conversations at school about gender identity and sexual orientation for a class or peer group is fine. Sadly, students prevented from participating would be at a huge disadvantage. Parents could be invited, perhaps by teleconference, so they, too, could learn. It is not always easy to understand the spectrum of gender and sexual orientation evidenced by science today. There is a lot of mean-spirited and erroneous talk out there. The variations across gender have always been there. They are not going away, and the value of every person should be celebrated.

Many teachable moments on this topic are spontaneous. Kids of any age bring up words and misinformation they hear outside the classroom. Teachers must have the right to answer unscripted questions and troubleshoot disparagement around LGBTQ issues thoughtfully and sensitively without being afraid of being fired.

Having a safe place to talk about these topics is essential to saving the lives of our children and young adults.
