Amended Budget (in thousands)

- Mental Health Trust: The Alaska Training Cooperative (\$0.6)
 - \$50.0 MHT-GF
 - (\$50.6) MHTAAR
- Compensation to Base FY23 Supplemental General Funds \$6,460.9
 - 3% faculty & additional 1% staff (staff received a 2% increase in FY23)
- Local 6070 Compensation \$543.8 (\$461.7 state funds)
 - 2.75% salary increase
- Technical Vocational Education Program (TVEP) \$6,263.5
 - Increase of \$96.2 from FY23
 - OMB proposing to move TVEP to the language section
- Update Description only to UAA Expanding WWAMI
 - Increase student enrollment in July 2024 (FY25)
