Analysis

This bill creates a new class of petitioners for protective orders by enabling employers to seek protective orders against individuals for committing or threatening to commit acts of violence against the employer or an employee. Additionally this bill creates a new misdemeanor crime of violating a workplace domestic violence protective order.

All new crimes will result in additional workload for the Office of Public Advocacy. The Agency is unable to absorb additional workload increases as a result of trial case backlog created by by jury trial suspensions in response to Covid-19 and by unprecedented recruitment and retention challenges facing public advocacy nationwide. The Agency is therefore requesting one support staff position in FY2024 and beyond:

Add 1 Investigator 1-3 position (Anchorage Range 18 Step C)

Personal Services - \$ 112.7 Indirect rates - \$13.7 Case Costs - \$ 23.1 Travel - \$4.7 Commodities - \$4.0
