RECOMMENDATIONS:

The Senate Finance Budget Subcommittee for the Judiciary submits the following FY24 recommendations to the Senate Finance Committee:

BUDGET ACTIONS:

The Senate Finance Budget Subcommittee for the Judiciary reviewed the Governor's FY24 budget request. The following are highlights of the Subcommittee's action.

Governor's Amended Budget Request:

The Senate Finance Subcommittee accepted all of the Governor's requested changes.

Subcommittee Additions, Reductions and Changes

• Add funding for court-appointed attorneys (\$147.8 UGF.) The court primarily appoints lawyers to represent respondents in adult conservatorship cases, parents in Child of Need of Aid proceedings that involve ICWA, and people convicted of a crime who are filing a second petition for post-conviction relief. The Office of Public Advocacy's new contract rates will be between \$115 and \$145 per hour. This amendment funds the court-appointed attorneys at a level sufficient to pay \$130 per hour. If the court's rates remain below other agencies, they will have difficulty filling these needs.

Remove special counsel funding for the Alaska Commission on Judicial Conduct (-\$27.0 UGF) from the numbers section. The Commission only rarely uses this funding for formal proceedings against judges. There has not been a full formal hearing since FY16.
Because this funding is used responsibly and sporadically, the Subcommittee recommends adding it to the language section.

Organizational Changes:

The Senate Finance Subcommittee does not recommend organizational changes.

Intent or Conditional Language

The Senate Finance Subcommittee recommends a language appropriation for the Commission on Judicial Conduct: "An amount, estimated to be \$0, but not to exceed \$75,000, is appropriated from the general fund to the Judiciary, Commission on Judicial Conduct for special counsel costs related to unanticipated investigations."
