

Operating Budget Comparison DEPARTMENT OF LAW







Human Services

- \$2,000.0 in awards for reimbursements for Medicaid Third-Party Liability (TPL)
- \$6.7 in annuity collections for TPL
- \$518.6 in Medicaid Estate/Trust recovery
- \$594.3 in Medicaid audit settlements and judgements
- \$333.5 in recovery of Medicaid expenditures from post-conviction litigation

Natural Resources

Collected \$1,400.0 in damages associated with sinking of Faulkner Walsh's barge The Delta Chief

State Fiscal Preservation EXAMPLES OF FY2022 REVENUE GENERATION AND PROTECTION

Public Corporations & Government Services

- Obtained \$25,000.0 (less attorneys' fees) in Allianz/Alaska Permanent Fund Corporation securities fraud settlement
- Saved ~\$80,000.0-86,000.0 annually in dismissal of U.S. Department of Education Impact Aid action


- \$6,200.0 in quantifiable consumer benefits in FY2022 for reduction in utilities costs

- Section fully staffed for the first time in several years
- In FY2022, the average caseload per attorney was 50-85 cases; variables include location and severity
- Attorneys continue to conduct most hearings via Zoom or telephone; initiatives move back to in-person hearings may strain existing resources
- While there continues to be some delay in permanency, the backlog created by the pandemic is decreasing

What is Statehood Defense?

Defending the rights and privileges promised to the Citizens of the State of Alaska upon the State's admission into the Union, especially concerning the use, conservation, and management of the State's lands, waters, and natural resources.

Why Statehood Defense?

Protect Alaska's Rights to Manage our Land, Waters, Fish, Wildlife

United States Constitution:

- Establishes a federal government of limited power
- 10th Amendment Expressly reserves State rights
- Equal Footing Doctrine State submerged lands, inland and tidal waters
- Anti-commandeering doctrine

Statehood Act:


- State land selections
- State submerged lands
- Right to manage state lands, waters, fishery resources, mineral development, and wildlife

Federal Submerged Lands Act:

State submerged lands – inland, tidal, and coastal waters

Alaska National Interest Lands Conservation Act (ANILCA):

- State land selections
- Management of state lands, waters, fish and wildlife confirmed
- Sturgeon v. Frost limits the extent of federal lands in Conservation System Units

DEPARTMENT OF LAW CIVIL DIVISION

Add Attorney for Parental Rights in Education Advocate, +209.0 UGF, +1PFT

- There are a number of education laws that protect parental rights in directing and guiding their child's education
- This position would assist parents in advocating for themselves and their students with schools and school districts

Add Attorney to Lead on Tribal Law Issues, +209.0 UGF, +1PFT

- This Civil position would oversee and coordinate the myriad
 of civil issues that continue to arise, such as compacting
 (child welfare, education and potentially gaming),
 government to government consultation, sovereign
 immunity, regulatory actions by the federal government, etc
- This lead attorney would manage the larger picture, act as a liaison, and be the subject matter expert to consult, would ensure the department could adequately address these issues and start thinking more strategically and creatively about how to effectively partner with Tribes while also asserting the state's rights and sovereignty when needed

This increment is necessary to accommodate rate increases to State owned facilities Department of Law occupies.

The Duty of a Prosecutor


The primary duty of a lawyer engaged in public prosecution is not to convict, but to see that justice is done.

-Canons of professional ethics: Canon 5. American Bar Association (1908).

The prosecutor may prosecute with earnestness and vigor – indeed he should do so. But, while he may strike hard blows, he is not at liberty to strike foul ones. It is as much his duty to refrain from improper methods calculated to produce a wrongful conviction as it is to use every legitimate means to bring about a just one.

-Justice George Southerland, Berger v. United States, 295 U.S. 78, 88 (1935).



Recruitment and Retention Applicant Shortage



- 10,000 Baby Boomers retiring per day = 11% of workforce per year. (Washington Post)
- 20% of Alaska state workers projected to retire in 1-5 years (Alaska Department of Administration)
- 11% of Alaska state workers eligible to retire in less than 1 year (Alaska Department of Administration)

FY2021 Department Of Law Budget Slide

Recruitment and Retention Applicant Shortage

- 8% decrease in number of applicants looking for public sector jobs
- Average of 22% fewer applicants per job 2013-2018
- "Legal has suffered the biggest impact in applicants per job, with a 64% decline in applications. Legal jobs saw, on average, 33 fewer applicants per available job in 2018 compared to 2013."

(NEOGOV Hiring Trends Report 2019)

- 19% decrease in Alaska applicants over last five years (Alaska Department of Administration)
- 49 prosecutor positions recruited during 2019 with an average of less than 5 applicants per position.


Improvement In Applicant Numbers

Prosecutors in 2022	19.0% turned over (25 of 131)

2022

- 6 of 25 (24%) transferred to Civil Division;
- 2 of 25 (8%) transferred to Dept. of Admin. (Public Defender/Ofc. Of Public Advocacy)
- 3 of 25 Licensing issue

2022 - hired 31 attorneys - 13 of which had experience

(including 6 former employees returning)

Software and Storage for Audio/Visual Evidence in Criminal Cases, +400.0 UGF

As state and local law enforcement expand their use of multimedia evidence collection and maintenance, the prosecutors and staff must also receive, review, and store the same evidence. This increment will allow the Criminal Division to process, review, and store digital evidence more efficiently.

One Time Request to Expand Internet Connectivity for Rural Prosecution Offices, +350.0 UGF

With upgrades, the Criminal Division can transition several division rural community offices onto the division's cloud-based case management system, improve workflows within the cases, and eliminate the need to maintain local servers within those offices.

FY2024 Governor Amended Proposed Budget Changes

DEPARTMENT OF LAW CRIMINAL DIVISION

Criminal Investigator for Election Fraud, Conflict Cases, and Rural Homicide/Felony Sex Offenses/Other Violent Crimes, +143.7 UGF, +1 Permanent Full Time (PFT)

- Full-time Investigator for election fraud and other matters handled by Special Prosecutions
- There are no dedicated investigators for elections fraud in Alaska
- Reports of potential election fraud are assigned to a law enforcement officer who must simultaneously handle other criminal investigations
- Having a dedicated investigator allows election fraud matters to be a primary focus for the investigator during the election season
- This investigator position can help fill another need in the Office of Special Prosecutions by providing investigative services to two other areas: conflict cases and major felonies from rural communities
