Please include this in my public testimony about HB 105. I'm not usually able to get an internet or phone connection, and I heard emails were best anyway. 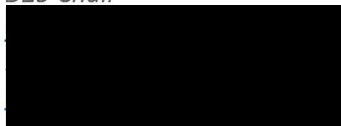

Thank you for your service to the people of Alaska. I'm writing to urge you to oppose House Bill 105.

You have already heard testimony from many Alaskans who feel similarly that HB 105 is an unwelcome distraction from the real work to be done around properly funding preschool, K-12, and secondary education, fixing the retirement system so that you can retain educators, and finding better resources to support the mental health of students and educators. There are so many reasons to oppose this bill!

First, the requirement of written parent permission for students to participate in health education about sexuality and puberty is a solution in search of a problem. Parents already have the right to review materials and opt their children out of this instruction. Sexual abuse is a massive problem in our state. Many young people only learn about appropriate and inappropriate touch in their health classes. This information enables them to recognize abuse and seek help. By erecting a hurdle like written permission, you would remove this invaluable tool in fighting child sex abuse. Further, sexuality education health classes help young people anticipate and plan for the changes they experience during puberty and adolescence. Healthy sexuality helps people live whole and joyful lives. This instruction should include information about consent, sexually transmitted diseases, interpersonal violence, hygiene, and options for preventing pregnancy.

Second, adults seem far more concerned about bathrooms than students do. Requiring students to use the bathroom of the biological sex that they were assigned at birth is not necessary. Students are safest when they use the bathrooms that fit with their gender expression. This new requirement outs transgender students to their peers, staff members, and parent volunteers. It is a violation of their privacy and basic human kindness. There are lots of problems that happen in the bathrooms at school: vandalism, clogged pipes, locked stalls with no one in them, long wait times, smeared feces, overflowing sinks, kids climbing the stall walls, etc. But I've never had students complain about which bathroom others were using.

Again, I strongly encourage you to oppose House Bill 105 and get back to the important business at hand. Our state is hemorrhaging educators and families are going elsewhere because education here is so underfunded. College bound high school graduates are fleeing to better funded secondary institutions. There is plenty of real work for you to focus on.

As a mother of a 3 year old and 5 year old I would appreciate the opportunity to share in their education. My husband and I were both educated through the public school systems. We expect that as our children enter the school system, we will work together with their teachers. The curriculum should be supported by scientific evidence and supplemented with the personal moral and values of each family unit.

My husband and I remember parents coming in to help the teachers with sex education. It was transparent classroom teaching.

The programs presented all the scientific facts of how the human body works both male and female. **Regardless of biological sex or sex identity, the human bodies of male and female always work the same way.** There was also information on birth control. This as well was presented in a scientific manner without the need to add in value statements overreaching into other topics of sexuality. The information was simple and thorough.
