**SUBJ:** Renewal No. 3 of the Lease for Fairbanks Office Space

The original lease agreement between the Legislative Affairs Agency and Alaska USA Federal Credit Union for office space in Fairbanks, Alaska, was for a five-year term that began August 1, 2016. There are five lease renewals available under the lease agreement, each for a one-year period. We have exercised two of the renewal options.

Renewal No. 2 of the lease expires on July 31, 2023. The Legislative Affairs Agency would like approval to proceed with Renewal No. 3 for the period August 1, 2023, through July 31, 2024.

If Legislative Council approves Renewal No. 3, this will leave two (2) one-year renewal options of the lease available before we must issue an RFP or conduct a lease extension.

This lease renewal exceeds \$50,000 in one fiscal year; therefore, Legislative Council's approval is required.
