Dear Representatives--

I am writing to strongly encourage you to move HB52 out of committee to a vote during this legislative session. I also highly encourage your final support of the bill. I honestly think this Patient's Rights bill should be codified nationwide.

I am both a nurse in a hospital and the daughter of a mother who was forced to pass away alone in a nursing home during the early stages of the recent pandemic. So, I take this bill very personally.

My 83 year old mother transitioned to Hospice care in a nursing facility outside of Alaska the beginning of March of 2020 just as things were starting to go "crazy". Nobody ever considered the human factor of the rules they were making. My mother, whose life revolved around her huge extended family, did not have one family member visit her, hold her hand or give her comfort for over TWO MONTHS before she died! She will never get that time back and neither will we! She may have been given physical care and comfort by her caregivers, but there was no emotional support from her family except for the weekly video calls we were allowed to have. Can you imagine how difficult those calls were? She didn't have any understanding of what and why things were the way they were. She had a very difficult time communicating while using the tablet. The tablet couldn't hold her hand, give her a hug or a kiss. At the end, she died of a broken heart as much as the illness that slowly drained the life from her. The other tragedy was her funeral was very important to her. She had even written the program. She was a prominent citizen from a pioneer family in the community where she lived. She never got that funeral and people were not ever allowed to pay their final respects.

As a nurse working in the hospital during the pandemic, what I saw broke my heart. I've always felt strongly that an advocate at the bedside was crucial for patients--for their comfort, emotional and physical support, healing and especially safety. I saw so many lonely, confused, sad and vulnerable patients. It's not that they didn't get good health care, but the staff couldn't reasonably meet their emotional needs. Even though we tried, it was extremely difficult to communicate with their families about the progress of their care, so the family members were suffering as well. The isolation never made any sense to me and in a way, I believe what we did to our most vulnerable citizens was bordering on criminal! We should have and could have done better! This bill will promise and guarantee our loved ones and patients their most basic need--a support person at their bedside!

I am sorry that I was not able to testify at previous hearings for this bill. I just had a long conversation with Rep Prax's staff on this and the so called "issues" by the Hospitals.

My understanding from the call today is that the Feds say that Hospitals can have any rules and regulations they deem necessary to protect themselves and the workers. Fine, but and this is the big but, those regulations can and should be challenged when they are wrong, harm patients and patient families as was done during the China Virus pandemic. To deny families from being with their loved ones is violating basic rights of the patient and those families. The actions of the hospitals was more out of fear vs real science. All hospitals had PPE at many different levels that any and all family members could have used to protect the workers from a possibility of contracting the China Virus in this case. Add to that those same staff were in the communities and interacting with strangers without the level of PPE that they have in the hospitals, thus if they contract that virus, there is no way they could point to family members in the hospital.

Hospitals are wanting to be held harmless from lawsuits be that from angry families that were denied access to loved ones or hospital workers claiming they contracted the disease from families. To me, as a health care worker, we all have a risk of contracting a disease in caring for our patients. When HIV/AIDS first came out we masked up and took extraordinary precautions at the EMS level. Prior to that PPE use and levels at the hospital to EMS was far less than we have now. I can't count the times of encounters of patients where we got blood and body fluids into our eyes, unprotected skin, doing mouth to mouth resuscitation and then being told that under HIPPA law, we could not know if the patient was positive for HIV/AIDS or Hepatitis B! EMS was not testing us for HIV/AIDS or Hepatitis B exposure. In point of fact, I had a job going to Russia as a Site Paramedic and to get into Russia I had to be tested for HIV/AIDS. That was years after HIV/AIDS came out, needless to say the level of anxiety was high when I opened the envelope! Fortunately was negative. The level of PPE and Infection Control procedures have and are highly evolved compare to then. The hospitals have the PPE to give to the

families so they can see their family members, thus protecting the staff.

Per Prax staff, the hospitals are concerned about the cost of camera's in the patient rooms to stop families from doing something the "rules" say they can't do. My wife had a camera in her room because she was a fall risk. Yet to use a room camera to enforce rules, such as hugging the loved one, giving them a kiss is just plain stupid. Frankly knowing many nurses they would look the other way. If a person came in to stop me, there would be hell to pay as well!

Bottom line is I can't begin to imagine the harm, anxiety, loss and anger those that were denied to be with loved ones during this pandemic. I was able to be with my wife throughout the 20 days she was in the hospital. I know it would have taken an army to keep me from her! The lies that were used to push this agenda have now been shown to be just that lies and the use of fear to control people. Then when the people and real science showed that the "science" was fake, then the weaponizing politically toward those that were demanding to see their loved one and those of us that were not and will not comply with all the mandates has caused long lasting if not even harm that cannot be undone.

Where we once listened to our Doctors and scientist, we have lost any faith that they are speaking the truth. That is a harm to the medical community that will last I for decades to come.

Thus, this bill will give us the ability for when the next medical issue comes up so that those actions do not repeat themselves. Hopefully the medical community has learned to not do this again, sadly, the Administrators and other high level scientists and the CDC, I believe learned a valuable lesson. How to control a nation with fear, propaganda and a media fully on their side to take away freedoms, thus, this bill must be passed and then enforced to the max!

Dear Chair Rep Prax and Committee Members:

Thank you for the opportunity to share my viewpoint with your Committee re: HB 52, the No Patient Left Alone Act.

Three years ago I was unaware of a health issue. All I know is that I was getting weaker and more lethargic every day. When my husband finally called for an ambulance, I could barely stay awake long enough to respond to the paramedics.

At the hospital it was discovered that I had a severe viral infection and, if left alone for another day, would have succumbed. I was immediately given two missing pints of blood and placed on the infectious diseases floor, where I remained for six days. As visiting my room required "gowning up" for staff and visitors, I was only minimally seen by staff.

Throughout this time, I was unable to adequately communicate with my physicians and nurses of my needs. Whenever I attempted to explain a problem to staff, I could either not make myself clear or I would be crying from the pain. I believe the only reason I survived this harrowing experience was because throughout each day and into the night my husband was there to communicate for me.

Three days after I was released, that hospital, Providence, closed its doors to all but the patients. I cannot imagine the terror experienced by a patient in my condition being locked away from a spouse, child or parent. In my opinion, what Providence did was criminal, and our family will no longer use Providence for anything.

When I first read Rep Vance's HB 52, I was thrilled that someone was taking measures to ensure that no patient would ever again be abandoned at Providence. With this Bill, administrators can no longer make the cold-hearted decision to isolate patients from their representatives or threaten family members. In my opinion, those that carried out those administrative orders were criminally responsible, and those that created the orders should be charged.

Please forward this Bill out of Committee and ensure that all patients have access to a representative of their choice. Thank you.


