I support HB105 as introduced as a reasonable but sadly necessary protection of parents' rights in Alaska. In my opinion current Anchorage School District "guidelines" directing the concealment of information regarding their children from parents are a potential violation of constitutional and federal law and I have so advised the Anchorage School District in writing.

In *Treacy v. Municipality of Anchorage*, 91 P.3d 252 (Alaska 2004), the Alaska Supreme Court held, citing *Meyer v. Nebraska*, 262 U.S. 390 (1923), "**that parents have a fundamental right to control the upbringing of their children.**" (at 268) In the recent United States District Court decision in *Ricard v. Geary County School Board* May 9, 2022 the court stated:

"while the policy by its terms would prohibit any disclosure of a child's preferred name and pronouns to parents absent a child's permission, the District admitted at the hearing that if parents requested copies of education records that included information concerning preferred names and preferred pronouns, the District would disclose the information to parents without a child's permission because the Family Educational Rights and Privacy Act (FERPA), 20 U.S.C. § 1232g; 34 C.F.R. Part 99, requires it. Thus, the District is willing to make an exception for the secular purpose of complying with federal law, but not religious reasons."

"Because it is illegitimate to conceal information from parents for the purpose of frustrating their ability to exercise a fundamental right, there are real questions whether the District's claimed interests in the Communication with Parents Policy-broadly written as it iswould satisfy even the rational basis standard that would govern if the rule were neutral and generally applicable." (emphasis added)

Dear Education committee members,

Please accept this email as my testimony since I won't be able to call in tonight.

I find it sad that we even need this type of legislation; parents rights and responsibilities for all aspects of their children's welfare have been respected up until the past several years.

As far as I know, as a grandparent, parents must still sign a paper giving permission for their child to enroll in school, go on a field trip, and take something so benign as aspirin at school. They must have permission to get their ears pierced, they cannot get a driver's license until they are old enough, and they cannot vote until they are 18. These are all physical permissions.

How much more critical is it that our children have permissions for emotional and mental considerations, such as those experienced by children both before, during, and after puberty? This is a vulnerable time in a child's development, and a parent is responsible to decide what is best for their child. It is the parent's duty and responsibility to ensure that their child is protected from anything, which in THEIR judgement, may be harmful to THEIR child, physically, emotionally, and otherwise.

It is a parent's role to guide their children and ensure that they are kept safe from what can be a period of poor judgment in a child's life; just because they are growing bigger physically, is not an indication that their mind is mature enough to make important decisions. During what is normally a very confusing and vulnerable time in a child's life, a parent is best suited to determine what is in their child's best interest. There is no substitute for the love of a parent.

There is nobody in any educational setting who should be able to override the role of a parent in a child's life, unless there is evidence of abuse. Anyone who seeks to usurp the will of (most) parents in their children's lives, do not have the children's best interests at heart. Woe to anyone who leads a vulnerable and malleable growing child in a manner which causes harm.

It is for these reasons that I support the proposed changes to AS14.03.016(a) through AS14.18.040, as outlined in HB105. Please pass this bill and protect the rights of parents.

Nelson Mandela had the best interests of children at heart. He said we should protect them from ignorance, molestation, and abuse. Webster's dictionary defines **abuse as**; a corrupt practice or custom; improper or excessive use or treatment i.e., misuse.

When a system, as in this case a school district, inserts itself in between a parent and their child. That in my estimation constitutes SYSTEMIC ABUSE. Science has shown that a youth's brain isn't fully developed until they reach 25 years of age. We were all young once. Who didn't want to be a fireman, a teacher, or a pirate? All 50 states were counted. For Alaska, there was 5,000 youth surveyed, between the ages of 13-17 that self-identified as LGBT. This means 3.81% of youth that self-identify as LGBT. Will killing HB105 then leave schools deciding how the other 96.19% of youth (and their parents) will have to navigate their school lives? What about these youth's rights?

My husband and I were unable to reach the office recording votes regarding HB105 yesterday and would like to urge our votes to be collected or that an additional vote period be alloted for the bill, as this bill directly affects every child in every household and every parent wanting to weigh in on this issue should have the chance to have their vote recorded.

Christopher McBride and Lillian McBride both vote to keep parental rights regarding HB105.

My husband and believe firmly that every individual has a right to do with their body as they choose, but only once they reach legal adult age or are regarded as a legal independent by the state due to reviewed and lawfully judged conditions. We adults can't trust the majority of persons under 18 years of age to make responsible decisions regarding having sex, voteing, getting a tattoo, smoking tobacco, and many other things. We should not expect them to make the right decision in transitioning into the opposite sex without parental consent.

I would like to point out that there is a large spectrum of identities effeminate males and masculine females could fall into. These identities could change as the individual lives their life. It is a drop in the bucket for those who truly wish to transition and wish they could have changed their sex as a child instead of fully developing their unfavorable gender's body. Some are simply homosexual, some are heterosexual but enjoy being "tomboys" or "graceful men," and the list of labels continues but they find joy in their gender bodies they were born with.

In school, kids are heavily pressured to find a label to describe themselves quickly. They are also pressured by their peers to fit into labels they might not fully embrace. As they grow, they learn new terms they feel they fit into, and they change their labels and identity. Some children know what they are immediatly, but others change multiple times -each with conviction. However, as it is now in schools, none of these labels are permanent, life-long decisions. Hormone treatments change brain chemistry and therefore have life-long effects that cannot be undone, even if the treatment is reversed. This is proven in transition case studies.

Taking away parental rights to know about and deny the medical procedure of puberty treatments from their kids is not the correct approach to make sure no trans is denied their optimal opportunity for happiness by transitioning before puberty. Instead, group counseling between the parents, the child, the school, and the state should determine if the child's argument is strong enough to override the parent's authority over their child's optional medical procedures that have life-long effects -including infertility.

To explain my point, here is my personal experience below:

When my sister and I (born females) hit puberty and "Aunt Flow" came to town, my parents would take us out for ice cream for the first few times to answer questions and generally take the displeasure out of the situation. Then we got to go shopping for special items as we developed, and we enjoyed these trips very much.

My brother (born male), youngest of us 3 siblings, would get jealous of these special times he would be left out of. He wouldn't hit puberty for a few years. He would constantly say with conviction that he was jealous of our periods and wished he was a girl. However, my parents would try to explain he would get special treatment too once he hit puberty and he would like it more than ice cream and clothes shopping.

Then his puberty hit and my parents did as promised. He had "manly" adventures and found great joy in strength competitions with his dad. He enjoyed competition sports, started working out, and grew into a happy man with a wife and a child on the way.

My parents knew he didn't actually want to be a girl, and that he was only impatient and jealous of his sisters getting something before he did. He didn't comprehend the full scope of the situation. He was one of those who would be smart enough to convince someone he really wanted to be a woman, but dunb enough not to know the coincidences of pursuing it (if it was a choice he could make).

Before around the age of 16, brains have literally not developed physically enough to comprehend complex situations of cause and effect past around 1 month. That is why the legal age of adulthood has been placed at 18 -that part of the brain should be activated at around that age that provides a more complex comprehension. Before this time, it is up to the parents to make judgment calls for their children's future based on what the parent knows about their children they have raised and share genetic traits with.

If my brother had the option to go to a school authority and change his sex, he would have. And he would have regretted it because he did not actually want to be a woman. He enjoys being a man. And he would have irreversible damage to his puberty and brain that would not have made him happy. He had no idea what he was talking about, but my parents knew what was best.

Therefore, it is important to reserve parental rights in life-long effects regarding their children.
