This is Triston Nyquest, Juneau. I would have preferred to deliver in person so that everyone could see that there are indeed parents (in Juneau no less) who strongly agree with the bill HB 105. I am thankful for our democracy and thankful to You for taking the time to hear my plea.

After listening to those opposing views on the bill one thought kept coming to mind; what is the role of government employees in shaping the worldview of my kids?

I am a certified teacher and have a wife and mother, and many other family members that have been teachers at one point or another. I know teaching is hard, and appreciate teachers maybe more than most, BUT they as government employees should have no more right to have as personal a conversation as one's sexuality with a student. Teachers are professionals, at least they should be, and I would hope that instead of encouraging their students to confide in them on issues like this would encourage students to talk to their parents. I think this sadly is not the case most of the time when these kinds of topics come up at school currently, obviously at least in Juneau by the number of teachers that gave a public testimony tonight.

Teachers like most people have personal beliefs and opinions and sometimes those biases get spilled into the classroom in ways that are inappropriate. Which I believe is what the heart of this bill touches on, that not all teachers conduct themselves in a professional manner and utilize their influence over young children who trust them to tell them what they think and how they should think or feel about particular issues. This gives parents concern that may not believe the same way as those in the classroom or in the school, specifically about how their children are being influenced by other's beliefs in the classroom.

If I as a Christian, and as a teacher started teaching about Christianity in class, most of those opposing this bill would want to have the right to know that as a parent and either exclude their kids from the lesson or sue me, probably sue me, but the point remains.

As a society I think we have to ask the question; where does government influence stop? It seems that just 10 years ago we had the discussion about weather or Not we should even teach sex ed at all, and now we are having the discussion whether or not parents should be involved at all with their child's Sexual education?

I think most parents don't want their 8 year old hearing about different sex positions in class, or seeing explicit sexual images and being told it's okay to feel or think certain things, and "don't worry we won't tell your parents, your secrets safe with us". I fully support HB 105 to protect parental rights.

The schools, teachers, education system need to stay in their lane and FOCUS ON EDUCATION. Alaska public schools sit at the bottom in the nation for education and somehow they feel it's in their area of responsibility and priority to counsel our children on their sexual orientation/sex education?? Schools should be focused on teaching our kids reading, writing, arithmetic, science skills, critical thinking, art/music, history (and I don't mean censored or altered history), geography. NO teacher/school should override my right as a parent or grandparent to teach my child about sexuality.

I don't expect other people to follow my faith or cultural traditions, but I expect other people to respect my faith and cultural traditions, and that includes how I choose to raise my children and grandchildren. To: House Education Committee Members:

**I fully support HB 105 Parental Rights in a Child's Education.** I taught for thirty-two years in Anchorage classrooms, and eight years in Australia. I have a Masters in Curriculum and Instruction with an endorsement in Special Education, and I have taught at all levels of elementary and secondary education.

This is my response to HB 105 and I came to my conclusions after realizing how little parents/guardians know about materials and instruction in Anchorage classrooms/libraries, and how stakeholders' trust may have been betrayed by some Anchorage teachers and librarians. I see HB 105 as a way of leveling the education platform, so that all vested parties are "on the same instructional page." Here are my responses to HB105:

Ideally, parents/guardians take an active role in the education of their child/children. I know the Anchorage School District invites parents to visit classrooms and observe. I am confident those invitations are extended to parents/guardians in all statewide districts. For whatever reason, parents do not find it easy to spend time in a classroom. This bill will require school districts to allow parental access to school records. It requires schools to develop policies asking for written consent prior to providing instruction related to human reproduction and sexual matters. Written notice and consent may be extremely critical in the case of Special Education students. (As an aside and as part of parents becoming more aware of what is being taught in schools, I'm wondering how many of you have read some of the books that are contained in our school libraries with questionable sexual content for young readers? For example, *George/Melissa* has been upsetting parents in districts nationwide for years. It is perceived as sexualizing and grooming youth, and promoting early hormone therapy and gender affirming surgery. It is recommended for grades 3-7 according to the ASD Controversial Concerns Committee report. The book, *George/Melissa*, was unanimously approved by a secretive and clandestine committee, allowing eleven, mostly unnamed members, to control what students in the District can read, and what materials can be used in the classroom for the next three years. With their decision. I have been left wondering why all students need "transgender" information (as the population of transgenders is relatively small), and why this complex, life decision is left in the hands of unqualified, classroom teachers, and is taught as part of a curriculum in some classrooms.

I know the ASD is seeking counselors for all schools, which seems sensible. A counselor has more training in regards to particular student concerns, and is the perfect confidant for those issues that distress our students. A counselor is also the perfect mediator between student and parent/guardian, if need be. I know this law has a protection clause in it if a student's personal welfare is deemed in danger. That seems significant to me and warranted.

I would suggest that students' personal welfare can also be endangered by current library books and would encourage members to read school library books like *The Bluest Eye* (explicit scenes of pedophilia, incest, and rape) by Toni Morrison, *Persepolis* (with confusing shifts in Iranian political history and upheaval, and the advocacy of dialectical materialism; a video of the same name and



meant for adults is also in the ASD libraries) by Satrapi, *Thirteen Reasons Why* (a popular film/book placing a heavy burden on friends after a teen commits suicide) by Jay Asher. I would also ask the Education Committee to review the increasing numbers of books with contentious issues being placed on school library shelves in order to enhance collections. Hmmm.

I think this bill will require that teachers seek parent/guardian approval regarding controversial material, and there will be less suspicion and more harmonious co-operation from all stake holders. There is an uneasiness in schools at the present time; teachers need direction. A bill, of this nature, will surely upset some people, but who has the ultimate right and responsible for the child's education? The parent/guardian, of course. If this bill does not pass, I am hearing that more and more parents are willing to opt for school choice and that will give them the opportunity to be in charge of their child's/children's education and welfare. School funds will then have to be redistributed. I did a quick search on Alaska's top schools and found that Charter Schools do very well.

A fine seems to be appropriate for those who would choose to supersede family values, cultural values, and parental rights. A teacher is given certain discretions within the classroom, but not unquestioning autonomy. There is a curriculum in place and opting for gender discussions and sex education seems to hold the regular curriculum "up to ransom." Our kids are failing reading and math, and it is time for all teachers to fulfill the goals of their Districts and be more acutely aware of curriculum.

I heard lots of people testify tonight about safety and gender identity in the classroom, and I would like to present another perspective. As a substitute teacher, I call roll according to the attendance roll I am given. The roll does not give me a choice or change of name. It gives me the legal name because it is a legal document. It has been my experience that if a child wants to be known by a different name, that person lets me, the sub, know. I do my best formally and informally.

It has occurred to me, however, that a real fire, earthquake, or other disaster, puts a new slant on the seriousness of "chosen identities." Consider that as a sub I would have to notify authorities according to the names on the roll. That leaves a student known by another name and pronoun and possibly dressed as they wish to be identified, in more danger. In all the confusion of some disaster, I might have to ask authorities to find John, when they should be looking for Jane Smith. It also puts those responsible for that individual's safety in danger. A fireman, a policeman, regular teacher, or a substitute teacher by profession will try to save a student's life. That means they will go into a burning building, struggle with a collapsing roof, or shove students into the nearest classroom and lock the door. Not approving this bill is dangerous for the majority of students, as valuable time might be wasted hunting for a student who, by personal choice, doesn't exist on the roll. I am wondering if HB 105 fails whether that would leave lawmakers also vulnerable. A really, smart attorney might say that legislators ignored the importance of legal names and a student or students died as a result.

The bill intentionally strengthens a parent/guardian's legal rights. A baby was named at birth, and the adults/guardians have accepted responsibility for that child's needs, until no longer a minor. The parent's rights include records and information about the student's physical, medical, and mental health. (Please note that I am not disparaging the wonderful young students and people who spoke, the local residents without children that weighed-in, the classroom teachers, the paid professionals involved with mental health, and the passionate parents who proudly spoke in opposition to the bill because they have a transgender child. However, the law in this case clearly sides with the parent/guardian and is more concrete and less emotional.) If a parent/guardian chooses to litigate because a school has knowingly or recklessly denied a parent/guardian's right to access information, and what is being taught in the schools with written notice (in the language spoken at home?) then that is an unfortunate outcome for teachers or schools. Actions have consequences.



There are no statistics I could find that indicate how many students in Alaska identify as LGBTQ. We do know what all vested parties want. We want our kids to be safe. We want our kids to be educated. We want our kids to be successful. I quickly researched half a dozen peer-reviewed articles this evening, and this is what I found. There is a higher degree of depression in students who identify in a minority group like LGBTQ. These students are less suicidal if they have a support group. School nurses should advocate for support for these students. All students benefit from positive mental health. There was no mention of sex education as a relief for adolescents who have gender identity issues, but changing identities as a youth, or later in life can be problematic. The one thing that I found that could be useful to our current discussion, and includes all students, is fostering policies that enhance positive school environments. (Sheras & Bradshaw, 2016) The article suggested rewarding positive student and staff behaviors, and teaching social and emotional skills. The article suggested following some already established ways to foster a positive environment in the school, and staff training for teaching social and emotional skills is recommended. That makes sense to me.

And finally, issues regarding locker rooms and restrooms, is also a part of this bill. All students have to be safe at school. A bathroom or locker room is an area of the school least monitored by school personnel. Strictly speaking a boy stands up to pee and a girl sits down. A girl is in a more vulnerable position in a locker room and should never be in a position to have to dress or undress in front of a member of the opposite sex. How a person feels about his/her gender is not the issue, when it comes down to modesty, exposure, and genitalia. She doesn't need to see his boy parts and her girl parts are private. Period. I'm sure you are aware of a recent rape case where a boy wearing a skirt raped a girl in a girl's restroom. That is outrageous!

While I am sensitive to a person who has conflicted views about his/her gender, I am also very sure that no single person gets to invade the privacy of another person's personal space because of a differing sense of self. This is where the recommendation for a positive school environment may help solve the conflict. A person with a differing sense of self may need to reconcile that some spaces are off limits and be grateful for the safety and privacy of a single restroom. I know some schools have designated a bathroom that insures the privacy and safety of an individual student and that seems reasonable and practical. Additionally, I heard testifiers remark that the concern is for the transgender student's safety at school. If areas like restrooms and locker rooms are not monitored as closely as hallways then for ultimate safety an individual bathroom is warranted.

Respectfully submitted after eight hours of careful and thoughtful consideration. I encourage you to support HB 105 and the majority of parents/guardians who have expressed a need to know, while encouraging districts to do more to develop a positive school environment where all students come to learn and find their place as productive citizens.

Representative Allard,

This is Triston Nyquest, if my name was a eventually called you will remember I was not there. I came to testify at the meeting tonight because my wife was gracious enough to watch the kids by herself to let me come. I stayed for an hour and a half and did not have time to stay the other hour and a half that I would have had to wait to be heard. It was my fault that I got there late. I have never testified before, so the whole process was new to me. Next time I will be more prepared.

But because there was no one else there in person supporting the bill I felt it necessary to follow up with an email with my comments with which I would have preferred to deliver in person so that everyone could see that there are indeed parents (in Juneau no less) who strongly agree with the bill HB 105. I am thankful for our democracy and thankful to You for taking the time to hear my plea.

After listening to those opposing views on the bill one thought kept coming to mind; what is the role of government employees in shaping the worldview of my kids?

I am a certified teacher and have a wife and mother, and many other family members that have been teachers at one point or another. I know teaching is hard, and appreciate teachers maybe more than most, BUT they as government employees should have no more right to have as personal a conversation as one's sexuality with a student. Teachers are professionals, at least they should be, and I would hope that instead of encouraging their students to confide in them on issues like this would encourage students to talk to their parents. I think this sadly is not the case most of the time when these kinds of topics come up at school currently, obviously at least in Juneau by the number of teachers that gave a public testimony tonight.

Teachers like most people have personal beliefs and opinions and sometimes those biases get spilled into the classroom in ways that are inappropriate. Which I believe is what the heart of this bill touches on, that not all teachers conduct themselves in a professional manner and utilize their influence over young children who trust them to tell them what they think and how they should think or feel about particular issues. This gives parents concern that may not believe the same way as those in the classroom or in the school, specifically about how their children are being influenced by other's beliefs in the classroom.

If I as a Christian, and as a teacher started teaching about Christianity in class, most of those opposing this bill would want to have the right to know that as a parent and either exclude their kids from the lesson or sue me, probably sue me, but the point remains.

As a society I think we have to ask the question; where does government influence stop? It seems that just 10 years ago we had the discussion about weather or Not we should even teach sex ed at all, and now we are having the discussion whether or not parents should be involved at all with their child's Sexual education?

I think most parents don't want their 8 year old hearing about different sex positions in class, or seeing explicit sexual images and being told it's okay to feel or think certain things, and "don't worry we won't tell your parents, your secrets

safe with us". I think schools and parents should work together, not be at odds. Parents should not be the last to hear about class material or discussions that happened at school that they were unable to have with their kids on their timing because they weren't notified and were not given the opportunity to speak.
