Representative Allard, Representative Ruffridge, and members of House Education Committee -

On behalf of Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida), I write in opposition to HB 105 Sex/Reproduction Education; Schools.

Just as it has become necessary for our children to be educated on how to respond in the event of school shootings to stay safe, it is also necessary to educate our children on reproductive health, sex safety and how to respond if you are unsafe. This cannot be an opt in program, as every child deserves to have the tools to protect themselves and have healthy dialogue on these issues.

Legislation over human bodies is becoming increasingly hypocritical. The same policy makers who are arguing to remove autonomy when it comes to choice in becoming a parent, and here weare fighting to take away autonomy from our youth in the name of parents.

We are deeply concerned about the lasting impacts that this kind of legislation could have on the mental health of our youth and community members, writ large. Legislation of this nature is likely to lead to increased bullying, harassment, and stigmatization towards LGBTQ+ students. The lack of knowledge on an issue can often lead to fear and misunderstanding – that is why it is absolutely critical that schools remain a safe place for kids to learn about the world – and themselves. Diversity should be celebrated – not suffocated.

The grave reality is that 45% of LGBTQ+ youth have seriously consider attempting suicide in last year. LGBTQ+ youth who found their school to be LGBTQ-affirming reported lower rates of attempting suicide. LGBTQ+ youth who live in a community that is accepting of LGBTQ+ people reported significantly lower rates of attempting suicide than those who do not.

Tlingit & Haida will always stand in support of ALL citizens' rights. To protect student rights, privacy, and health, I urge you to oppose HB 105 / SB 96.

HB 105 will increase bullying, harassment, and stigmatization towards LGBTQ+ youth, especially trans students. The bill's provisions perpetuate stigma and discrimination, putting LGBTQ+ youth at greater risk of depression and suicide. The bill targets transgender students by forcing them to use a bathroom or locker room that doesn't match their gender identity. This would violate students' privacy and force trans youth to choose between violating their sense of self or facing punishment. Trans youth deserve dignity, respect, and the opportunity to live a healthy life, and lawmakers should oppose this bill to protect all students' privacy and health. HB 105 threatens LGBTQ+ students' sense of safety and makes it difficult for them to live healthy and safe lives. All kids have the right to feel safe at school.

This bill is similar to Florida's "Don't Say Gay" bill by requiring written permission from parents before students can participate in any activity involving gender identity, human reproduction, or sexual matters, including sexual abuse or assault awareness. With the highest rate of child sexual assault in the nation, Alaska children need access to this information. This bill could have serious unintended consequences and restrict access to critical information. The bill prohibits sex education below 4th grade, despite the importance of equipping children with skills for good health and critical thinking. Over 90% of Alaskan voters agree that sex education should be medically accurate and age-appropriate, including healthy relationships, consent, and communication skills.

The bill would forcibly out LGBTQ+ youth to their parents, requiring written permission before school staff can use a student's preferred name or pronoun. Educators are forced to get parental permission regardless of the student's wishes or appropriateness, and parents can sue the district for violating their rights, further straining school budgets and resources. This bill allows parents to access a student's health record without their consent, undermining the trust between students and school counselors. LGBTQ+ youth deserve to be affirmed in their identity and have access to health care and counseling without fear of being outed to their parents. If a youth has not come out to their parents about their identity, it is likely for good reason; no child should be forcibly outed to people they're not yet ready to talk to, nor should teachers be put in a position to potentially compromise the safety of their students by sharing that information with parents who may not be receptive to it.

This bill is hateful, harmful, and discriminatory. I understand the desire for parents to feel included and involved in their child's education, and the desire to protect them from information parents may not their students are prepared to learn. Sexual health, safety, and identity are appropriate and necessary topics to educate students about at any age, and I urge you to oppose this bill which would jeopardize students understanding of critical health information and directly harm their sense of safety and belonging at school.

Hello Co-chairs Allard and Ruffridge and the House Education Committee,

I am writing today in DEEP opposition to HB 105, a bill that benefits no one and does nothing but limit parental rights and harm our children.

Parents do not have ownership over their children, and their ability to express themselves and be their authentic selves should not be curtailed by the misguided beliefs of a bigoted parent.

Prior to living in Alaska, I worked in many different public schools as a science educator. In that capacity, I served as a faculty advisor for the GSA, or Gay-Straight Alliance, where LGBTQ+ students were able to have a safe place away from their peers' bullying (and oftentimes their bigoted parents' bullying as well).

You are intentionally letting parents supersede their own children's agency and identity in an attempt to provide "parental rights," and you KNOW that requiring parents to opt into programs like the GSA will out children to violent households and bar them from participating in the few school programs that will support these children. You are allowing child abuse in the pursuit of political gain.

You cannot legislate away LGBTQ+ children, you can only make life more miserable for them and the teachers who actually care about their students' safety. HB 105 would empower bigoted, uninformed parents to litigate against schools and school districts simply for doing what's best for their students. This is only going to make even more qualified teachers and administrators leave the state or leave the profession, something that Alaska cannot afford in the least.

Let's also talk about another component of this legislation, the one that would require school districts to either force trans students to use the restroom or locker room of their sex assigned at birth, no matter how these students present externally or identify currently, or use a separate isolated facility (or other safety protocols, whatever they may be). Let's put aside for now the complete misrepresentation of "biology" and the erasure of individuals who are intersex and therefore do not neatly fall into a single box. Let's put aside, for instance, the absurdity of putting someone who has identified and presented as male their entire lives (maybe even having secondary characteristics like facial hair) in the girls' locker room. This is a policy that is engineered specifically to harm children.

Your aim with this part of the legislation is to either force trans students to detransition, causing massive mental health damage, harming their families and friends (so much for parental rights), or to make them kill themselves, or leave the public school system (or state) entirely. This is a disgusting policy aimed at individuals who have done NOTHING wrong other than existing as their authentic selves. Trans people only want to use the bathroom for the same reason everyone else does - they are NOT inherently predators.

You can claim that this policy will give "local control" and "parental rights." However the impacts of this policy will extend far beyond the individual school districts and their communities. Even if you don't live in a school district governed by theocrats who ignore testimony from LGBTQ+ students and their parents, such as the Mat-Su Borough School District (that ignored a litany of comments in opposition to their recent trans sports and bathroom bans and rejected a petition from their students to create a separate gender neutral bathroom), there will still be effects to

students all across Alaska.

I know personally young trans people who have committed suicide in Juneau in the wake of this wave of politicallymotivated and entirely fabricated otherization of trans people. Juneau would likely not adopt a policy like the Mat-Su, but trans people in Alaska are still waiting in anxiety to see if the hate from areas such as the Valley trickle down into their communities, and are impacted just the same.

In summation, this bill is lazy. This bill is hateful. This bill addresses no issues that we have in Alaska and only will create more as teachers, administrators, students, and businesses leave the state in droves. This bill is just a thoughtless copyand-paste job from a lazy administration that seeks to demonize children for its own political gain. Shame on you, shame on the governor, and shame on anyone who actually promotes this kind of garbage in our schools.

Throw this terrible bill into the trash where it belongs.

My name is Ben Kellie. I am a resident of Anchorage, Alaska and am writing this email in my personal capacity as a citizen of Alaska.

I am strongly, stridently, and wholly <u>OPPOSED to HB105</u> in any form. I stand with the Alaskans who, during the last testimony period, made clear their strong opposition to this bill. We do not need outside politicians driving legislation in Alaska, nor do we need to advance legislation that will hurt children.

I am a straight, white, cisgendered man, a business owner, and a father. It may seem odd to you for someone like myself, who is neither transgendered nor has transgenered children, to have such a strong opinion on this issue. Though I was never in favor of legislation targeting trans people, the full weight of the importance of supporting our trans neighbors became clear to me about six years ago.

I was volunteering at a "Speed Mentoring" event in Anchorage where kids from all over the district go from table to table to learn about different career opportunities that they may want to pursue one day. A young person sat down at my table and, according to my log sheet they were named "Beth" (changed to protect them). I addressed them as such and they said, "Actually my name is Tyler. Isn't that weird?" I told them, "No that's not weird, I'm happy to call you whatever you'd like."

The look that came over that child's face when I said that simple sentence is hard to describe. Surprise and happiness, yes, but mostly relief. Remembering their reaction brings tears to my eyes because they simply wanted something that I received and took for granted every single day: To be who they are, and to be comfortable doing it.

When the time to change tables came, Tyler asked not to leave. I let them stay at the table and introduced them to each new round of students who joined us. None of the students had any issues with Tyler being there and being called by their preferred name, and everyone got along famously. Between rounds Tyler began to open up to me about the struggles they'd faced with their family and in their community. When I consider now that 82% of trans kids contemplate suicide, I am filled with dread for Tyler and hope they are ok.

It's hard enough to be a teenager in this world without being targeted for who you are. HB105 does not keep kids safe. HB105 would have caused someone like Tyler to hide, feel ostracized, and not able to open up to someone at a networking event.

It is important for cisgendered allies to stand-up for our neighbors who simply want to live their lives alongside us in community. Thank you for listening to Alaskans' overwhelming opposition, and for the opportunity to testify.

Representative Allard, Representative Ruffridge, and members of House Education Committee -

On behalf of Central Council of Tlingit & Haida Indian Tribes of Alaska (Tlingit & Haida), I write in opposition to HB 105 Sex/Reproduction Education; Schools.

Just as it has become necessary for our children to be educated on how to respond in the event of school shootings to stay safe, it is also necessary to educate our children on reproductive health, sex safety and how to respond if you are unsafe. This cannot be an opt in program, as every child deserves to have the tools to protect themselves and have healthy dialogue on these issues.

Legislation over human bodies is becoming increasingly hypocritical. The same policy makers who are arguing to remove autonomy when it comes to choice in becoming a parent, and here weare fighting to take away autonomy from our youth in the name of parents.

We are deeply concerned about the lasting impacts that this kind of legislation could have on the mental health of our youth and community members, writ large. Legislation of this nature is likely to lead to increased bullying, harassment, and stigmatization towards LGBTQ+ students. The lack of knowledge on an issue can often lead to fear and misunderstanding – that is why it is absolutely critical that schools remain a safe place for kids to learn about the world – and themselves. Diversity should be celebrated – not suffocated.

The grave reality is that 45% of LGBTQ+ youth have seriously consider attempting suicide in last year. LGBTQ+ youth who found their school to be LGBTQ-affirming reported lower rates of attempting suicide. LGBTQ+ youth who live in a community that is accepting of LGBTQ+ people reported significantly lower rates of attempting suicide than those who do not.

Tlingit & Haida will always stand in support of ALL citizens' rights. To protect student rights, privacy, and health, I urge you to oppose HB 105 / SB 96.

HB 105 will increase bullying, harassment, and stigmatization towards LGBTQ+ youth, especially trans students. The bill's provisions perpetuate stigma and discrimination, putting LGBTQ+ youth at greater risk of depression and suicide. The bill targets transgender students by forcing them to use a bathroom or locker room that doesn't match their gender identity. This would violate students' privacy and force trans youth to choose between violating their sense of self or facing punishment. Trans youth deserve dignity, respect, and the opportunity to live a healthy life, and lawmakers should oppose this bill to protect all students' privacy and health. HB 105 threatens LGBTQ+ students' sense of safety and makes it difficult for them to live healthy and safe lives. All kids have the right to feel safe at school.

This bill is similar to Florida's "Don't Say Gay" bill by requiring written permission from parents before students can participate in any activity involving gender identity, human reproduction, or sexual matters, including sexual abuse or assault awareness. With the highest rate of child sexual assault in the nation, Alaska children need access to this information. This bill could have serious unintended consequences and restrict access to critical information. The bill prohibits sex education below 4th grade, despite the importance of equipping children with skills for good health and critical thinking. Over 90% of Alaskan voters agree that sex education should be medically accurate and age-appropriate, including healthy relationships, consent, and communication skills.

The bill would forcibly out LGBTQ+ youth to their parents, requiring written permission before school staff can use a student's preferred name or pronoun. Educators are forced to get parental permission regardless of the student's wishes or appropriateness, and parents can sue the district for violating their rights, further straining school budgets and resources. This bill allows parents to access a student's health record without their consent, undermining the trust between students and school counselors. LGBTQ+ youth deserve to be affirmed in their identity and have access to health care and counseling without fear of being outed to their parents. If a youth has not come out to their parents about their identity, it is likely for good reason; no child should be forcibly outed to people they're not yet ready to talk to, nor should teachers be put in a position to potentially compromise the safety of their students by sharing that information with parents who may not be receptive to it.

This bill is hateful, harmful, and discriminatory. I understand the desire for parents to feel included and involved in their child's education, and the desire to protect them from information parents may not their students are prepared to learn. Sexual health, safety, and identity are appropriate and necessary topics to educate students about at any age, and I urge you to oppose this bill which would jeopardize students understanding of critical health information and directly harm their sense of safety and belonging at school.

Hello Co-chairs Allard and Ruffridge and the House Education Committee,

I am writing today in DEEP opposition to HB 105, a bill that benefits no one and does nothing but limit parental rights and harm our children.

Parents do not have ownership over their children, and their ability to express themselves and be their authentic selves should not be curtailed by the misguided beliefs of a bigoted parent.

Prior to living in Alaska, I worked in many different public schools as a science educator. In that capacity, I served as a faculty advisor for the GSA, or Gay-Straight Alliance, where LGBTQ+ students were able to have a safe place away from their peers' bullying (and oftentimes their bigoted parents' bullying as well).

You are intentionally letting parents supersede their own children's agency and identity in an attempt to provide "parental rights," and you KNOW that requiring parents to opt into programs like the GSA will out children to violent households and bar them from participating in the few school programs that will support these children. You are allowing child abuse in the pursuit of political gain.

You cannot legislate away LGBTQ+ children, you can only make life more miserable for them and the teachers who actually care about their students' safety. HB 105 would empower bigoted, uninformed parents to litigate against schools and school districts simply for doing what's best for their students. This is only going to make even more qualified teachers and administrators leave the state or leave the profession, something that Alaska cannot afford in the least.

Let's also talk about another component of this legislation, the one that would require school districts to either force trans students to use the restroom or locker room of their sex assigned at birth, no matter how these students present externally or identify currently, or use a separate isolated facility (or other safety protocols, whatever they may be). Let's put aside for now the complete misrepresentation of "biology" and the erasure of individuals who are intersex and therefore do not neatly fall into a single box. Let's put aside, for instance, the absurdity of putting someone who has identified and presented as male their entire lives (maybe even having secondary characteristics like facial hair) in the girls' locker room. This is a policy that is engineered specifically to harm children.

Your aim with this part of the legislation is to either force trans students to detransition, causing massive mental health damage, harming their families and friends (so much for parental rights), or to make them kill themselves, or leave the public school system (or state) entirely. This is a disgusting policy aimed at individuals who have done NOTHING wrong other than existing as their authentic selves. Trans people only want to use the bathroom for the same reason everyone else does - they are NOT inherently predators.

You can claim that this policy will give "local control" and "parental rights." However the impacts of this policy will extend far beyond the individual school districts and their communities. Even if you don't live in a school district governed by theocrats who ignore testimony from LGBTQ+ students and their parents, such as the Mat-Su Borough School District (that ignored a litany of comments in opposition to their recent trans sports and bathroom bans and rejected a petition from their students to create a separate gender neutral bathroom), there will still be effects to

students all across Alaska.

I know personally young trans people who have committed suicide in Juneau in the wake of this wave of politicallymotivated and entirely fabricated otherization of trans people. My name is Ben Kellie. I am a resident of Anchorage, Alaska and am writing this email in my personal capacity as a citizen of Alaska.

I am strongly, stridently, and wholly <u>OPPOSED to HB105</u> in any form. I stand with the Alaskans who, during the last testimony period, made clear their strong opposition to this bill. We do not need outside politicians driving legislation in Alaska, nor do we need to advance legislation that will hurt children.

I am a straight, white, cisgendered man, a business owner, and a father. It may seem odd to you for someone like myself, who is neither transgendered nor has transgenered children, to have such a strong opinion on this issue. Though I was never in favor of legislation targeting trans people, the full weight of the importance of supporting our trans neighbors became clear to me about six years ago.

I was volunteering at a "Speed Mentoring" event in Anchorage where kids from all over the district go from table to table to learn about different career opportunities that they may want to pursue one day. A young person sat down at my table and, according to my log sheet they were named "Beth" (changed to protect them). I addressed them as such and they said, "Actually my name is Tyler. Isn't that weird?" I told them, "No that's not weird, I'm happy to call you whatever you'd like."

The look that came over that child's face when I said that simple sentence is hard to describe. Surprise and happiness, yes, but mostly relief. Remembering their reaction brings tears to my eyes because they simply wanted something that I received and took for granted every single day: To be who they are, and to be comfortable doing it.

When the time to change tables came, Tyler asked not to leave. I let them stay at the table and introduced them to each new round of students who joined us. None of the students had any issues with Tyler being there and being called by their preferred name, and everyone got along famously. Between rounds Tyler began to open up to me about the struggles they'd faced with their family and in their community. When I consider now that 82% of trans kids contemplate suicide, I am filled with dread for Tyler and hope they are ok.

It's hard enough to be a teenager in this world without being targeted for who you are. HB105 does not keep kids safe. HB105 would have caused someone like Tyler to hide, feel ostracized, and not able to open up to someone at a networking event.

It is important for cisgendered allies to stand-up for our neighbors who simply want to live their lives alongside us in community. Thank you for listening to Alaskans' overwhelming opposition, and for the opportunity to testify.

To the Honorable Members of the Alaska House Education Committee:

I am a resident of Senate District H, House District 15. On the evening of 13 April 2022, I testified via phone before the House Education Committee regarding House Bill 105, Governor Dunleavy's "parental rights" bill. During that testimony I made what I hope was a morally persuasive argument against this misguided and dehumanizing bill. I would like to supplement my spoken remarks with written remarks that, I hope, lay bare the wild impracticality and unfeasibility of this bill.

I taught sixth grade in the Anchorage School District for five years. During that time, despite what the baroque imaginations of some of HB105's backers might lead you to believe, I never once independently brought up the topic of gender identity or sexual preference—I was too busy teaching students to write multiparagraph essays, to read critically, to do science, to multiply fractions. However, because children are autonomous humans with identities of their own, sometimes the topic came up—once because students were using the term "gay" as a derogatory (as I habitually used to, to my own eventual regret, as an adolescent) and once because a student, who had formerly identified and presented as a girl, announced to the class that she was a boy and wanted to be addressed that way.

Some students were, rather understandably, perplexed, and one boy asked me, "Why does that student want to be called a boy now?" The student in question was Samoan, and I used my limited familiarity with Samoan culture to explain it to him in terms of *fa'afafine*, a third gender identity in traditional and contemporary Samoa. I would like to use this incident to illustrate the unsurmountable problems HB105 would present to working educators.

If HB105 had been in effect when this incident happened, a strict reading of it would hold that by answering the student's perfectly understandable question about his classmate, I was in violation of the clause requiring that, "before any activity, class, or program that includes content involving gender identity," his parent must "receive notification not less than two weeks before the activity, class, or program; and provide written permission for the child to participate in the activity, class, or program." To be more specific, the bill would leave me open to *civil liability* for answering a child's question about his classmate.

But the problem is far worse than that. Consider the issues that arise from discussing *fa'afafine*, not in the context of explaining gender fluidity to a student regarding his classmate, but as a well-known, long-standing, and rather important aspect of Samoan/Polynesian culture.

It should be uncontroversial that Polynesian culture is worth studying in Alaska--particularly in Anchorage, a great Pacific Rim city, Polynesian culture forms one of the brightest strings in the tapestry of our society But even if Polynesians weren't our friends and neighbors in Anchorage, Polynesia is home to one of the world's most noteworthy and interesting cultures. So, could a teacher run afoul of HB105 by teaching about *fa'afafine* and analogous third and fourth genders in other Polynesian societies? After all, it is "content involving gender identity." A possible response would be to cover other aspects of Polynesian culture, but leave out *fa'afafine*. Another would be to teach about *fa'afafine*, but to require two weeks' notice and a permission slip, with students presumably cast off to study hall or to twiddle their thumbs if they forgot to bring the permission slip home or back or their parents forgot to sign it.

But what about another world culture often studied in K-12: medieval Europe? We all learned about the Middle Ages growing up, and in particular we learned about the rather strict gender roles of that society: lords and ladies, knights and damsels. Men in medieval Europe performed certain jobs and dressed a certain way, and women did other jobs and dressed in other ways, and anyone who deviated (like the famous Joan of Arc) was often severely punished. Does *this* run afoul of HB 105? This is clearly still "content involving gender identity."

If the answer is "Yes," then it is clear evidence that HB 105 is simply untenable. It would require every social studies teacher to have a permission slip for nearly every lesson in their curriculum, and not only that but *obligate* them, under civil penalty, to excuse from class every student who didn't have the permission slip for that day. "Gender identity" is an inescapable part of the human experience and touches on nearly every aspect of life. In medieval Europe, for instance, different societies had different rules regarding whether, and under what circumstances, women could inherit land and title; and many a war of succession was fought due to competing claims based on different rules. In a non-trivial sense, medieval Europeans fought wars over gender roles and norms. It is therefore impossible to meaningfully teach anything about medieval history—social, economic, political, or military—without discussing gender identity, and only brief mental exercise will reveal that the same is true of any historical period anywhere in the world. If the goal of HB 105 is to mire every school district and every teacher in the state in litigation, it is well-constructed for that purpose; as a vehicle for anything else, it is a disaster.

If the answer, though, is "No"—lessons about *fa'afafine* require written permission slips, but lessons about lords and ladies does not, then it is clear evidence that HB 105 is simply discriminatory. It tells students that European gender roles are "the norm," an ordinary and unremarkable part of the social studies curriculum; whereas Samoan gender roles are scandalous and require parental permission to even discuss. It means that discussing Samoan gender roles is optional and European gender roles is not. Even worse, it actively *forbids* students from learning about Samoan gender roles if they do not have a permission slip; it suggests that Samoan culture (and many other cultures beside, including many indigenous American cultures) is off-limits and "other" in a way that European culture is not. Alaska is one of the most diverse states in an outrageously diverse country, and this approach would preclude students from these diverse backgrounds—but not European-American students!--from learning about *their own* cultures. We cannot put teachers in the position of choosing which of their students' cultures are normal and which are abnormal.

In sum, HB 105 is either wildly untenable, or untenably discriminatory. It is an irredeemably flawed piece of legislation conceived in contempt for Alaskan students' dignity and dedicated to the proposition that some students are more equal than others. I urge each member of this committee to recognize that this bill is beyond redemption, and to vote against advancing it out of its committee."

Good afternoon,

My name is Courtney Weaver, I am an Anchorage, Alaska resident and am contacting the Education Committee in strong opposition to House Bill 105, the so-called "Parental Rights" bill. I testified for the first time on Thursday April 13th during the 5:15pm committee meeting; as I had stated in my testimony this bill should not be entertained or brought to a vote. According to the Gay, Lesbian, and Straight Education Network's 2021 National School Climate Survey 81.8% of LGBT+ identifying students do not feel safe in their school environment; 68% said they felt unsafe due to their sexual orientation (i.e. identifying as gay, straight, bisexual, pansexual, etc.) gender identity (i.e. female, male, nonbinary), or gender expression. As written this bill would only add to their struggles. As many testifiers had stated during last night's hearing LGBT+ youth face higher rates of violence, bullying, suicidial thoughts, and suicidal attemps; House Bill 105 does nothing to help address parental struggles with their LGBT+ child's mental wellbeing.

Many of the changes and additions zero in and target students who are part of the LGBT+ community; because of this I find myself worried that as a future educator I will not be allowed to practice *Inclusive Pedagogy*. This school of thought focuses on making diverse students feel as though they are part of their school environment by making the classroom inclusive for all students no matter their race, creed, ethnicity, gender, or expression. I have read the bill in its; entirety and do not respect or appreciate the remarks made by Co-Chair Allard that voters are misinformed and do not understand the text of the bill, because I do. I understand that requiring written permission for a student to go by a different name or pronoun in the classroom effectively 'outs' a child to their family - whether that is the bill's intention or not that is what will happen. The requirement will only serve to eliminate another safe space for students. Of course not all parents are abusive or will choose to neglect their child due to their sexual orientation or gender identity; but there are far too many that will abuse or neglect their child that making this -a requirement is not worth the risk. Alaska's system is already inundated with far too many children in the foster care system. Do not put this burden on educators who are already the first line of defense and mandatory reporters for childhood abuse and neglect.

Secondly, this bill is contradictory. As stated in Section 1 lines 20 - 25: 20 (7) requiring written permission from a parent before the name or 21 pronoun used by a public school to address or refer to the parent's child in 22 person, on school identification, or in school records is changed 23 (8) requiring that a parent be informed in writing of the right to 24 pursue legal action against a school district if the parent's rights have been 25 violated.

Only to be followed by Section 4 lines 12 - 21:

12 shall provide a copy of the child's record. When responding to a request for 13 records, a school district or regional educational attendance area may not 14 selectively withhold information regarding a child's physical, medical, or mental 15 health from a parent, foster parent, or guardian unless a reasonably prudent 16 person would believe that disclosure of the information would result in child 17 abuse or neglect as defined under AS 47.17.290. This section does not apply to 18 (1) a record of a child who is an emancipated minor; or 19 (2) record information that consists of the child's address if the school 20 district determines that the release of the child's address poses a threat to the health or

21 safety of the child.

So now I ask this legislative body: would a reasonably prudent teacher or administrator disclose a student's in-class request to be called by a different name or a different pronoun to a parent or caregiver with a known history of abuse? Or a household wherein the child has privately expressed discomfort or nervousness in telling their caregiver about their new found identity? Would a failure to tell a household under investigation by the State of Alaska Department of Health and Human Services Office of Children's Services result in a lawsuit? Would it result in a caring involved teacher being disbarred? Would it result in the death of a child?

Third, parental involvement is only an issue for parents who choose not to be involved in their child's education. Section 5 would require parental permission and opt-in practices for health related subjects such as sex education, reproductive education and gender identity. Parents are notified via newsletter or personal letter when **planned lessons will take place**. If an *involved* parent is truly against their child learning such things in a class setting they then have the option to opt-out of the lesson. The teacher would then plan to either have that child in a different class room for that time period or would assign the child a different lesson to work on during the planned time. Section 5 does not add or take away from parental rights; rather it makes a teacher's job more difficult.

Much of what this bill is trying to paint itself as is already legally protected under local regulation, state laws or federal laws. The Federal Educational Parental Rights Act provides legal protections to parents' rights to access their child's records. Anchorage School District teachers publish links to their lesson plans via school applications. What this bill does, however, is stoke the flames of hatred and demonization of the LGBTQ+ community. While Governor Dunleavy would like to fight culture wars to garner attention and support of right wing extremists our classrooms are falling short to help our children achieve their goals.

If the Governor would like to help parents and increase Alaska's success he would support a state income tax, slashing oil tax credits, taxes on out of state workers, and so much more. There are better ways to address the growing issues that face today's youth and their caregivers, House Bill 105 is not it. So I write to you today to urge you to oppose House Bill 105.
