I can't believe I have to do this again- so soon after writing the last time (March 30). I'm writing to express my vehement opposition to HB105. I would call in but I will be at my 2nd job during the public testimony time frame- a job taken so I can help pay for out of state college for my trans son. College in a state where we feel he can be safe and be himself without constant attacks from people who deny his very existence.

The agony I went through as a parent watching my child struggle with mental health issues in his pre-teen years is reemerging now as fear over his safety in our home state and many parts of the country. It took a long struggle in counseling for him to realize what was so negatively impacting his mental health- the anxiety, depression, intrusive thoughts, self-harm-- all finally began subsiding as he started outing himself as trans and asking us to use his new name and pronouns. My son was always a straight-A student, in gifted, AP, and IB classes. School had always been his favorite place. He buried himself in his schoolwork and maintained his high grades but school became almost unbearable at times. On the surface his school was supportive of LGBTQ kids, including special accomodations for trans kids. However, certain individuals took it upon themselves to not follow the accommodating practices. There were also problems with substitute teachers deadnaming my son due to database issues. Due to COVID concerns, there were multiple substitute teachers daily. So my son's refuge became a dreaded place. Eventually, we were able to work with the principal and other staff to address the problems and life settled into that of a typical HS senior- college exams, applications, essays, and prom rather than anxiety and multiple meetings over names and pronouns. My son is now a pre-med major at a top-tier school on a huge merit award- a testament to his resilience and the support of family, counselors, and many individuals at his school.

To now threaten to take those same supportive systems away from other struggling kids is criminal. My son had the support of his family and could be out at home, however many children do not have that chance. Even my son came out at school first- to friends and teachers before gathering his courage to come out at home. To think that other children would be forcibly outed without their consent before they're ready is appalling. To not provide bathroom facilities for all students to feel safe while taking care of bodily necessities is appalling.

I am unhappily willing to provide more information about our struggles and successes in order to help defeat bills like this.

I'm retired and live in Anchorage. I strongly oppose HB 105. The opt-in requirement is especially troubling. Alaska has a very high rate of sexual abuse and many of the abusers are often times a parent or a "friend" of a parent. As an example, a young woman in her twenties told me that when she was in elementary school, she was molested by her mother's boyfriend (dealer) several times so her mother could get drugs. My young friend thought it was normal behavior until she learned in school it wasn't. Do you think her mother would have opted-in?

In the 1980's, I met a young woman who was raped regularly by her father starting when she was 12. In adulthood, that woman had addictions to drugs and alcohol. She allowed her adolescent daughter to be abused by her dealer in exchange for drugs. Her daughter died of AIDS before her 21st birthday.

Children and teens who are in similar situations today would be endangered if HB 105 is enacted. So I don't see this bill as Parental Rights Bill. If enacted, HB 105 could be considered an Abuser's Rights bill. What about the student's right to not be abused? Parents and guardians already have the ability to review materials used for instruction and can opt-out for their student to receive classes they find objectionable.

All of the gender identity language in this bill should not be in state statute and is very discriminatory.

I feel like we don't have enough education employees as it is to teach kids, the last thing we need are the "private parts police" making sure everyone uses the correct restroom. Again, if you care who you pee next to, then use the bathroom in the nurse's office. I have a personal story of how this kind of behavior effects children. My 11-year old daughter is on the swim team and someone decided that they were going to police the locker rooms at the gym to make sure kids were using the "correct" locker room. My daughter has short hair. She likes her hair short because she doesn't have to do anything with it in the mornings and it's easier and she likes the way it looks. An adult comes

up to her WHILE SHE HAS A TOWEL WRAPPED AROUND HER NAKED BODY (tell me that's not super creepy) and says to my daughter that the boy's locker room is the next door. My daughter says, "yeah I know." The creepy adult DOESN'T leave it at that. They continue on saying that my kid should make sure they are in the right locker room. This adult women is intimidating my daughter for being in the correct locker room. In order to get this adult to leave her alone, my daughter had to say, "I know, I'm a girl and I'm in the right locker room." This is 100% awful behavior and I see this HB 105 being the exact same thing. It gives adults the right to approach kids and judge them as they see fit. It gives adults permission to approach an 11-year old little girl that is just trying to change after swim team and question whether they have a penis or vagina because that's exactly what this lady was intimating to my daughter. It's horrifying to imagine a learning environment where teachers cant support their students. I am short on time so I will quote an article written beautifully by an unnamed author

"If passed, HB 105 would require school employees to notify parents in writing if a student requests to be called by pronouns or a name that differs from those assigned at birth. In short, educators must choose between forcibly outing students and facing legal action (including the potential loss of employment). Outing someone against their will doesn't just violate their legally-protected right to privacy; it also puts them at risk of hostility, rejection, and even violence from their parents or guardians. The governor seems to be using his previous experience as an educator to justify this bill, stating that "Research shows that involving families more in a child's education leads to better relationships and improved educational outcomes for students, and this bill will do just that." He has conveniently ignored the fact that research also shows that the presence of just one supportive adult figure in an LGBTQIA+ child's life reduces suicide attempts by 40%. Many LGBTQIA+ youths have reason to fear their parents' or guardians' reaction to their gender identity or sexuality, and this bill ensures that they will find no safety at school either.

Under this bill, parents would also need to provide written permission for their children to participate in any educational programs or classes involving sexual education and reproductive health. Again, the governor is risking the health and safety of Alaskan children in order to further his anti-LGBTQIA+ agenda. Comprehensive, age-appropriate sex education programs play a crucial role in keeping children safe. Studies have shown that these programs reduce rates of sexual activity, risky sexual behaviors, STIs, and unwanted pregnancy among youth, while also equipping younger children with the knowledge necessary to prevent, recognize, and report sexual abuse. And yes, they also teach ageappropriate information on sexual expression, orientation, and gender identity, equipping all children with the tools to understand their own identity, whatever that may be. As with all of the provisions in this bill, children from marginalized communities and those living in unsafe homes will suffer the most.

Finally, the bill requires that students in Alaskan schools use bathrooms and locker rooms that correspond to the sex recorded on their birth certificate, rather than to their gender identity. Again the governor wants us to believe that he is motivated by concerns for student safety or privacy, and again it is clear that his true motivation is ignorance, misinformation, and fear. Trans students do not pose a risk to their classmates, inside the bathroom or out of it, and this provision will force them to either reveal private medical information to their peers and teachers or risk breaking the rules and being punished and forcibly outed. This is an impossible choice for children who already face heightened risks of harassment and abuse from both their peers and adults."

All children deserve to feel safe and protected in school. All teachers should be able to teach and communicate with their students openly without fearing legal action. It's unfair to make schools a political battleground. We can do better. Stand on the side of mental health professionals. Supporting students is a good place to start for healing the mental health state of our country. Please stand with our kids.

Hello Co-chairs Allard and Ruffridge and the House Education Committee,

I am writing today in DEEP opposition to HB 105, a bill that benefits no one and does nothing but limit parental rights and harm our children.

Parents do not have ownership over their children, and their ability to express themselves and be their authentic selves should not be curtailed by the misguided beliefs of a bigoted parent.

Prior to living in Alaska, I worked in many different public schools as a science educator. In that capacity, I served as a faculty advisor for the GSA, or Gay-Straight Alliance, where LGBTQ+ students were able to have a safe place away from their peers' bullying (and oftentimes their bigoted parents' bullying as well).

You are intentionally letting parents supersede their own children's agency and identity in an attempt to provide "parental rights," and you KNOW that requiring parents to opt into programs like the GSA will out children to violent households and bar them from participating in the few school programs that will support these children. You are allowing child abuse in the pursuit of political gain.

You cannot legislate away LGBTQ+ children, you can only make life more miserable for them and the teachers who actually care about their students' safety. HB 105 would empower bigoted, uninformed parents to litigate against schools and school districts simply for doing what's best for their students. This is only going to make even more qualified teachers and administrators leave the state or leave the profession, something that Alaska cannot afford in the least.

Let's also talk about another component of this legislation, the one that would require school districts to either force trans students to use the restroom or locker room of their sex assigned at birth, no matter how these students present externally or identify currently, or use a separate isolated facility (or other safety protocols, whatever they may be). Let's put aside for now the complete misrepresentation of "biology" and the erasure of individuals who are intersex and therefore do not neatly fall into a single box. Let's put aside, for instance, the absurdity of putting someone who has identified and presented as male their entire lives (maybe even having secondary characteristics like facial hair) in the girls' locker room. This is a policy that is engineered specifically to harm children.

Your aim with this part of the legislation is to either force trans students to detransition, causing massive mental health damage, harming their families and friends (so much for parental rights), or to make them kill themselves, or leave the public school system (or state) entirely. This is a disgusting policy aimed at individuals who have done NOTHING wrong other than existing as their authentic selves. Trans people only want to use the bathroom for the same reason everyone else does - they are NOT inherently predators.

You can claim that this policy will give "local control" and "parental rights." However the impacts of this policy will extend far beyond the individual school districts and their communities. Even if you don't live in a school district governed by theocrats who ignore testimony from LGBTQ+ students and their parents, such as the Mat-Su Borough School District (that ignored a litany of comments in opposition to their recent trans sports and bathroom bans and rejected a petition from their students to create a separate gender neutral bathroom), there will still be effects to

students all across Alaska.

I am writing as a concerned Alaskan to strongly urge your committee to oppose Governor Dunleavy's House Bill 105.

As a fairly new resident of Alaska, what I fell in love with was the open mindedness and acceptance of this state and their LGBTQ+ community. This should extend to the youth of the community.

As a former resident of Florida, my heart breaks to see Alaska begin to follow in them for laws that hurt our LGBTQ+ youth.

Forcibly outing trans youth is a dangerous prospect. As someone who grew up in an abusive and homophobic household, I fear for those whose families are not accepting of their children.

According to the Trevor Project, 42% of LGBTQ2 youth—and 52% of trans youth in particular—have seriously considered suicide in 2021. More than half of all Alaskan LGBTQ2 youth reported experiencing depression, and almost three-fourths experiencing significant anxiety. Alaska Native LGBTQ2 youth, in particular, report more instances of harassment and discrimination due to being LGBTQ2, furthering already-abhorrent mental health statistics and making them 2.5 times more likely to attempt suicide than non-Native LGBTQ2 peers. Research from the National Education Association shows that harmful legislation, such as House Bill 105, only exacerbates depression and anxiety for LGBTQ2 students, and significantly increases the likelihood of suicidal ideation.

LGBTQ2 youth matter. In a state with high prevalence of adverse childhood experiences, Alaskan schools have the opportunity to encourage tolerance and acceptance through inclusive curricula, respecting a student's inherent agency and using their chosen pronouns, and creating affirming spaces to encourage personal and interpersonal growth. This helps shape a future where LGBTQ2 youth can thrive and flourish into contributing members of society, and where all Alaskan students grow to be aware and compassionate citizens.

As a concerned Alaskan and an ally to LGBTQ2 youth, I strongly urge members of the committee to oppose Governor Dunleavy's HB 105.

"If passed, HB 105 would require school employees to notify parents in writing if a student requests to be called by pronouns or a name that differs from those assigned at birth. In short, educators must choose between forcibly outing students and facing legal action (including the potential loss of employment). Outing someone against their will doesn't just violate their legally-protected right to privacy; it also puts them at risk of hostility, rejection, and even violence from their parents or guardians. The governor seems to be using his previous experience as an educator to justify this bill, stating that "Research shows that involving families more in a child's education leads to better relationships and improved educational outcomes for students, and this bill will do just that." He has conveniently ignored the fact that research also shows that the presence of just one supportive adult figure in an LGBTQIA+ child's life reduces suicide attempts by 40%. Many LGBTQIA+ youths have reason to fear their parents' or guardians' reaction to their gender identity or sexuality, and this bill ensures that they will find no safety at school either.

Under this bill, parents would also need to provide written permission for their children to participate in any educational programs or classes involving sexual education and reproductive health. Again, the governor is risking the health and safety of Alaskan children in order to further his anti-LGBTQIA+ agenda. Comprehensive, age-appropriate sex education programs play a crucial role in keeping children safe. Studies have shown that these programs reduce rates of sexual activity, risky sexual behaviors, STIs, and unwanted pregnancy among youth, while also equipping younger children with the knowledge necessary to prevent, recognize, and report sexual abuse. And yes, they also teach age-appropriate information on sexual expression, orientation, and gender identity, equipping all children with the tools to understand their own identity, whatever that may be. As with all of the provisions in this bill, children from marginalized communities and those living in unsafe homes will suffer the most.

Finally, the bill requires that students in Alaskan schools use bathrooms and locker rooms that correspond to the sex recorded on their birth certificate, rather than to their gender identity. Again the governor wants us to believe that he is motivated by concerns for student safety or privacy, and again it is clear that his true motivation is ignorance, misinformation, and fear. Trans students do not pose a risk to their classmates, inside the bathroom or out of it, and this provision will force them to either reveal private medical information to their peers and teachers or risk breaking the rules and being punished and forcibly outed. I can say with certainty that being outed to a parent when someone is not ready is dangerous, and will cause years of damage to whoever this happens to. I can say this because it happened to me. When I was 12 years old, I found an adult that I trusted in my after school program, and I told them that I thought I was queer. They were very supportive, and made me feel like I was accepted for who I am. About a month later my dad found out, he confronted me when I was not ready to talk about it. I felt ambushed, ashamed, and like I never wanted to talk with another person about being queer ever again. This experience has stayed with me into adulthood. I have a very hard time trusting anyone with personal information around my sexuality or gender regardless if they have been vocally supportive of LGBTQ+ people. It instilled a lifelong fear of being outed and ostracised by people that I love.

I worked at Juneau School District as a Paraeducator for two years, and I loved it. During this time I also began to realize that I am not cisgender. As those feelings kept coming up more and more, I realized that I still had that deep seeded fear of being outed and accused of being a negative influence on children. The transphobic rhetoric and legislation across this country has only fed this fear of mine. I told myself if I wanted to be my true self, I would not be able to work with students without constant anxiety or fear, so I quit. I stopped doing a job that I was great at, and the school district lost a valuable staff member.

This house bill reinforces those ideas, for students, for staff members, and the LGBTQ+ community as a whole. Please do not allow this bill to pass.
