Please accept this email as my testimony since I won't be able to call in tonight.

I find it sad that we even need this type of legislation; parents rights and responsibilities for all aspects of their children's welfare have been respected up until the past several years.

Tamara Maddox Re: HB105 April 13, 2023

My Name is Tamara Maddox. I am a black American woman, and I have been an Alaskan resident since roughly 1989. I support the governor's bill because this bill is about preserving the rights of parents to raise, teach, and instill their values in their kids. I am genuinely dismayed that anyone would be against this basic sacred right. But here we are.

First, in 1978 congress enacted the Protection of Pupil Rights Amendment, giving parents the right to inspect curriculum being taught to their children. In 2016, the State of Alaska passed a parental rights bill, defining parental authority and ensuring that a parent could withdraw their children from any test or curriculum they deemed inappropriate. HB105 further defines parental authority and changes the language around human growth and development and sexual education from parental right to "opt out" to the requirement that parents must "opt in".

Second, HB105 preserves a parent's right to know what a child is being taught, especially as it comes to sex content, and it empowers parents to remove their kids from questionable lessons, groups, as well as prohibit gender labels without the parents' permission. This protects and respects the family structure, and it protects the child from unwanted advances and conversations. Imagine being a 4th or 5th grader and your teacher begins talking to you about their sexual proclivity. This is an inappropriate boundary that cannot be championed. Further, the media has purposely misled the public about the realities of HB 105, provoking inflammatory responses and outrageous accusations that the bill somehow endangers or discriminates against gender non-conforming students. This is a prime example of why the media has a lower approval rating than congress.

Third, Governor Dunleavy has introduced HB105 to provide more transparency and communication between parents, students, and their schools. HB105 will ensure privacy and safety for <u>all</u> students, by designating bathrooms and locker rooms according to biological sex or providing for the use of single occupant facilities.

Fourth, HB105 requires parental notification and permission to participate in sexual education including gender identity, and to change a student's name. HB105 protects all children by establishing that parents, not school personnel, have the authority in a child's education.

Last, HB105 gives parents the power to focus their child's education on what the parent feels is important. For most parents, each academic year is an opportunity to prepare their child to one day be self-sufficient and gainfully employed. Walter E. Williams, a renowned black American economist, said it best, "the high school diploma is supposed to be a guarantee that the diploma holder can read, write, understand science, and do math on a 12th grade level, and if the diploma holder cannot do these things, that diploma is a fraud." Last year, the National Assessment of Education Progress reported that Alaska's students are a full year behind the national average in reading, and only 28% of 4th graders are proficient in math. We have missed the mark. But HB105 empowers parents to priorities areas of study that will help their child best. After all, there is only 24 hours in a day, and our kids have so much to accomplish.

I urge the House of Representatives to pass HB105 so that Alaskan parents maintain their authority over their child's education and development. Thank you for your time and consideration.

My name is Kendal Kruse, I am a Palmer resident, mother of four children and a local school board member. I urge you to support HB 139.

Many families in my district, community, and my family utilize the correspondence program in Alaska to optimize the education of their children. I support multiplying the ADM to 100%, however multiplying by 90% is a great step towards that.

In nearly all cases those who participate in the correspondence program are the only ones who perform all of the work of educating their children as well as providing the facility. Reducing the funding for correspondence program participants is punishing them for utilizing school choice. If you justify the full ADM for public schools and charters you should treat the correspondence program with equal measure.

Here is an example of the arbitrary measures and controls put into place by the correspondence programs due to the reduced funding. If a parent needs to purchase a quality desk or a bookshelf for their child's education needs, furniture that is fully funded for charters and public schools, a parent can only spend a total of \$250 on any furniture per year. I challenge anyone to find a desk or bookshelf that can support the weight of many textbooks for \$250 or less in the state of Alaska.

The correspondence funding needs to be increased to treat our students across the state in an equitable manner. Please support HB 139 and increase the ADM multiplier for correspondence programs to 90% or greater.
