I am writing in opposition to HB 105. From what I gather, parents have the right to review sex education curricula and to recuse their children from participating if they choose. This bill unnecessarily breeds distrust of teachers and poisons the confidence students have in themselves and their teachers.

I object to forcing other children to live by the norms and standards of parents who would prefer to cancel transgender individuals. I know the nation's norms have changed in my lifetime, and I grew up with many unquestioned assumptions about binary sexual identity. I understand that it can all feel strange.

But I also remember that back in my high school years, I was beginning to differentiate my sense of who I am from my parents' sense of who I was. I didn't disclose everything to them. I claimed my independence and autonomy gradually through my teen years, and school was my opportunity to be, without constant parental surveillance or monitoring. I granted my own kids a growing sense of autonomy during those years because I wanted them eventually to be independent of me. I'm guessing they didn't tell me everything either.

But I did keep lines of communication open, especially with regard to human sexuality, and our family saw to it that they each were able to enroll in church programs that provided them with affirmation, as well as medically accurate and developmentally appropriate information so that they wouldn't depend on the misinformation of peers nor fall prey to messages of shame.

I'm glad to see that they have matured into people who make their own decisions and take responsibility for those choices.

I object to this bill because I feel compassion for youth who are all still figuring things out. Sexual maturation can be extremely awkward. Who among us adults didn't feel a little overwhelmed through puberty--so many physiological and psychological changes happening at once during a liminal time in life.

I don't see any harm in allowing youth to be called by their preferred pronouns. If parents want to know more, they can ask their youth. If parents cannot communicate with their own youth, then they have a problem, but it's not up to the government or the teachers or the school administrators to fix that problem for them. I call on parents to claim their own autonomy and the responsibility that comes with it--talk to your children, create a safe environment at home. No one can do that for you.
