

AFN is the largest statewide Native organization and continues to be the principal forum and voice of Alaska Natives in dealing with critical issues of public policy and government. Together, AFN and its members include 209 federally recognized tribes, 185 village corporations, 9 regional corporations, and 12 regional nonprofit and tribal consortiums.

The Alaska BOG's main role is to conserve, develop, and manage the policy of the state's wildlife resources. It is important that the BOG has fair representation from various user groups, including subsistence users who depend on the state's wildlife resources. Mr. Hoffman has gained the respect of fellow Board members and groups around the state as an active, concerned, informed, and effective member of the BOG. In addition, Mr. Hoffman has developed many valuable relationships with the Alaska Department of Fish and Game, advisory committee members, and other public officials. Mr. Hoffman has proven that he is a valuable asset to the BOG by solving many challenges around the state, including subsistence hunting regulations that are critical for a strong relationship with our rural communities.
