Dear Senator Giessel,

I was made aware today of Senate Bill 68 removing public notices from being published in local community newspapers. For a while now I've been wondering where public notices by the State of Alaska have been published?

I have lived in the Fairbanks/North Pole communities for over 50 years. I and many in my community read the classified notices in our local newspaper for information as to what's occurring in our state. Many in the Fairbanks North Star Borough do not have access to the internet at their residence. This bill will do a disservice to our community and our state as a whole. We need Alaskan residents to be more involved in state government, not less. Postings only on the state website limits the visibility of these notices.

Senate Bill 68 will not allow citizens to stay informed with important water rights occurring in our state. We need transparency now more than ever. One way for that transparency is that our local and state government publish through the local community newspapers what meetings and state business is taking place.

The public has relied on community newspapers to keep them informed and to publish public notices. If the state government publishes their own notices where's the transparency in that? I took an informal survey today of people in Fairbanks asking them if they knew the state had an "online public notices" website and they did not.

Keeping public notices in the local community newspapers is part of the checks and balances that our country was built on. I hope you will reconsider your sponsorship for Senate Bill 68, it does not serve the best interest for Alaskans.

## Senator Giessel,

I became aware today of Senate Bill 68, and I'm writing to express my strong opposition to it. SB 68 seeks to remove the requirement to publish public notices in a newspaper and instead place them on a state-run government website. I believe this change would have serious negative consequences for transparency and public participation in important decisions related to water rights.

The current law, which requires notices to be published in newspapers of general circulation, ensures that the public is informed and has the opportunity to provide feedback and input on matters that affect their communities. Newspapers (and their websites, which include all the notices published) have a vastly wider reach and are more accessible to Alaskans who may not have access to the internet or are not frequent users of government websites. This change would disenfranchise these individuals and limit their ability to participate in the decision-making process.

Furthermore, placing notices solely on a government website will stifle the visibility of these notices, making it easier for them to be overlooked or missed entirely. This could lead to important decisions being made without sufficient public input or scrutiny, which is not in the best interest of the people of Alaska.

I urge you to consider the potential negative consequences of this bill. The current system of publishing public notices in newspapers has worked well and has ensured that Alaskans are informed and have a voice in important decisions that affect them. Please do not take away this vital tool for transparency and public participation.

Thank you for your attention to this important matter, and if your schedule allows I'd love the opportunity to provide feedback (including data showing the reach of newspapers and their websites) in person or by phone.
