Good afternoon members of the committee,

My name is Joshua Girard. I am a paraprofessional at Seward Middle School. I've worked for KPBSD for about five years now. I started out as a long-term sub in the intensive needs classroom at Sterling Elementary. After a few months of learning and not running in fear, I interviewed and was selected to join the team of wonderful paras and staff. It wasn't long before the world was hit hard by COVID. Suddenly, teachers and education support professionals were lifted out of schools and had to move curriculum online and teach in a new environment. We responded to this great need and were raised to the status of heroes. Even though the world was going through terrible times, I felt like I truly mattered, and the work I was doing mattered.

Soon enough, we were back in schools, and things slowly went back to normal. Or so we thought. It wasn't long before we felt like we were the villains in the same story. After two years of dealing with the virus and distance learning, the lack of funding reared its ugly head. We started to lose the arts, then teaching positions, and soon staff had to take up even more duties. There was no compensation, and we would often hear how we weren't doing enough. Community leaders blamed the teachers, not only in our wonderful state, but across the nation. The stress of our work and the lack of competitive pay drove ever more of our great educators to seek greener fields, taking their knowledge of the job with them.

We've continued to do the best with what we have, but the ones truly suffering from this are our students. Our students are Alaska's greatest resource. They will be Alaska's next educators, next legislators, and our future. What we are currently showing them is that Alaska doesn't care about their education. The lack of funding for our public schools, and the meager interest in our educators has become ever more apparent. Our students see it. They are much more aware than so many give them credit for. We are tasked with raising them to their highest potential, but how are educators supposed do that with a skeleton crew and no funding?

In our school we will be down to 6 teachers next year, one who we will share with our high school. We will have no arts. We may not even be able to do electives. I am the only paraprofessional and will be expected to work with my intensive needs students, as well as our resource. I will have to manage the curriculum of all our students in each of their classes, where I am expected to make sure they complete all their assignments, while managing their needs. We cannot hire more because the cost of living is so high. We do not make a living wage, not even close. I will quite possibly be homeless as an educator come summer, but I will continue to do my job because it is needed, and I love doing it. I care for my students and their wellbeing.

I am asking for this increase in the BSA because it is NEEDED. We cannot raise the next generation of Alaskans with what we have. As I said before, our students are our greatest resource, and unless we invest in them, we will continue to flounder, and lose even more ground.

Testimony on April 17, 2023 to Senate Finance on SB52.

Dear members of the Senate Education Committee. My name is Scott MacManus, and I am a life-long Alaskan and product of our public school and university systems. I am currently the Superintendent of Alaska Gateway School District. Thank you for the opportunity to support full funding of SB52.

Right now AGSD is in the middle of our FY24 budgeting process. We are preparing a budget based on the \$30 BSA increase, our first increase since 2017, because that is what we know we can count on. For my district that translates into an annual increase of under \$50,000 a year. Yet our audited fixed costs since 2017 has increased to approximately \$1.2M more a year. This week we learned that our health insurance was increased by 34.8% and will cost \$2.1M a year... a 100% increase since 2017.

Our average teacher in 2017 made \$65K...this year it is \$80K...which does not even begin to keep up with inflation. Staff turnover in my district has traditionally been very low, but this year like many district's we are experiencing increased teacher turnover...and are recruiting teacher candidates...for a recent elementary position we have in Tok, I have over a 100 applicants...but only 1 of them from the US. We currently have two international teachers who are doing an excellent job and if are unable to fill our positions will hire more.

There has been recent discussion regarding the School Fund Balance that DEED prepared on April 17, it shows our undesignated reserve at \$1.1M, which we worked hard to build, and is right near the 10% allowable not subject to limitation. It shows our capital project fund balance at just over \$1M. That is the money we use for basic maintenance emergencies and summer maintenance program, and yet we have nearly \$30M in identified deferred maintenance needs.

The sheets shows \$1.1M in remaining in our COVID Relief Funds...these funds are NOT left over funds...they are already allocated and planned for, and will help get us through next year. They are paying for mental health counselors and other educational services and programs that are planned. We have planned out timed the use of those fund as we were told we could, so that we maximize the use of every cent to help with what our kids need. We have used all the funds as allowed and expired. Our funds are planned for, and we will use all of it, and they were meant to meet the learning needs for kids, not used to balance a state budget.

Alaska School districts are absolutely accountable. From our elected school boards who answer to their constituents, to annual fiscal audits and reports to various departments, we are accountable. This year alone AGSD has had it's Annual financial Audit, A TRS and PERS audit, A Food Service Audit, and we are going through an ESSER audit right now. Accountability is a must, but there needs to be a full understanding that every accountability measure has costs to provide it, and they increase the costs of doing business.

I ask the Senate to show their support of Alaska kids and education by supporting the BSA increase proposed in SB52, we should not have to run our schools on unsustainable grants such as ESSER.

Thank you to Chairman Olson and members of the Senate Finance Committee for taking public testimony on SB 52. My name is Andy DeGraw and I'm the Chief Operations Officer for Fairbanks North Star School District and I'm testifying in support of SB 52.

I'd like to address the document titled "DEED School district fund balances".

This document is misleading in its current form for 2 reasons:

- 1. It's dated June 30, 2022 and represents outdated, inaccurate numbers.
- 2. Additionally, many of the balances listed are NOT available to fund regular operating expenses.

Speaking specifically to Fairbanks' numbers found in the document:

Operating Fund FB - This is accurate, we are at \$0.00.

Pupil Transportation - \$4.7M listed, actual is \$3.5M. These funds are committed to our transportation services and we currently run a \$3.0M annual deficit in transportation and will be close to \$0.00 in fund balance at the end of FY24. Transportation funding has remained unchanged for eight consecutive years.

Capital Projects - \$2.3M is accurate. These funds are committed to capital projects in our district in cooperation with the Borough.

Other Gov funds - \$13M is accurate. These funds are committed to pay for health and other insurance claims, our food service operations, and our equipment replacement program that replaces nearly 20 thousand student and staff technology devices over a 4 year timeframe.

COVID Funds Remaining - \$16.1M listed. \$4.3M actual. These funds are already committed to our FY24 budget.

Therefore the grand total available to Fairbanks for FY24 is not \$36 M, rather it's \$4.3 M.

I would encourage Senators' staff to reach out to their respective districts to get current and accurate figures and to get insight regarding the various funds identified in the DEED document. I would guess that actual COVID funds available for FY24 are FAR lower than the \$236 M listed.

Thank you again to members of the committee and for your dedication to the State of Alaska and to a strong public education system.

**BSA** Increase

First, I would like to thank you for doing the work to make Alaska a wonderful place to live and work. I have been an educator here since 2011. I hope that you will fight for our schools and our kids during this crucial time as the Legislature considers increasing the Base Student Allocation.

Due to inflation and especially increased costs in energy and shipping, there are several critical programs in our schools that are suffering as our funding has to be diverted to pay utilities bills, increased costs for the every day supplies used in classrooms, and maintenance materials. Things that directly impact our students, like MTSS services, trauma informed practices, project based learning materials, and art and music supplies, are being cut so we can keep the busses running and the heat on in our buildings. Teachers and paraprofessionals are being laid off, and some schools may even be closed. I urge you to take bold and immediate action to provide relief to school districts through a BSA increase and develop long-term education funding solutions.

Since 2017, inflation has risen by 15% which has steadily diminished school districts' buying power. Meanwhile, the BSA has only increased by 0.5% over that same period. Some estimates have suggested that in order to keep up with inflation, the BSA should be \$1,300 more than it is right now. Regardless of how we calculate inflation or the right amount for the BSA, one thing is clear: our public schools need help now.

On a personal note, my current position as a Dean of Students will be cut if we do not see a BSA increase. I work with students daily on restorative justice and fostering positive behavior and community standards. I maintain safe conditions in my building because everyone deserves to feel safe when they are at school. I oversee our RTI and Special Education programs to make sure our struggling students are having their needs met. I support our classroom teachers in myriad ways so they can deliver the best education possible to our students. The work I do is integral to creating a thriving learning community and is moving us forward towards our school improvement goals. Sometimes when we look at budgets, we can forget that these numbers represent something more than money. They correlate to people, like me, and to services our kids need.

I urge you to do everything in your power to set aside political differences and focus on providing relief to our public schools. Governor Dunleavy and legislators of all political persuasions have indicated their openness to increasing the BSA. I hope I can count on you to join them in finding common ground to pass a meaningful budget increase.

You can be a hero for Alaska's public schools this legislative session. Please don't let us down.

I am a self employed registered architect living and working professionally in Anchorage for the last 21 years.

I want to echo all the points made in support of SB 52 from the last hour and 20 minutes of testimony and add that when I moved to Alaska in 2002, Alaska was ranked number 1 in the nation for schools and education. Teachers were flocking to Alaska to teach and our students had every opportunity in the world because of their education.

That is no longer the reality.

Why have we deprioritized our children to such a degree? I see that we have consistently balanced the budget in the backs of our children instead of creating a sustainable fiscal plan.

As an architect, I know that every architecture and engineering firm in Anchorage is short staffed and cannot meet the professional demand for our services. I also know that there are many building contractors and sub-contractors that cannot staff up to build projects that they are already under contract to build. We are about to leave a lot of infrastructure funding on the table due to lack of workforce. So why are we so short staffed? Because we can't recruit with the perception that Alaska does not value education. That's it. Professionals have left, and new professionals cannot be recruited due to lack of educational opportunities for their children.

Please, pass SB 52.

We have to provide stable and predictable funding for school districts and stop relying on one-time stop gap funding. Our children and the future of Alaska's workforce is worth it.
