Analysis

AS 11.41.260(a) stalking is amended adding stalking protective orders and sex offense protective orders to the conditions for charging someone with stalking as a C felony. Based on current data available, it is estimated that this amendment will increase the total prison days by 475 days per conviction and estimates up to seven convictions per year. Consequently, the daily average prison population is projected to increase by seven inmates in the first year following the effective date and 9.1 inmates thereafter.

AS 12.55.127(c). violation of conditions of release (VCOR) is amended requiring conviction sentences to be imposed consecutively when the person has two or more crimes of VCOR under AS 11.56.757. VCOR is a highly common offense within the departments available data. The majority of the VCOR convictions within the department's data currently reflect consecutively imposed sentences. However, the department estimates this amendment will impact 10% of all applicable VCOR convictions and increase the daily prison average by, at most, approximately 6.3 inmates per day.

AS 12.63.100(7) is amended adding AS 11.61.130(a)(2), misconduct involving a corpse, to the list of registerable sex offenses.

AS 18.66.990(3) domestic violence enhancements is amended adding unlawful contact and interfering with a report of a crime of domestic violence to the definition of crime involving domestic violence and triggers mandatory arrest if the officers have probable cause. This section will impact the daily average prison population. However, the department is not able to quantify the full impacts of this change and anticipates any impact can be absorbed into current capacity due to the current prison population.

Section 11 makes the applicability section of sec. 142.(c), ch. 4, FSSLA 2019 (HB49), retroactive as it pertains to the requirement for sex offenders who must register in another state to also register in Alaska when they are present in the state.

The DOC does not have sufficient data to project the full impacts of this legislation on the daily prison population; however, the department does not anticipate any significant fiscal impact with these changes and can absorb any increases within the current capacity and resources based on current inmate population counts.

Analysis

This legislation makes a number of changes which clean up statutes and create efficiencies in the system. Among the changes made in the bill are requiring consecutive sentencing when offenders are convicted of more than one crime of violating conditions of release, amending the definition of "crime involving domestic violence" to include interfering with a report of a crime of domestic violence and unlawful contact, and allowing testifying witnesses to summarize the statements of others at the grand jury phase of the case.
The Department of Law does not anticipate a fiscal impact from this legislation.

Analysis

This bill makes substantive and conforming substantive and conforming amendments to statutes relating to sex offenses, sex offender registration, stalking, sex trafficking as registerable offenses, and domestic violence.
The Department of Public Safety (DPS) maintains the state's central registry of sex offenders under AS 18.65.087. The changes proposed in this bill will impact the business and technical procedures DPS has in place to manage the registry in order to capture the additional data fields and information on registered sex offenders. However, it is anticipated the changes as proposed in this bill can be implemented with existing resources.
Therefore, a zero fiscal note is being submitted.

Analysis

The bill requires increased sex offender registry. Registry requirements are a significant factor in assessing litigation strategies and options for the accused and may increase the number of cases that are brought to trial rather than resolved through pleas agreements.

Increased jury trials, contested sentencing hearings, and post-conviction litigation will increase the workload and costs for the Office of Public Advocacy. Additional staff will be needed to manage an increase in discovery and client contact.

Additionally, Office of Public Advocacy public guardians are responsible for wards of the state, some of whom are registered sex offenders. Thus, the increased registry requirements will cause a corresponding increase to the workload of the public guardian.

OPA will need the following positions to address the increased workload:

	House Bill 67 changes multiple requirements relating to the sex offender registry (secs. 4-7), requires consecutive jail time for a person convicted of two or more offenses of violating conditions of release (sec. 3), adds additional offenses to the definition of "sex offense" for which a person is required to register (sec. 8), and adds crimes to the list of offenses that comprise the definition of domestic violence (sec. 9). These changes are not anticipated to have a material effect of the court's caseload.
	In addition, Section 12 would amend a court procedural rule to allow any evidence that the prosecutor believes would be admissible at trial to be admitted at the grand jury stage of a case, and further amends that court procedural rule to allow the prosecutor to present hearsay evidence in all grand jury proceedings. This would change the way evidence is presented to a grand jury but would not have a fiscal impact on the court system.
