**A BILL**

**FOR AN ACT ENTITLED**

1   **"An Act relating to an interstate physical therapy licensure compact; relating to the**  
2   **licensure of physical therapists, physical therapist assistants, occupational therapists,**  
3   **and occupational therapy assistants; and providing for an effective date."**

4   **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

5    \* **Section 1.** AS 08.84.010(b) is amended to read:

6           (b) The board shall control all matters pertaining to the licensing of physical  
7           therapists, physical therapist assistants, occupational therapists, and occupational  
8           therapy assistants and the practice of physical therapy and the practice of occupational  
9           therapy. The board shall

- 10                           (1) pass upon the qualifications of applicants;  
11                           (2) provide for the examination of applicants;  
12                           (3) issue temporary permits and licenses to persons qualified under this  
13           chapter;  
14                           (4) suspend, revoke, or refuse to issue or renew a license under

1 AS 08.84.120;

2 (5) keep a current register listing the name, business address, date, and  
3 number of the license of each person who is licensed to practice under this chapter;

4 (6) adopt regulations under AS 44.62 (Administrative Procedure Act)  
5 necessary to carry out the purposes of this chapter, including regulations establishing  
6 qualifications for licensure and renewal of licensure under this chapter;

7 **(7) implement the Interstate Physical Therapy Licensure Compact**  
8 **under AS 08.84.188.**

10 **Sec. 08.84.030. Qualifications for licensing.** (a) To be eligible for licensure  
11 by the board as a physical therapist or physical therapist assistant, an applicant, unless  
12 a graduate of a foreign school of physical therapy located outside the United States,  
13 shall

14 (1) have graduated from a professional physical therapy education  
15 program that includes supervised field work and is accredited by a national  
16 accreditation agency approved by the board;

17 (2) pass, to the satisfaction of the board, an examination prepared by a  
18 national testing service approved by the board to determine the applicant's fitness for  
19 practice as a physical therapist or physical therapist assistant, or be entitled to  
20 licensure without examination as provided in AS 08.84.060; [AND]

(2) pass, to the satisfaction of the board, an examination prepared by a national testing service approved by the board or an examination recognized by a national accreditation agency approved by the board to determine the applicant's fitness for practice as an occupational therapist or occupational therapy assistant, or be entitled to licensure without examination under AS 08.84.060; [AND]

(3) meet qualifications for licensure established in regulations adopted by the board under AS 08.84.010(b); and

(4) have been fingerprinted and have provided the fees required by the Department of Public Safety under AS 12.62.160 for criminal justice information and a national criminal history record check; the fingerprints and fees shall be forwarded to the Department of Public Safety to obtain a report of criminal justice information under AS 12.62 and a national criminal history record check under AS 12.62.400.

**Sec. 08.84.032. Foreign-educated applicants.** (a) To be eligible for licensure by the board as a physical therapist or physical therapist assistant, an applicant who is a graduate of a school of physical therapy that is located outside the United States shall

(1) have completed, to the satisfaction of the board, a resident course of study and professional instruction substantially equivalent to a professional physical therapy program that is accredited by a board-approved national accreditation agency in the United States;

(2) have completed, to the satisfaction of the board, an internship under the continuous direction and immediate supervision of a physical therapist in an institution that ordinarily provides physical therapy and is approved by the board, for that period of time specified by the board, and furnish documentary evidence of compliance with this paragraph;

(3) pass an examination recognized by the board that measures the

competence of the applicant in the English language if the applicant's physical therapist or physical therapist assistant education program was not taught in English;

(4) have met applicable requirements under 8 U.S.C. 1101 - 1503 (Immigration and Nationality Act), unless a United States citizen;

(5) pass the examination approved by the board under AS 08.84.030(a)(2);

(6) pay the fee required under AS 08.84.050; [AND]

(7) meet additional qualifications for licensure established in regulations adopted by the board under AS 08.84.010(b); **and**

**(8) have been fingerprinted and have provided the fees required by the Department of Public Safety under AS 12.62.160 for criminal justice information and a national criminal history record check; the fingerprints and fees shall be forwarded to the Department of Public Safety to obtain a report of criminal justice information under AS 12.62 and a national criminal history record check under AS 12.62.400.**

(b) To be eligible for licensure by the board as an occupational therapist or occupational therapy assistant, an applicant who is a graduate of a school of occupational therapy that is located outside the United States shall

(1) have completed, to the satisfaction of the board, a resident course of study and professional instruction substantially equivalent to a professional occupational therapy education program that is accredited by a board-approved national accreditation agency in the United States ;

(2) have completed, to the satisfaction of the board, supervised field work equivalent to that required under AS 08.84.030(b);

(3) pass an examination recognized by the board that measures the competence of the applicant in the English language if the applicant's occupational therapist or occupational therapy assistant education program was not taught in English;

(4) have met applicable requirements under 8 U.S.C. 1101 - 1503 (Immigration and Nationality Act), unless a United States citizen;

(5) pass an examination administered or approved by the board under

AS 08.84.030(b);

(6) pay the fee required under AS 08.84.050; [AND]

(7) meet additional qualifications for licensure established in regulations adopted by the board under AS 08.84.010(b); **and**

**(8) have been fingerprinted and have provided the fees required by the Department of Public Safety under AS 12.62.160 for criminal justice information and a national criminal history record check; the fingerprints and fees shall be forwarded to the Department of Public Safety to obtain a report of criminal justice information under AS 12.62 and a national criminal history record check under AS 12.62.400.**

(a) It is unlawful for a person to practice physical therapy without being licensed under this chapter unless the person is

(1) a student in an accredited physical therapy program;

(2) a graduate of a foreign school of physical therapy fulfilling the internship requirement of AS 08.84.032, and then only unless under the continuous direction and immediate supervision of a physical therapist; [OR]

(3) issued a limited permit under AS 08.84.075; **or**

**(4) granted a compact privilege under AS 08.84.188.**

**Article 3A. Interstate Physical Therapy Licensure Compact.**

1           **Sec. 08.84.188. Compact enacted.** The Interstate Physical Therapy Licensure  
2 Compact as contained in this section is enacted into law and entered into on behalf of  
3 the state with all other states and jurisdictions legally joining it in a form substantially  
4 as follows:

5   SECTION 1. PURPOSE

6           The purpose of this Compact is to facilitate interstate practice of physical therapy with  
7 the goal of improving public access to physical therapy services. The practice of physical  
8 therapy occurs in the state where the patient or client is located at the time of the patient/client  
9 encounter. The Compact preserves the regulatory authority of states to protect public health  
10 and safety through the current system of state licensure. This Compact is designed to achieve  
11 the following objectives:

- 12                           (1) Increase public access to physical therapy services by providing for  
13 the mutual recognition of other member state licenses;  
14                           (2) Enhance the states' ability to protect the public's health and safety;  
15                           (3) Encourage the cooperation of member states in regulating multi-  
16 state physical therapy practice;  
17                           (4) Support spouses of relocating military members;  
18                           (5) Enhance the exchange of licensure, investigative, and disciplinary  
19 information between member states; and  
20                           (6) Allow a remote state to hold a provider of services with a compact  
21 privilege in that state accountable to that state's practice standards.

22   SECTION 2. DEFINITIONS

23           As used in this Compact, and except as otherwise provided, the following definitions  
24 shall apply:

- 25                           (1) "Active duty military" means full-time duty status in the active  
26 uniformed service of the United States, including members of the National Guard and  
27 Reserve on active duty orders pursuant to 10 U.S.C. Chapter 1209 and 1211.  
28                           (2) "Adverse action" means disciplinary action taken by a physical  
29 therapy licensing board based upon misconduct, unacceptable performance, or a  
30 combination of both.  
31                           (3) "Alternative program" means a non-disciplinary monitoring or

1 practice remediation process approved by a physical therapy licensing board. This  
2 includes substance abuse issues.

3 (4) "Compact privilege" means the authorization granted by a remote  
4 state to allow a licensee from another member state to practice as a physical therapist  
5 or work as a physical therapist assistant in the remote state under its laws and rules.  
6 The practice of physical therapy occurs in the member state where the patient or client  
7 is located at the time of the patient/client encounter.

8 (5) "Continuing competence" means a requirement, as a condition of  
9 license renewal, to provide evidence of participation in, and/or completion of,  
10 educational and professional activities relevant to practice or area of work.

11 (6) "Data system" means a repository of information about licensees,  
12 including examination, licensure, investigative, compact privilege, and adverse action.

13 (7) "Encumbered license" means a license that a physical therapy  
14 licensing board has limited in any way.

15 (8) "Executive Board" means a group of directors elected or appointed  
16 to act on behalf of, and within the powers granted to them by, the Commission.

17 (9) "Home state" means the member state that is the licensee's primary  
18 state of residence.

19 (10) "Investigative information" means information, records, and  
20 documents received or generated by a physical therapy licensing board pursuant to an  
21 investigation.

22 (11) "Jurisprudence requirement" means the assessment of an  
23 individual's knowledge of the laws and rules governing the practice of physical  
24 therapy in a state.

25 (12) "Licensee" means an individual who currently holds an  
26 authorization from the state to practice as a physical therapist or to work as a physical  
27 therapist assistant.

28 (13) "Member state" means a state that has enacted the Compact.

29 (14) "Party state" means any member state in which a licensee holds a  
30 current license or compact privilege or is applying for a license or compact privilege.

31 (15) "Physical therapist" means an individual who is licensed by a

1 state to practice physical therapy.

2 (16) "Physical therapist assistant" means an individual who is licensed  
3 or certified by a state and who assists the physical therapist in selected components of  
4 physical therapy.

5 (17) "Physical therapy," "physical therapy practice," and "the practice  
6 of physical therapy" mean the care and services provided by or under the direction and  
7 supervision of a licensed physical therapist.

8 (18) "Physical Therapy Compact Commission" or "Commission"  
9 means the national administrative body whose membership consists of all states that  
10 have enacted the Compact.

11 (19) "Physical therapy licensing board" or "licensing board" means the  
12 agency of a state that is responsible for the licensing and regulation of physical  
13 therapists and physical therapist assistants.

14 (20) "Remote state" means a member state other than the home state,  
15 where a licensee is exercising or seeking to exercise the compact privilege.

16 (21) "Rule" means a regulation, principle, or directive promulgated by  
17 the Commission that has the force of law.

18 (22) "State" means any state, commonwealth, district, or territory of  
19 the United States of America that regulates the practice of physical therapy.

### 20 SECTION 3. STATE PARTICIPATION IN THE COMPACT

21 (a) To participate in the Compact, a state must:

22 (1) Participate fully in the Commission's data system, including using  
23 the Commission's unique identifier as defined in rules;

24 (2) Have a mechanism in place for receiving and investigating  
25 complaints about licensees;

26 (3) Notify the Commission, in compliance with the terms of the  
27 Compact and rules, of any adverse action or the availability of investigative  
28 information regarding a licensee;

29 (4) Fully implement a criminal background check requirement, within  
30 a time frame established by rule, by receiving the results of the Federal Bureau of  
31 Investigation record search on criminal background checks and use the results in

1 making licensure decisions in accordance with Section 3(b);

2 (5) Comply with the rules of the Commission;

3 (6) Utilize a recognized national examination as a requirement for  
4 licensure pursuant to the rules of the Commission; and

5 (7) Have continuing competence requirements as a condition for  
6 license renewal.

7 (b) Upon adoption of this statute, the member state shall have the authority to  
8 obtain biometric-based information from each physical therapy licensure applicant and  
9 submit this information to the Federal Bureau of Investigation for a criminal  
10 background check in accordance with 28 U.S.C. §534 and 34 U.S.C. §40316.

11 (c) A member state shall grant the compact privilege to a licensee holding a  
12 valid unencumbered license in another member state in accordance with the terms of  
13 the Compact and rules.

14 (d) Member states may charge a fee for granting a compact privilege.

#### 15 SECTION 4. COMPACT PRIVILEGE

16 (a) To exercise the compact privilege under the terms and provisions of the  
17 Compact, the licensee shall

18 (1) Hold a license in the home state;

19 (2) Have no encumbrance on any state license;

20 (3) Be eligible for a compact privilege in any member state in  
21 accordance with Section 4(d), (g) and (h);

22 (4) Have not had any adverse action against any license or compact  
23 privilege within the previous 2 years;

24 (5) Notify the Commission that the licensee is seeking the compact  
25 privilege within a remote state;

26 (6) Pay any applicable fees, including any state fee, for the compact  
27 privilege;

28 (7) Meet any jurisprudence requirements established by the remote  
29 state in which the licensee is seeking a compact privilege; and

30 (8) Report to the Commission adverse action taken by any non-  
31 member state within 30 days from the date the adverse action is taken.

1 (b) The compact privilege is valid until the expiration date of the home  
2 license. The licensee must comply with the requirements of Section 4(a) to maintain  
3 the compact privilege in the remote state.

4 (c) A licensee providing physical therapy in a remote state under the compact  
5 privilege shall function within the laws and regulations of the remote state.

6 (d) A licensee providing physical therapy in a remote state is subject to that  
7 state's regulatory authority. A remote state may, in accordance with due process and  
8 that state's laws, remove a licensee's compact privilege in the remote state for a  
9 specific period of time, impose fines, and/or take any other necessary actions to  
10 protect the health and safety of its citizens. The licensee is not eligible for a compact  
11 privilege in any state until the specific time for removal has passed and all fines are  
12 paid.

13 (e) If a home state license is encumbered, the licensee shall lose the compact  
14 privilege in any remote state until the following occur:

15 (1) The home state license is no longer encumbered; and

16 (2) Two years have elapsed from the date of the adverse action.

17 (f) Once an encumbered license in the home state is restored to good standing,  
18 the licensee must meet the requirements of Section 4(a) to obtain a compact privilege  
19 in any remote state.

20 (g) If a licensee's compact privilege in any remote state is removed, the  
21 individual shall lose the compact privilege in any remote state until the following  
22 occur:

23 (1) The specific period of time for which the compact privilege was  
24 removed has ended;

25 (2) All fines have been paid; and

26 (3) Two years have elapsed from the date of the adverse action.

27 (h) Once the requirements of Section 4(g) have been met, the licensee must  
28 meet the requirements in Section 4(a) to obtain a compact privilege in a remote state.

## 29 SECTION 5. ACTIVE DUTY MILITARY PERSONNEL OR THEIR SPOUSES

30 A licensee who is active duty military or is the spouse of an individual who is active  
31 duty military may designate one of the following as the home state:

- 1 (1) Home of record;
- 2 (2) Permanent Change of Station (PCS); or
- 3 (3) State of current residence if it is different than the PCS state or
- 4 home of record.

## 5 SECTION 6. ADVERSE ACTIONS

6 (a) A home state shall have exclusive power to impose adverse action against  
7 a license issued by the home state.

8 (b) A home state may take adverse action based on the investigative  
9 information of a remote state, so long as the home state follows its own procedures for  
10 imposing adverse action.

11 (c) Nothing in this Compact shall override a member state's decision that  
12 participation in an alternative program may be used in lieu of adverse action and that  
13 such participation shall remain non-public if required by the member state's laws.  
14 Member states must require licensees who enter any alternative programs in lieu of  
15 discipline to agree not to practice in any other member state during the term of the  
16 alternative program without prior authorization from such other member state.

17 (d) Any member state may investigate actual or alleged violations of the  
18 statutes and rules authorizing the practice of physical therapy in any other member  
19 state in which a physical therapist or physical therapist assistant holds a license or  
20 compact privilege.

21 (e) A remote state shall have the authority to:

22 (1) Take adverse actions as set forth in Section 4(d) against a licensee's  
23 compact privilege in the state;

24 (2) Issue subpoenas for both hearings and investigations that require  
25 the attendance and testimony of witnesses, and the production of evidence. Subpoenas  
26 issued by a physical therapy licensing board in a party state for the attendance and  
27 testimony of witnesses, and/or the production of evidence from another party state,  
28 shall be enforced in the latter state by any court of competent jurisdiction, according to  
29 the practice and procedure of that court applicable to subpoenas issued in proceedings  
30 pending before it. The issuing authority shall pay any witness fees, travel expenses,  
31 mileage, and other fees required by the service statutes of the state where the witnesses

1 and/or evidence are located; and

2 (3) If otherwise permitted by state law, recover from the licensee the  
3 costs of investigations and disposition of cases resulting from any adverse action taken  
4 against that licensee.

5 (f) Joint Investigations

6 (1) In addition to the authority granted to a member state by its  
7 respective physical therapy practice act or other applicable state law, a member state  
8 may participate with other member states in joint investigations of licensees.

9 (2) Member states shall share any investigative, litigation, or  
10 compliance materials in furtherance of any joint or individual investigation initiated  
11 under the Compact.

12 SECTION 7. ESTABLISHMENT OF THE PHYSICAL THERAPY COMPACT

13 COMMISSION

14 (a) The Compact member states hereby create and establish a joint public  
15 agency known as the Physical Therapy Compact Commission.

16 (1) The Commission is an instrumentality of the Compact states.

17 (2) Venue is proper and judicial proceedings by or against the  
18 Commission shall be brought solely and exclusively in a court of competent  
19 jurisdiction where the principal office of the Commission is located. The Commission  
20 may waive venue and jurisdictional defenses to the extent it adopts or consents to  
21 participate in alternative dispute resolution proceedings.

22 (3) Nothing in this Compact shall be construed to be a waiver of  
23 sovereign immunity.

24 (b) Membership, Voting, and Meetings

25 (1) Each member state shall have and be limited to one delegate  
26 selected by that member state's licensing board.

27 (2) The delegate shall be a current member of the licensing board, who  
28 is a physical therapist, physical therapist assistant, public member, or the board  
29 administrator.

30 (3) Any delegate may be removed or suspended from office as  
31 provided by the law of the state from which the delegate is appointed.

(4) The member state board shall fill any vacancy occurring in the Commission.

(5) Each delegate shall be entitled to one vote with regard to the promulgation of rules and creation of bylaws and shall otherwise have an opportunity to participate in the business and affairs of the Commission.

(6) A delegate shall vote in person or by such other means as provided in the bylaws. The bylaws may provide for delegates' participation in meetings by telephone or other means of communication.

(7) The Commission shall meet at least once during each calendar year. Additional meetings shall be held as set forth in the bylaws.

(c) The Commission shall have the following powers and duties:

(1) Establish the fiscal year of the Commission;

(2) Establish bylaws;

(3) Maintain its financial records in accordance with the bylaws;

(4) Meet and take such actions as are consistent with the provisions of this Compact and the bylaws;

(5) Promulgate uniform rules to facilitate and coordinate implementation and administration of this Compact. The rules shall have the force and effect of law and shall be binding in all member states;

(6) Bring and prosecute legal proceedings or actions in the name of the Commission, provided that the standing of any state physical therapy licensing board to sue or be sued under applicable law shall not be affected;

(7) Purchase and maintain insurance and bonds;

(8) Borrow, accept, or contract for services of personnel, including, but not limited to, employees of a member state;

(9) Hire employees, elect or appoint officers, fix compensation, define duties, grant such individuals appropriate authority to carry out the purposes of the Compact, and to establish the Commission's personnel policies and programs relating to conflicts of interest, qualifications of personnel, and other related personnel matters;

(10) Accept any and all appropriate donations and grants of money, equipment, supplies, materials and services, and to receive, utilize and dispose of the

1 same; provided that at all times the Commission shall avoid any appearance of  
2 impropriety and/or conflict of interest;

3 (11) Lease, purchase, accept appropriate gifts or donations of, or  
4 otherwise to own, hold, improve or use, any property, real, personal or mixed;  
5 provided that at all times the Commission shall avoid any appearance of impropriety;

6 (12) Sell convey, mortgage, pledge, lease, exchange, abandon, or  
7 otherwise dispose of any property real, personal, or mixed;

8 (13) Establish a budget and make expenditures;

9 (14) Borrow money;

10 (15) Appoint committees, including standing committees composed of  
11 members, state regulators, state legislators or their representatives, and consumer  
12 representatives, and such other interested persons as may be designated in this  
13 Compact and the bylaws;

14 (16) Provide and receive information from, and cooperate with, law  
15 enforcement agencies;

16 (17) Establish and elect an Executive Board; and

17 (18) Perform such other functions as may be necessary or appropriate  
18 to achieve the purposes of this Compact consistent with the state regulation of physical  
19 therapy licensure and practice.

20 (d) The Executive Board shall have the power to act on behalf of the  
21 Commission according to the terms of this Compact.

22 (1) The Executive Board shall be composed of nine members:

23 (A) Seven voting members who are elected by the Commission  
24 from the current membership of the Commission;

25 (B) One ex-officio, nonvoting member from the recognized  
26 national physical therapy professional association; and

27 (C) One ex-officio, nonvoting member from the recognized  
28 membership organization of the physical therapy licensing boards.

29 (2) The ex-officio members will be selected by their respective  
30 organizations.

31 (3) The Commission may remove any member of the Executive Board

1 as provided in bylaws.

2 (4) The Executive Board shall meet at least annually.

3 (5) The Executive Board shall have the following duties and  
4 responsibilities:

5 (A) Recommend to the entire Commission changes to the rules  
6 or bylaws, changes to this Compact legislation, fees paid by Compact member  
7 states such as annual dues, and any commission Compact fee charged to  
8 licensees for the compact privilege;

9 (B) Ensure Compact administration services are appropriately  
10 provided, contractual or otherwise;

11 (C) Prepare and recommend the budget;

12 (D) Maintain financial records on behalf of the Commission;

13 (E) Monitor Compact compliance of member states and  
14 provide compliance reports to the Commission;

15 (F) Establish additional committees as necessary; and

16 (G) Other duties as provided in rules or bylaws.

17 (e) Meetings of the Commission

18 (1) All meetings shall be open to the public, and public notice of  
19 meetings shall be given in the same manner as required under the rulemaking  
20 provisions in Section 9.

21 (2) The Commission or the Executive Board or other committees of  
22 the Commission may convene in a closed, non-public meeting if the Commission or  
23 Executive Board or other committees of the Commission must discuss:

24 (A) Non-compliance of a member state with its obligations  
25 under the Compact;

26 (B) The employment, compensation, discipline or other  
27 matters, practices or procedures related to specific employees or other matters  
28 related to the Commission's internal personnel practices and procedures;

29 (C) Current, threatened, or reasonably anticipated litigation;

30 (D) Negotiation of contracts for the purchase, lease, or sale of  
31 goods, services, or real estate;

1 (E) Accusing any person of a crime or formally censuring any  
2 person;

3 (F) Disclosure of trade secrets or commercial or financial  
4 information that is privileged or confidential;

5 (G) Disclosure of information of a personal nature where  
6 disclosure would constitute a clearly unwarranted invasion of personal privacy;

7 (H) Disclosure of investigative records compiled for law  
8 enforcement purposes;

9 (I) Disclosure of information related to any investigative  
10 reports prepared by or on behalf of or for use of the Commission or other  
11 committee charged with responsibility of investigation or determination of  
12 compliance issues pursuant to the Compact; or

13 (J) Matters specifically exempted from disclosure by federal or  
14 member state statute.

15 (3) If a meeting, or portion of a meeting, is closed pursuant to this  
16 provision, the Commission's legal counsel or designee shall certify that the meeting  
17 may be closed and shall reference each relevant exempting provision.

18 (4) The Commission shall keep minutes that fully and clearly describe  
19 all matters discussed in a meeting and shall provide a full and accurate summary of  
20 actions taken, and the reasons therefore, including a description of the views  
21 expressed. All documents considered in connection with an action shall be identified  
22 in such minutes. All minutes and documents of a closed meeting shall remain under  
23 seal, subject to release by a majority vote of the Commission or order of a court of  
24 competent jurisdiction.

25 (f) Financing of the Commission

26 (1) The Commission shall pay, or provide for the payment of, the  
27 reasonable expenses of its establishment, organization, and ongoing activities.

28 (2) The Commission may accept any and all appropriate revenue  
29 sources, donations, and grants of money, equipment, supplies, materials, and services.

30 (3) The Commission may levy on and collect an annual assessment  
31 from each member state or impose fees on other parties to cover the cost of the

1 operations and activities of the Commission and its staff, which must be in a total  
 2 amount sufficient to cover its annual budget as approved each year for which revenue  
 3 is not provided by other sources. The aggregate annual assessment amount shall be  
 4 allocated based upon a formula to be determined by the Commission, which shall  
 5 promulgate a rule binding upon all member states.

6 (4) The Commission shall not incur obligations of any kind prior to  
 7 securing the funds adequate to meet the same; nor shall the Commission pledge the  
 8 credit of any of the member states, except by and with the authority of the member  
 9 state.

10 (5) The Commission shall keep accurate accounts of all receipts and  
 11 disbursements. The receipts and disbursements of the Commission shall be subject to  
 12 the audit and accounting procedures established under its bylaws. However, all  
 13 receipts and disbursements of funds handled by the Commission shall be audited  
 14 yearly by a certified or licensed public accountant, and the report of the audit shall be  
 15 included in and become part of the annual report of the Commission.

16 (g) Qualified Immunity, Defense, and Indemnification

17 (1) The members, officers, executive director, employees and  
 18 representatives of the Commission shall be immune from suit and liability, either  
 19 personally or in their official capacity, for any claim for damage to or loss of property  
 20 or personal injury or other civil liability caused by or arising out of any actual or  
 21 alleged act, error or omission that occurred, or that the person against whom the claim  
 22 is made had a reasonable basis for believing occurred within the scope of Commission  
 23 employment, duties or responsibilities; provided that nothing in this paragraph shall be  
 24 construed to protect any such person from suit and/or liability for any damage, loss,  
 25 injury, or liability caused by the intentional or willful or wanton misconduct of that  
 26 person.

27 (2) The Commission shall defend any member, officer, executive  
 28 director, employee or representative of the Commission in any civil action seeking to  
 29 impose liability arising out of any actual or alleged act, error, or omission that  
 30 occurred within the scope of Commission employment, duties, or responsibilities, or  
 31 that the person against whom the claim is made had a reasonable basis for believing

1 occurred within the scope of Commission employment, duties, or responsibilities;  
 2 provided that nothing herein shall be construed to prohibit that person from retaining  
 3 his or her own counsel; and provided further, that the actual or alleged act, error, or  
 4 omission did not result from that person's intentional or willful or wanton misconduct.

5 (3) The Commission shall indemnify and hold harmless any member,  
 6 officer, executive director, employee, or representative of the Commission for the  
 7 amount of any settlement or judgment obtained against that person arising out of any  
 8 actual or alleged act, error or omission that occurred within the scope of Commission  
 9 employment, duties, or responsibilities, or that such person had a reasonable basis for  
 10 believing occurred within the scope of Commission employment, duties, or  
 11 responsibilities, provided that the actual or alleged act, error, or omission did not result  
 12 from the intentional or willful or wanton misconduct of that person.

#### 13 SECTION 8. DATA SYSTEM

14 (a) The Commission shall provide for the development, maintenance, and  
 15 utilization of a coordinated database and reporting system containing licensure,  
 16 adverse action, and investigative information on all licensed individuals in member  
 17 states.

18 (b) Notwithstanding any other provision of state law to the contrary, a member  
 19 state shall submit a uniform data set to the data system on all individuals to whom this  
 20 Compact is applicable as required by the rules of the Commission, including:

- 21 (1) Identifying information;
- 22 (2) Licensure data;
- 23 (3) Adverse actions against a license or compact privilege;
- 24 (4) Non-confidential information related to alternative program  
 25 participation;
- 26 (5) Any denial of application for licensure, and the reason(s) for such  
 27 denial; and
- 28 (6) Other information that may facilitate the administration of this  
 29 Compact, as determined by the rules of the Commission.
- 30 (c) Investigative information pertaining to a licensee in any member state will  
 31 only be available to other party states.

1 (d) The Commission shall promptly notify all member states of any adverse  
2 action taken against a licensee or an individual applying for a license. Adverse action  
3 information pertaining to a licensee in any member state will be available to any other  
4 member state.

5 (e) Member states contributing information to the data system may designate  
6 information that may not be shared with the public without the express permission of  
7 the contributing state.

8 (f) Any information submitted to the data system that is subsequently required  
9 to be expunged by the laws of the member state contributing the information shall be  
10 removed from the data system.

#### 11 SECTION 9. RULEMAKING

12 (a) The Commission shall exercise its rulemaking powers pursuant to the  
13 criteria set forth in this Section and the rules adopted thereunder. Rules and  
14 amendments shall become binding as of the date specified in each rule or amendment.

15 (b) If a majority of the legislatures of the member states rejects a rule, by  
16 enactment of a statute or resolution in the same manner used to adopt the Compact  
17 within 4 years of the date of adoption of the rule, then such rule shall have no further  
18 force and effect in any member state.

19 (c) Rules or amendments to the rules shall be adopted at a regular or special  
20 meeting of the Commission.

21 (d) Prior to promulgation and adoption of a final rule or rules by the  
22 Commission, and at least thirty (30) days in advance of the meeting at which the rule  
23 will be considered and voted upon, the Commission shall file a Notice of Proposed  
24 Rulemaking:

25 (1) On the website of the Commission or other publicly accessible  
26 platform; and

27 (2) On the website of each member state physical therapy licensing  
28 board or other publicly accessible platform or the publication in which each state  
29 would otherwise publish proposed rules.

30 (e) The Notice of Proposed Rulemaking shall include:

31 (1) The proposed time, date, and location of the meeting in which the

1 rule will be considered and voted upon;

2 (2) The text of the proposed rule or amendment and the reason for the  
3 proposed rule;

4 (3) A request for comments on the proposed rule from any interested  
5 person; and

6 (4) The manner in which interested persons may submit notice to the  
7 Commission of their intention to attend the public hearing and any written comments.

8 (f) Prior to adoption of a proposed rule, the Commission shall allow persons to  
9 submit written data, facts, opinions, and arguments, which shall be made available to  
10 the public.

11 (g) The Commission shall grant an opportunity for a public hearing before it  
12 adopts a rule or amendment if a hearing is requested by:

13 (1) At least twenty-five (25) persons;

14 (2) A state or federal governmental subdivision or agency; or

15 (3) An association having at least twenty-five (25) members.

16 (h) If a hearing is held on the proposed rule or amendment, the Commission  
17 shall publish the place, time, and date of the scheduled public hearing. If the hearing is  
18 held via electronic means, the Commission shall publish the mechanism for access to  
19 the electronic hearing.

20 (1) All persons wishing to be heard at the hearing shall notify the  
21 executive director of the Commission or other designated member in writing of their  
22 desire to appear and testify at the hearing not less than five (5) business days before  
23 the scheduled date of the hearing.

24 (2) Hearings shall be conducted in a manner providing each person  
25 who wishes to comment a fair and reasonable opportunity to comment orally or in  
26 writing.

27 (3) All hearings will be recorded. A copy of the recording will be made  
28 available on request.

29 (4) Nothing in this section shall be construed as requiring a separate  
30 hearing on each rule. Rules may be grouped for the convenience of the Commission at  
31 hearings required by this section.

1 (i) Following the scheduled hearing date, or by the close of business on the  
2 scheduled hearing date if the hearing was not held, the Commission shall consider all  
3 written and oral comments received.

4 (j) If no written notice of intent to attend the public hearing by interested  
5 parties is received, the Commission may proceed with promulgation of the proposed  
6 rule without a public hearing.

7 (k) The Commission shall, by majority vote of all members, take final action  
8 on the proposed rule and shall determine the effective date of the rule, if any, based on  
9 the rulemaking record and the full text of the rule.

10 (l) Upon determination that an emergency exists, the Commission may  
11 consider and adopt an emergency rule without prior notice, opportunity for comment,  
12 or hearing, provided that the usual rulemaking procedures provided in the Compact  
13 and in this section shall be retroactively applied to the rule as soon as reasonably  
14 possible, in no event later than ninety (90) days after the effective date of the rule. For  
15 the purposes of this provision, an emergency rule is one that must be adopted  
16 immediately in order to:

17 (1) Meet an imminent threat to public health, safety, or welfare;

18 (2) Prevent a loss of Commission or member state funds;

19 (3) Meet a deadline for the promulgation of an administrative rule that  
20 is established by federal law or rule; or

21 (4) Protect public health and safety.

22 (m) The Commission or an authorized committee of the Commission may  
23 direct revisions to a previously adopted rule or amendment for purposes of correcting  
24 typographical errors, errors in format, errors in consistency, or grammatical errors.  
25 Public notice of any revisions shall be posted on the website of the Commission. The  
26 revision shall be subject to challenge by any person for a period of thirty (30) days  
27 after posting. The revision may be challenged only on grounds that the revision results  
28 in a material change to a rule. A challenge shall be made in writing, and delivered to  
29 the chair of the Commission prior to the end of the notice period. If no challenge is  
30 made, the revision will take effect without further action. If the revision is challenged,  
31 the revision may not take effect without the approval of the Commission.

## 1 SECTION 10. OVERSIGHT, DISPUTE RESOLUTION, AND ENFORCEMENT

## 2 (a) Oversight

3 (1) The executive, legislative, and judicial branches of state  
4 government in each member state shall enforce this Compact and take all actions  
5 necessary and appropriate to effectuate the Compact's purposes and intent. The  
6 provisions of this Compact and the rules promulgated hereunder shall have standing as  
7 statutory law.

8 (2) All courts shall take judicial notice of the Compact and the rules in  
9 any judicial or administrative proceeding in a member state pertaining to the subject  
10 matter of this Compact which may affect the powers, responsibilities or actions of the  
11 Commission.

12 (3) The Commission shall be entitled to receive service of process in  
13 any such proceeding, and shall have standing to intervene in such a proceeding for all  
14 purposes. Failure to provide service of process to the Commission shall render a  
15 judgment or order void as to the Commission, this Compact, or promulgated rules.

## 16 (b) Default, Technical Assistance, and Termination

17 (1) If the Commission determines that a member state has defaulted in  
18 the performance of its obligations or responsibilities under this Compact or the  
19 promulgated rules, the Commission shall:

20 (A) Provide written notice to the defaulting state and other  
21 member states of the nature of the default, the proposed means of curing the  
22 default and/or any other action to be taken by the Commission; and

23 (B) Provide remedial training and specific technical assistance  
24 regarding the default.

25 (2) If a state in default fails to cure the default, the defaulting state may  
26 be terminated from the Compact upon an affirmative vote of a majority of the member  
27 states, and all rights, privileges and benefits conferred by this Compact may be  
28 terminated on the effective date of termination. A cure of the default does not relieve  
29 the offending state of obligations or liabilities incurred during the period of default.

30 (3) Termination of membership in the Compact shall be imposed only  
31 after all other means of securing compliance have been exhausted. Notice of intent to

1 suspend or terminate shall be given by the Commission to the governor, the majority  
 2 and minority leaders of the defaulting state's legislature, and each of the member  
 3 states.

4 (4) A state that has been terminated is responsible for all assessments,  
 5 obligations, and liabilities incurred through the effective date of termination, including  
 6 obligations that extend beyond the effective date of termination.

7 (5) The Commission shall not bear any costs related to a state that is  
 8 found to be in default or that has been terminated from the Compact, unless agreed  
 9 upon in writing between the Commission and the defaulting state.

10 (6) The defaulting state may appeal the action of the Commission by  
 11 petitioning the U.S. District Court for the District of Columbia or the federal district  
 12 where the Commission has its principal offices. The prevailing member shall be  
 13 awarded all costs of such litigation, including reasonable attorney's fees.

14 (c) Dispute Resolution

15 (1) Upon request by a member state, the Commission shall attempt to  
 16 resolve disputes related to the Compact that arise among member states and between  
 17 member and non-member states.

18 (2) The Commission shall promulgate a rule providing for both  
 19 mediation and binding dispute resolution for disputes as appropriate.

20 (d) Enforcement

21 (1) The Commission, in the reasonable exercise of its discretion, shall  
 22 enforce the provisions and rules of this Compact.

23 (2) By majority vote, the Commission may initiate legal action in the  
 24 United States District Court for the District of Columbia or the federal district where  
 25 the Commission has its principal offices against a member state in default to enforce  
 26 compliance with the provisions of the Compact and its promulgated rules and bylaws.  
 27 The relief sought may include both injunctive relief and damages. In the event judicial  
 28 enforcement is necessary, the prevailing member shall be awarded all costs of such  
 29 litigation, including reasonable attorney's fees.

30 (3) The remedies herein shall not be the exclusive remedies of the  
 31 Commission. The Commission may pursue any other remedies available under federal

1 or state law.

2 SECTION 11. DATE OF IMPLEMENTATION OF THE INTERSTATE COMMISSION  
3 FOR PHYSICAL THERAPY PRACTICE AND ASSOCIATED RULES, WITHDRAWAL,  
4 AND AMENDMENT

5 (a) The Compact shall come into effect on the date on which the Compact  
6 statute is enacted into law in the tenth member state. The provisions, which become  
7 effective at that time, shall be limited to the powers granted to the Commission  
8 relating to assembly and the promulgation of rules. Thereafter, the Commission shall  
9 meet and exercise rulemaking powers necessary to the implementation and  
10 administration of the Compact.

11 (b) Any state that joins the Compact subsequent to the Commission's initial  
12 adoption of the rules shall be subject to the rules as they exist on the date on which the  
13 Compact becomes law in that state. Any rule that has been previously adopted by the  
14 Commission shall have the full force and effect of law on the day the Compact  
15 becomes law in that state.

16 (c) Any member state may withdraw from this Compact by enacting a statute  
17 repealing the same.

18 (1) A member state's withdrawal shall not take effect until six (6)  
19 months after enactment of the repealing statute.

20 (2) Withdrawal shall not affect the continuing requirement of the  
21 withdrawing state's physical therapy licensing board to comply with the investigative  
22 and adverse action reporting requirements of this act prior to the effective date of  
23 withdrawal.

24 (d) Nothing contained in this Compact shall be construed to invalidate or  
25 prevent any physical therapy licensure agreement or other cooperative arrangement  
26 between a member state and a non-member state that does not conflict with the  
27 provisions of this Compact.

28 (e) This Compact may be amended by the member states. No amendment to  
29 this Compact shall become effective and binding upon any member state until it is  
30 enacted into the laws of all member states.

31 SECTION 12. CONSTRUCTION AND SEVERABILITY

1 This Compact shall be liberally construed so as to effectuate the purposes thereof. The  
 2 provisions of this Compact shall be severable and if any phrase, clause, sentence or provision  
 3 of this Compact is declared to be contrary to the constitution of any party state or of the  
 4 United States or the applicability thereof to any government, agency, person or circumstance  
 5 is held invalid, the validity of the remainder of this Compact and the applicability thereof to  
 6 any government, agency, person or circumstance shall not be affected thereby. If this  
 7 Compact shall be held contrary to the constitution of any party state, the Compact shall  
 8 remain in full force and effect as to the remaining party states and in full force and effect as to  
 9 the party state affected as to all severable matters.
