To the Honorable Senators Olson, Hoffman, Stedman, Bishop, Merrick, Kiehl, and Wilson,

Good morning. My name is Natalie Troy and I live and work in Juneau. I currently work for the Alaska Council of School Administrators, but I am testifying on my own behalf.

Thank you for taking up SB 52 and for making education funding a top priority of the Senate Majority Caucus this session.

Public schools represent both a public good and a business whose outcomes are tied to many different factors, reaped over the decades in the ability of Alaska's citizens to build meaningful lives and survive and thrive in the changing economy. The main revenue source for Alaska's schools is state funding. All businesses need revenue and investment to thrive. Schools are no different. When schools have to make cuts to keep up with rising costs, kids' learning environment gets worse, staff jobs get harder as they have to take on more and more responsibility, and when positions are cut, communities and the state lose good jobs. This funding also needs to be inside the formula so districts can depend on it rather than tying ongoing costs like insurance and staff benefits to unpredictable one time funds. The forward funding aspects of SB 52 are also very helpful for this. As a recent college graduate looking to get certified and teach, investing in education and allowing districts to improve working conditions is something likely to get people like me to stay here rather than leaving for comparable states like Washington who have done much more to support public education in recent years.

There has been a lot of discussion of fund balances this week. As Senator Stedman and other committee members questioning has helped unpack in committee meetings this week, just because those funds may still be available does not mean districts are rich with cash. Those numbers come from an uncontextualized chart and many of them have already been budgeted to expend. Or, if districts choose or are instructed by their school boards to keep money in their bank account, we need to remember that that is sound financial practice. As individuals, we try to keep money in the bank account in case of medical or other emergencies. School districts are maintaining buildings and running classes for up to thousands of students. Keeping a certain level of fund balance is prudent to deal with unexpected costs.

I also urge you to support funding for public libraries and services supporting childcare and services for disabled Alaskans. The state should prioritize public services and supporting the most vulnerable. A huge PFD should not be offered without a sound fiscal plan.

Thank you for considering my testimony. Please remember as well how much support public education has drawn in testimony before your committee as well as the House Education Committee this session. Investing in schools will make them better and will result in staff who are less stretched thin and able to achieve important goals, such as implementation of the Alaska Reads Act, better.

My name is Abby O'Neill, and I am an administrator representing North Star Elementary in Anchorage School District.

I am writing in support of: SB 52

Stable, predictable funding is necessary to ensure districts can attract and retain high quality educators. The base student allocation (BSA) has only been increased by \$30 since 2016, and the impact of inflation during that time has created a significant loss of purchasing power for school districts.

In the Anchorage school district, we have seen the impact of insufficient funding and inflation. Personally, as an administrator of a Title I school, I find it already hard to hire and now with our lack of increase in BSA funding I have a hard time retaining people, drawing in new hires, or asking teachers and paras to do the job at hand knowing that we are paying less than Target and Walmart to our paraprofessionals. I have had new teachers not move to AK once they see the salary in relation to our cost of living. The other thing impacting our teachers is the lack of retirement in our state as well giving them no reason to stay invested in our state.

I work at a high needs school that houses a self-contained sped program as well as ages preschool to 6th grade. The lack of funding makes it hard to provide adequate training, professional development and the foundational skills needed to handle high level behaviors, academic needs, and the trauma-informed practices that are essential to student success.

Reliable funding is key to improving student outcomes by stabilizing schools and reducing educator turnover.

With an increase to the BSA our district will use the additional funds to decrease pupil to teacher ratio, make much needed improvements to buildings, provide better resources and tools for classrooms, and provide a better work experience and livable wage for employees.

I invite anyone who is interested to come visit North Star. It is a beautifully diverse school that meets the needs of not only the students but of our families as well. We are a support to the community and work hard to provide a quality education for students. Raising the BSA is essential for our school because it will provide more funding for better training, higher more qualified staff, and making sure our school is a safe place for kids.

Please consider increasing, as well as inflation proofing the BSA to ensure Alaska schools can continue to serve students with the quality education they deserve.
