In case I continue to be disconnected from the call-in number for Fairbanks to testify, I am including my testimony here:

To the Honorable Members of the House Education Committee,

My name is Putt Clark, I am from Fairbanks, I am a 55 year old born-and-raised Alaskan, and I am testifying on behalf of myself against HB 105.

Governor Dunleavy's bill is a continued attack on LGBTQ+ youth and will increase bullying, harassment, and stigmatization towards transgender youth in particular.

First, the Governor slyly removed a policy from the state Human Rights Commission website that included protections for LGBTQ Alaskans from most forms of discrimination. In early March, some observant folks discovered the policy was quietly removed months before, without ANY discussion on the matter from the Governor's office.

Next, he introduced bills HB 105 and SB 96, relating to "parental rights" and diminishing LGBTQ student's rights.

He also directed his State Board of Education to pass a Resolution called "Preserving the Opportunity for Student Athletes", which discriminates against trans-gendered (more specifically, trans-female) athletes. My daughter has given up her hopes of competing in track this year because of this.

The actions of this Governor are an orchestrated assault against our vulnerable youth. As the parent of a trans-female high school Senior, I recognize this legislation to be nothing short of bigotry, and it puts transteens at risk.

My daughter has chosen to continue to use the boys bathroom at school to reduce controversy and complaints. However, this has put her at risk. Recently she was harassed by a group of boys in the bathroom, and one of them tried to get the others to join him in "jumping" her. Fortunately, the other boys didn't, and she managed to escape.

While this legislation has the appearance of being benign and about the safety of children, the undercurrent of its intensions are more insidious. They are about controlling **other** people's rights and serve to unravel the safety nets for vulnerable youth. Call these "parental rights" but really, they are "bullying rights".

Our house has been a safe house for a number of vulnerable young people. Recently we took in a youth who was kicked out of her home for telling her parents she was gay. There are too many parents out there who put their belief systems **BEFORE** their own children. Giving more control to parents over their teens lives while at school will only tighten the noose these young, almost-adults, are feeling.

I suspect that those who support this legislation support Alaska's youth conditionally: they're all about protecting them as long as they're straight and narrow. However, if the youth are part of the LGBTQ community, they would rather just see them all "go away".

Those who would vote for HB 105, I ask that you consider the health and safety of ALL students. Please vote against this bill.

I would like to voice my extreme displeasure against the additions to HB105 due to its inherent discrimination.

Section 1(a)(3) adding "gender identity" to the subjects that parents must be pre-notified and approved is discriminatory and hurtful to those students who face gender dysphoria every day. Gender Dysphoria, as defined by the Mayo Clinic, is the feeling of discomfort or distress that might occur in people whose gender identity differs from their sex assigned at birth or sex-related physical characteristics. It is a valid diagnosis in the Diagnostic and Statistical Manual of Mental Disorders (DSM-5), where the diagnosis refers to the discomfort as the problem, not the identity.

Why is Gender Identity being added as a topic that requires parental permission? Why not add depression, or ADHD? It is a known fact that young adults with Gender Dysphoria have one of the highest suicide rates of all young adults. Not being able to address or discuss it only stigmatizes it further, driving those students further into despair.

It is frustrating when proposed legislation like HB 105 comes along and at its core is discriminatory to a portion of the population. HB 105 does the exact opposite of what we are trying to do in public education, teach students to work together and accept differences in others. These problems are being created by adults who find it difficult to be accepting of other differences. We can do better and need to do better for children. We should be pushing for legislation that is supportive of everyone regardless of individual differences. LGBTQ+ students want to come to school to learn, be treated with respect, prepare to enter the work force and be able to live their life, just like their peers.

In public education we must work to protect students from so many things, drugs, abusive relationships, bullying, and yes, poor family situations. HB 105 restricts our ability to do this. I would like a concrete example of what "result in child abuse or neglect" means? Can you give specific examples of what this looks like? No, you cannot because there are many variables that come into play. My job is not to determine if the student is in a situation of abuse or neglect but to report the possibility of such based on what the student says or is revealed to me. We as educators work to understand where students are coming from and try to connect them with services to assist them and their family. We need to be focused on increased funding for services that lift families up, improve parenting skills, provide mental health counseling, more after school programs, more early childhood services, more mentors, more financial assistance for struggling families, support for grandparents raising their grandchildren, drug and alcohol rehab programs, stable housing programs, I could go on and on.

I strongly encourage you to vote no on HB 105. We should be fostering acceptance not divisiveness.
