We want to be notified of topics and content that will be introduced in sex education classes, health instruction, and school counseling. This includes inviting parents to join guest speakers and view supplemental content like videos or web resources that will be given to students. I want to see improved and expanded communication between home and school so that parent engagement is foundational to how schools function. Busy, but concerned parents want notification to come in multiple forms such as newsletters, emails, robo-texts and calls, and facebook posts. Details about the particulars should be shared with us so we can make connections with our kids on these sensitive topics. Covid closed the doors to parents and supportive community members. Parents and caretakers literally could not come into schools with their children anymore. Now there is a desperate need to build parent partnerships back up within the schools and empower parents with ways to support their child's educational and health needs. To All Elected Officials of the State of Alaska:

Please pass HB 105. If the bill fails, please introduce new legislation just like the bill. The bill is not seeking anything extreme. Not passing the bill invites extreme behaviors, ideologies, and sexual indoctrination of our children to occur unchecked.

Any activities, classes, or programs that involve gender identity, human reproduction, or sexual matters delivered to the youth of Alaska should not be administered without the parent's ability to review such lesson plans and opt their child out if they so choose. A parent should have the right to also have conversations with their child before or after such materials or activities occur, which only strengthens the parent-child relationships. Fostering strong family bonds and open conversations only strengthens the future of our children and nation. Additionally, in no instance should parental rights be infringed upon as it is governmental overreach – and schools constitute government agencies, hence why bible teachings have not been allowed in public schools for decades. The fact that some teachers in Alaska have spoken out against this bill rings alarm bells, red flags, and should quite frankly, those teachers should be actively investigated by the school districts and Law Enforcement. The question should be – what are they trying to hide from us and why?

In many places, it has become acceptable, legal and/or standard practice that children be subjected to pornographic materials, drag shows, and disturbing extreme ideological concepts of gender identity (transitioning before adulthood through gender-affirming healthcare) at a very young age in schools. Some materials being used even graphically depict sexual acts – to include oral sex and anal penetration and sex acts between children and adults. These materials, drag shows, etc. are harmful for a young developing mind and should not be given to children. These types of materials and events should be for adults only. The countless viral drag show videos that can be found by a simple social media search show children of all ages being exposed to naked to half naked adults. In

one case, a 10th grade girl received a lap dance, and her face was buried in the crotch of an adult transgendered individual in front of what appeared to be a gym full of students. This is disturbing as we wouldn't allow biological women to perform a strip show for our children, so why would we allow a naked transgender person to do a stripper show? Simply put, neither is acceptable and parents should have a right to know what is being taught or shown to their children.

The materials and events occurring in some schools is truly "grooming" by adults with some nefarious intentions. Parents should never be kept in the dark regarding what their child is being exposed to at school. It outwardly contradicts the "no secrets" rule we have historically used to keep children protected from pedophiles and assailants. We question the motives of anyone trying to "keep secrets" regarding these matters from parents. Additionally, under no circumstances should a child under the fourth grade ever be taught any topic related to gender identity, human reproduction, or sexual matters, which is addressed later in the bill.

Regarding the next part of the bill for the use of names and pronouns, again, this is a parent-child relationship matter, not the government's right (i.e., schools) to involve itself in and keep secret. Social media, public figures, government officials, and schools across the nation are beginning to fill children's heads with concepts of which children cannot fully understand, as their brains have not been fully developed, nor has their sexuality. Thinking or believing otherwise simply is baseless nonsense with no real scientific evidence. The number of children and adults coming out as "de-transitioning" citing irreversible physical mutilations, mental health damages, and grooming by adults at a young age is not something to discredit and dismiss so nonchalantly. Lastly, regarding the physical safety and privacy of students in locker rooms and restrooms through the separation of students by biological sex, access to single occupant facilities, or other safety and privacy protocols is not an extreme request. A young girl should not have her first experience seeing a boy's penis in her school locker room or bathroom. Vice versa for boys. Additionally, there have been countless documented cases of sexual predators who have claimed to identify as the opposite sex just to gain access to see naked girls and/or commit violent assaults to include rape. The mainstream media is burying these incidents. However, they are occurring on an unimaginable scale – a simple search on non-mainstream media outlets will support the cases. Women in several prisons are crying out as biological males who identify as "trans" that are incarcerated with them have been repeatedly sexually assaulting the women. 


