After reading HB 105, it appears reasonable and in line with ideals of transparency and proper notice being given to parents, foster parents and guardians regarding the education of their children.

The opposition to this bill appears to focus on trying to "protect rights" of children, but all these arguments focus on privacy of discussions of sexual matters. As a survivor of sexual abuse by a teacher, anything that prevents information about sexual topics or obscures the contents of discussions about sexual topics from the view of parents, foster parents and guardians dramatically increases the risk of abuse for our children. Committee Members,

I would like to voice my support of the parental rights bill before you.

I remember sitting with my oldest child as a newborn and being overwhelmed with the job before me. But I wouldn't trade that job or hand it off to anyone else for all the world's riches. The very hardest things we are called to do are the most important.

I have 5 children now and raising them is a full time job that my husband and I have prioritized above all other commitments, hobbies, and responsibilities.

We have meaningful relationships with our kids and they can talk to us about anything. We provide a safe place to handle big ideas and questions and we create clear boundaries and healthy limits. This is parenting.

I cannot imagine that any teacher, no matter their love for children, could ever know or love my children more than myself and my husband. It simply isn't possible. We have watched them encounter every change and obstacle in their young lives. We have cried with them, hugged them when they failed, laughed hysterically with them, and celebrated their wins. We have a depth of knowledge that no teacher, administrator, or health provider could ever obtain. All of those people get snapshots of their life and the information they need to do their part in assisting with a particular area of their life, growth, and health.

Who pointed out to the doctor that my daughter had extra bones in her feet? I did. No provider had noticed (not even the physical therapist) but we did because we were the ones who taught her to tie her shoes and heard her complain about foot pain. So we read and searched and evaluated and found the cause and then shared it with her doctor who confirmed that we were correct! It's not a life altering problem but it was a simple answer to her pain that they had all missed. Doctors are generally smart and have tons of knowledge crammed into their brains but that doesn't make them more suited to caring for my children.

Who looked at two of my kids and realized they were dyslexic? I did. I was told by sponsor teachers that it was something they would just grow out of. Homeschool has been the key to our success. Who struggled day in and day out to help them to understand phonics and learn to read? Who threw an actual party the first time my daughter successfully read a page in a book? I did. Teachers are trained to work with a class and do their best to work with individual students. I am intimately invested in each of my children. They are my responsibility. Their pain is mine to share. When they cry over their struggles to learn math or to learn to read I am right there with them providing support and hugs and then pouring over resources to find the next tools we need. They won't move on to some other teacher next year who spends months getting to know them and trying to make an impact. I will be there with full knowledge of their strengths and weaknesses and ready to come alongside with the best fitting curriculum, ready to challenge and push them.

When another of my daughters went through a tomboy phase, who noticed all the times she looked longingly at the pretty dresses and then declared she only liked jeans? I did. Who watched her struggle and start to sort out who she really is with swings between fancy hairdos at home and boring ponytails when she left the house, make-up and dresses that were tried on at home while never making it out of the house in anything but grungy T-shirt's and jeans? I did. A

teacher at school would have only seen the tomboy, she wouldn't have seen the beautiful process of my daughter figuring out which parts of girly things she liked and what she didn't. They wouldn't have seen the value of the budding confidence as some of those things she loved started making it out of the house. They would have missed the significance of that stunning joy on her face when she put on some mascara, a purple sweatshirt, a pink hat, and dangling earrings and walked out with confidence in who she has determined that she is. Someone along the way might have misunderstood from their narrow outside perspective and lumped her into a category she didn't belong in. They might have destroyed her confidence altogether by missing who it is she was wanting to be. Instead, she is growing into a well-rounded young lady with varied interests, wildly changing style (the grunge look still makes its appearance), and confidence.

Each of our kids is unique and incredible and no one knows them better than my husband and I. No one can see their needs or read their emotions faster than we can—we have put in the time and effort to know who they are, know how to push them, and know when to comfort them. I cannot imagine a person outside of our home making life-changing decisions with my kids without ever tapping into the knowledge we possess about each of them. Teens are in such a state of change and growth. Their understanding is skewed by hormonal shifts. Each day can look completely different but we, as parents, get to see it all and understand who they really are. We get to hear their ever-changing dreams, goals, and interests without holding them to what they said those were yesterday. We have the full picture unlike anyone else in their life.

I ask that you preserve the rights of those who know kids best. Don't allow decisions to be made without the knowledge and input of the parents. We do know our children best. We have more concern for their health, growth, future, and confidence than anyone else in their life. We know when they are ready to handle big topics and when they need extra time. Let us do what we are designed to do and launch our kids as successful, confident individuals. Make sure that other people in their lives are pointed back to us to gain perspective and permission when it comes to things that could alter their lives! We know them best.
