To whom it may concern,

I'm writing this email today in regards to House Bill 105 which pertains to parental rights in my Child's education. This year (2022-2023) is the first year that my son has entered into the public school system. For years as a parent I looked forward to the day that I would place my children into school. My own personal experiences throughout my education was a positive, encouraging and uplifting one. It was a process filled with new friendships, positive relationships with teachers, new challenges, new goals and new milestones. Out of all of those things the part I appreciated and look back on the most was the interactions, openness and involvement between myself and my parents and between my schools and my parents. There was an open dialogue always, there was a mutual respect between both parents and educators. There was a comradery between myself, my parents and my educators throughout every grade level that all communicated TOGETHER that they cared about the well being of me and my classmates.

As a child and a student, I formed a respect and admiration for my parents AND my teachers because they created an environment where my parents trusted what my teachers were teaching me when I was at school and my teachers left the parenting to my parents outside of school.

Now as I sit here today and I'm seeing the potential of HB 105 not being passed, I have tremendous concern and fear for my son and his education process. Not because the teachers that he has before him are not fully equipt and outstanding educators. Because I know that they are. But because if Bills such as HB 105 does not get passed, the system is making the choice to sever the relationship between educator and parent. They're creating a wedge between a healthy and thriving relationship that for decades has been successful. They are blurring and crossing the line when it comes to overstepping a parents right to teach their own children the fundamentals of sexuality. And they're burning the most important bridge of trust from parent to teacher that once broken can only end in destruction. By choosing to withhold information about a parent's own child and what they're learning they are taking away that right. The school system risks breaking the trust of parents all across the state. Trust is the core of a system and only takes a second to break and a lifetime to rebuild.

I love my son. I've spent the last 6 years of his life teaching him, guiding him, having open honest conversations with him. Getting to know him, asking him questions about himself, staying up late with him, taking care of him when he's sick or when he's sad. I am his mother. No one else. I would love to continue to give my son a positive educational experience like the one that I had in my 18 years in the school system. I am choosing every day to trust that when I send my son to school each day, out of my care that what his educators are teaching him is within the realms of what is appropriate and that there is NO information or topic that is withheld from me.

But I will not hesitate to take my son out of that process if the line gets crossed. Which would be such a shame. I'm not asking you to stop being a "safe place" for all children. Schools should be that way. But I am imploring you to really think about the ramifications and ripple effect declining House Bill 105 will have on so many children and families.

### Parental Rights and why I support HB105

3. Medical rights. I am entrusted to make medical decisions for my children.  
**Lev 12:3** And in the eighth day the flesh of his foreskin shall be circumcised.

4. Provision rights. I am entrusted to provide food and shelter for them.  
**1Ti 5:8** But if any provide not for his own, and specially for those of his own house, he hath denied the faith, and is worse than an infidel.

5. Religious and educational rights. I am entrusted to educate and give religious training to my children.  
**Pro 22:6** Train up a child in the way he should go: and when he is old, he will not depart from it.  
**Isa 28:10** For precept *must be* upon precept, precept upon precept; line upon line, line upon line; here a little, *and* there a little:

6. Correction rights. I am entrusted to provide adequate correction when needed.
