Is history repeating itself?

Alaska history has shown that political operatives who have been extensively engaged in politics, political campaigns and campaign fundraising from the oil and gas industry are unfit for the Alaska Oil and Gas Conservation Commission. The unethical episodes of former AOGCC commissioners Randy Ruedrich and Sarah Palin is but one example of how appointing political operatives to the AOGCC is a recipe of corruption, among other unsavory things.

Please remember that one cannot serve two masters, as was the case in the corrupt AOGCC Ruedrich/Palin affair.
