"An Act relating to home- and community-based services under the medical assistance program; relating to medical assistance for recipients of Medicaid waivers; establishing an adult care home license and procedures; providing for the transition of individuals from foster care to adult home care settings; and providing for an effective date."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

CONDITIONAL EFFECT; NOTIFICATION. (a) Section 2 of this Act takes effect only if, and to the extent that, before July 1, 2027, the United States Department of Health and Human Services approves amendments submitted under sec. 7 of this Act.

(b) The commissioner of health shall notify the revisor of statutes in writing within 30 days after the United States Department of Health and Human Services approves amendments to the state plan.
