I am a resident Alaska since December 2022 residing at Eielson AFB, and represented by Senator Kawasaki, District P, Fairbanks. Although I am enlisted active duty military, the following is my personal view ONLY and NOT those of the Department of Defense.

Distinguished Senators of the State of Alaska,

I am distressed by the recent presentation by Senator Wielechowski, his staffer Mr David Dunsmore, and testimony from John Koza, PhD, Chair of the National Popular Vote organization.

My concern is that they use erroneous logic in their allegation that Alaska's current "winner-take-all" system is unfair, and that it results in candidates dismissing Alaska as not worth campaigning for it's meager 3 electoral votes.

The logical error these intelligent men make is that SB 61 will "force" candidates to campaign in AK. Why? Presidential and VP candidates would not be motivated at all to visit Alaska, because SB 61 will defer Alaska's electoral college votes to match the National "winner takes all" system. That is decidely less fair than the current ranked choice voting system currently in place in that gives a fair voice and vote to every resident proportional to the population across the great state of Alaska.

Entering Alaska into this interstate compact or policy agreement proposed by SB 61 will legally obligate electorates to disregard the views of ALL Alaskan voters. **Dear Members of the Senate State Affairs Committee:** 


I am Judy Andree, a 57-year resident of Alaska, with 13 years experience working on elections, primarily at an early voting station. I strongly support SB 61.

I have several reasons for supporting the use of the popular vote to select the President. The first is a need to have all votes for President counted rather than the Electoral College method which leaves a great number of votes at the state line. It should be the people electing the President and not the States.

Under the Electoral College and the winner-takes-all that most states follow, the battleground states become the center of campaign activity with many other states never seeing the Presidential candidates during the campaign season. Those same battleground states were targeted by foreign agents with disinformation and propaganda to try to sway the 2016 election, according to the Mueller report, and many of those actors are still busy today on social media. The Electoral College has become a national security issue, a situation made possible by modern technology that the Founding Fathers could not have predicted.
