### HB 118 Sectional Analysis

#### **Title 8 - Business and Professions**

#### **Chapter 60 - Junk Dealers and Junk Yards**

#### Section 1 - AS 08.60 is amended by adding a new section to read:

AS.08.60.215(a), requires scrap metal dealers to register with the Department of Public Safety prior to purchasing a used detached catalytic converter.

**AS.08.60.215(b)**, requires scrap metal dealers to purchase or acquire used catalytic converters or the non-ferrous part of a catalytic converters at their place of business during an in-person transaction.

AS.08.60.215(c), requires the scrap metal dealer to keep accurate paper or electronic records about the purchase of a detached used catalytic converter or non-ferrous part of a catalytic converter.

#### Sec. 2. AS 08.60.220 is amended to read:

**Inspection availability,** A dealer shall make the records required by AS 08.60.200, [AND] 08.60.210, and 08.60.215(c) available for inspection by a law enforcement officer during the dealer's regular hours of business or at reasonable times if the dealer does not keep regular hours of business.

#### Sec. 3. AS 08.60.230 is amended to read:

**Retention of records,** A dealer shall maintain the records of a transaction required by AS 08.60.200, [AND] 08.60.210, and 08.60.215(c) for five years after the date of the transaction.

#### Sec. 4. AS 08.60.250 is amended to read:

**Criminal penalties,** A dealer who knowingly fails to comply with AS 08.60.200 - 08.60.215 [AS 08.60.200 OR 08.60.210] or a person who knowingly makes a false entry for a record

required under AS 08.60.200, [OR] 08.60.210, or 08.60.215(c) is guilty of a class A misdemeanor. In this section, "knowingly" has the meaning given in AS 11.81.900.

#### Sec. 5. AS 11.76 is amended by adding a new section to read:

#### Sec. 11.76.160, Possession sale, or purchase of a used detached catalytic converter,

This new section describes in detail under what circumstances a person can be charged with knowingly possessing, selling, or purchasing a detached catalytic converter of non-ferrous parts of a catalytic converter.

#### Sec. 6. AS 44.41.020 is amended by adding a new subsection to read:

(h) The Department of Public Safety shall maintain a central registry of persons engaged in the business of purchasing used detached catalytic converters and shall adopt regulations to implement AS 08.60.215 and AS 11.76.160.

# Sec. 7. The uncodified law of the State of Alaska is amended by adding a new section to read:

#### APPLICABILITY,

(a) AS 08.60.215, enacted by sec. 1 of this Act, applies to used detached catalytic converters purchased on or after the effective date of this Act.

(b) AS 08.60.250, as amended by sec. 4 of this Act, and AS 11.76.160, enacted by sec. 5 of this Act, apply to offenses committed on or after the effective date of this Act.

(AS 11.81.900. Definitions.) (2) a person acts "knowingly" with respect to conduct or to a circumstance described by a provision of law defining an offense when the person is aware that the conduct is of that nature or that the circumstance exists; when knowledge of the existence of a particular fact is an element of an offense, that knowledge is established if a person is aware of a substantial probability of its existence, unless the person actually believes it does not exist; a person who is unaware of conduct or a circumstance of which the person would have been aware had that person not been intoxicated acts knowingly with respect to that conduct or circumstance;
