As a student pharmacist in Alaska that is dedicated to optimizing healthcare for all Alaskans, I wanted to ask for your continued support of HB 112, ""An Act relating to the Board of Pharmacy; . . .". The mission of the Alaska Board of Pharmacy is ultimately to ensure the safety and well-being of the Alaskan people by establishing clear standards for the practice of pharmacy. With this goal in mind, amendments are needed to current legislation to ensure accountability of all parties engaged in the practice of pharmacy and improved access to care.

HB 112 will modernize Alaska pharmacy statutes in the following ways:

- Increase diversity of representation by replacing one public member seat in the Alaska Board of Pharmacy with a pharmacy technician seat
- Improve access to life-saving epinephrine auto-injectors that can be used in the event of a severe allergic reaction
- Require pharmacists dispensing controlled substances to register with the controlled substance prescription database
- Regulate the qualifications of all parties involved in the profession of pharmacy, including drug manufacturers

By enabling the Alaska Board of Pharmacy to address current gaps in legislation, you are paving the way for improvements that can more fully address contemporary issues in pharmacy and better safeguard public health.
