## Good Morning,

I am writing as the current assistant principal of Mountain View Elementary in Kenai Alaska. Next year, I will be the principal of this school. <u>Please take action and permanently increase the BSA.</u>

It is hiring season. I am desperately attempting to retain and recruit teachers and other staff members for my school. Mountain View Elementary is a wonderful place. We are a Title I school and we have the largest special education program in the Kenai Peninsula Borough School District. We have excellent staff retention, with the majority of our teachers having worked here for 10+ years.

All of that being said, teachers and school staff are tired. COVID-19 was hard on educators across the state and country. Staff are still recovering. They are working with significant student learning loss, both academically and socially. My 5<sup>th</sup> grade teachers are working to teach 27+ students in all subject areas with student ability levels ranging from beginning Kindergarten to late middle school. They are doing this alone, with very little academic support in our classrooms. Our interventionists are swamped attempting to assist all of these students, and are only serving the students functioning far below average. While working to meet students where they are at academically, teachers and staff around the state are dealing with decreased attendance, increased behavior issues, and increased parent apathy.

Teachers and school staff members are miracle workers, yes, but they can't work miracles with insufficient resources. Teachers are leaving are state, and new ones aren't coming to replace them. School districts need money to fund school staff fully and provide financial incentives for people to want to work in our state. I am faced with class sizes of approximately 30 students in each of my third, fourth, and fifth grade classes next year due to staffing cuts.

From a school employee perspective, it seems that there is a war waging against public education. Nasty rumors are spread daily about what is happening inside public school walls. I hear words like "indoctrination", "woke teachers", etc. There is no hidden agenda in the Kenai Peninsula Borough School District. We are working diligently to help kids learn both academically and socially. We are teaching and shaping our country's future. Increasing the BSA is not "throwing money at a problem", it is giving highly trained, highly qualified educators the incentive and support they need to teach effectively in Alaska.

Please help us do this by allocating the funding we need to prosper.

Good morning Senator Stedman, Senator Olson and Senator Hoffman, and members of the Senate Finance Committe:

My name is Cyndy Mika and I am the Superintendent of the Kodiak Island Borough School District. As the Superintendent in Kodiak and the parent of a HS student, I am writing today to share my support and to ask you to support SB 52 and permanently increase the Base Student Allocation.

The BSA hasn't seen a significant increase since 2017 and you must recognize the diminishing value of flat funding in relation to inflation. Early notification of funding and forward funding is crucial to sound financial management, as well as recruitment and retention of quality educators.

We appreciate the \$175 million one-time funds for education currently included in the state budget, recognizing an increase to the BSA will give school districts the reliable funding they can count on beyond FY24.

This year I have had to cut 12 teaching positions and raise the per-pupil ratio of our secondary campuses to 30 students in a class. This has brought our deficit budget in KIBSD for FY24 from \$4.8 million to \$2.8 million. Without also cutting programs and potentially closing one elementary, I don't have any other positions to cut at this time to further lower the deficit. We continue to analyze our system for efficiencies, but with the increased costs we are facing, it seems an impossible task without taking away non-core programs for our students, which I know is not what is best for students. Additionally, I need to add 5 reading specialist positions to comply with the AK Reads Act which will raise our deficit from the \$2.8 million we lowered it to through cuts up to \$3.3 million.

An increase to the BSA would allow KIBSD to potentially lower teacher to pupil ratios in classrooms, add reading specialists to comply with the Alaska Reads Act, and create long term instructional and financial plans to ensure a high-quality education for students.

By increasing and inflation proofing the BSA, KIBSD will be able to budget for increasing fixed cost.



To be honest, here in this last month of school I have not been able to do the work my job demands of me AND monitor any chances to SB52 along the way. I'm not sure if changes have been made since I last saw that was being proposed. I support the increase of 1000 for this next SY24, and an increase beyond that in SY25. I also support creating a mechanism to tie future BSA in some way to inflation, consumer price index, or other measures to indicate an increase cost of living that doesn't just affect families or the private sector but impacts public programs as well.
