FISCAL NOTE ANALYSIS

BILL NO. CSHB25 (STA)

Analysis

This bill allows Alaskans serving their country in the NOAA Commissioned Officers Corps and U.S. Public Health Service Commissioned Corps to remain eligible for the Permanent Fund Dividend (PFD) if their duties require absences that are allowable for Alaskans in the other uniformed services groups. This bill also creates a new definition for the term 'uniformed services' within PFD's statutes.

This bill adds an allowable absence for merchant mariners whom are absent from the state during the qualifying year for the purposes of attending a vocational program approved by the US Coast Guard that trains students for a career in the US merchant marine program.

This bill also adds a hardship extension to the permanent fund dividend filing deadline for an eligible individual if that individual's parent, guardian, or other authorized representative was unable to file on their behalf due to a medical emergency. This bill will also require a new definition for the term 'medical emergency' within PFD's statutes.

The PFD Division has submitted an indeterminant note for the CS for HB 25 as it is unclear in this bill if it will require a new form or a new application type. HB 25 could be a potential conflict with current regulation 15 AAC 23.123; Application on behalf of a disabled, incompetent, or other adult.
