Analysis

This bill amends AS 44.12.010(a) establishing a new legal holiday on the 19th of June, to be known as Juneteenth Day.

To evaluate fiscal impact, the department pulled an average of actual costs on three holidays, July 4, 2022; October 18, 2022; and January 16, 2023.
