I am a ride leader for the Fairbanks Cycle Club, and Matt was a frequent, near-constant presence on our rides. He was strong, kind, and had an upbeat attitude on every ride--rain or shine. Getting to know Matt on these rides was an inspiring. Even though he logged many more miles than any of us (he commuted daily from his home in North Pole, Alaska, to work at the Alaska Railroad yard in Fairbanks), he never tired of joining our rides--after work, or riding in from NP to participate.

It is very appropriate to name the soon-to-be-constructed bike path after Matt because that was his route to and from work nearly every day. Morning and evening commuters could easily recognize him as they shared the road with him. But it was this very road on which he was struck one morning, and later died of his injuries. Chair and members of the committee, my name is Jennifer Cook I am from North Pole, AK and am representing myself as well as the Fairbanks Area Hiking Club. I am testifying in favor of SB 129, an act to name the bike path connection from North Pole to Fairbanks after my late friend, Matt Glover.

As an already approved project with funding this bill will not bring additional cost to the State of Alaska. This bill will recognize a gentleman that represents so much of what it means to be 'Alaskan'. I first met Matt on the hiking trails with his then 'wife to be' Ariane, through one of the Fairbanks hiking Club weekly social hikes. As Matt was one of a handful of the club members residing in North Pole and Ariane was employed on Eielson AFB (my place of employment) we quickly became acquaintances and subsequently friends. For every time I saw Matt at a social event, I saw him on his commute to/from Fairbanks ten times, or on a Sunday tandem bike ride with his wife. Matt was the SAFEST cyclist I have ever met. He was a lit-up beacon of orange, reflectors and flashers on his morning commute to work. He maintained his bike in safe riding condition always. He was predictable and responsible as he rode day in and day out from North Pole to Fairbanks. Unfortunately, all of Matt's efforts in being a safe rider was not enough. On his morning commute he was struck and after an incredible 5 week testament of his fortitude he passed away. In that time the greatness of the community of the Fairbanks NorthStar Borough were shown by the compassionate actions of its members in support of Matt and Ariane. A 'rallying of the troops' like that does not just happen without the interwoven connections of humanity placed ahead of time. Matt was that quiet community weaver. He always showed up. He lived by example. He walked the walk, but was not one to "talk the talk". As an 8-year transplant to Alaska myself, I came to call this place home. I fell in love with the wide-open spaces, abundance of 'all things outdoors' and the sense of community found within the Fairbanks NorthStar Borough. I can without hesitation say Matt represents each of those things that make Alaska home for me. Whether it was hiking in his hand made sandals he learned about at the Folk School, commuting to his job at the Alaska Railroad on bike, walking memory lane with my partner about their time as Wildland Firefighters or running over some cupcakes from his birthday to my kids simply to share. He may not have been a former political member, a war hero or someone that took center stage, but Matt represents our community to me. He was a man whos life was lived by example and felt by many, even if not attributed with public accolades. Matt is gone too soon, but a bike path in his name is a small gesture to give back to a man and his family that have given so much to us.

Again, I support SB 129 and the "Matt Glover Bike Path". In my eyes there is no other name more fitting for a public bike path, than "Matt Glover", a man who embodies our community. Thank you for your consideration of this matter.
